# Singular integrals with flag kernels on homogeneous groups, I 

Alexander Nagel, Fulvio Ricci, Elias M. Stein and Stephen Wainger


#### Abstract

Let $\mathcal{K}$ be a flag kernel on a homogeneous nilpotent Lie group $G$. We prove that operators $T$ of the form $T(f)=f * \mathcal{K}$ form an algebra under composition, and that such operators are bounded on $L^{p}(G)$ for $1<p<\infty$.


## 1. Introduction

This is the first of two papers dealing with singular integral operators with flag kernels on homogeneous nilpotent groups. Our goal is to show that these operators, along with appropriate sub-collections, form algebras under composition, and that the operators in question are bounded on $L^{p}$.

Operators of this kind arose initially when studying compositions of sub-elliptic operators on the Heisenberg group (such as the sub-Laplacian $\mathcal{L}$ and $\square_{b}$ ) with elliptic-type operators. In particular in [7] one saw that operators of the form $m(\mathcal{L}, i T)$ (where $m$ is a "Marcinkiewicz multiplier") are singular integrals with flag kernels and satisfy $L^{p}$ estimates. The theory was extended in [9] to encompass general flag kernels in the Euclidean space $\mathbb{R}^{N}$, and the resulting operators arising via abelian convolution. In addition, aspects of the CR theory for quadratic manifolds could be studied via such operators on various 2-step groups. More recently, flag kernels have been studied in [13] and [2]. In view of this, and because of their potential further application, it is desirable to extend the above results in [9] to the setting of homogeneous groups of higher step. To achieve this goal requires however that we substantially recast the approach and techniques used previously, since these were essentially limited to the 2 -step case.

Our main results are two-fold. Suppose $G$ is a homogeneous nilpotent group and $\mathcal{K}$ denotes a distribution on $G$ which is a flag kernel (the requisite definitions are given below in Definition 2.3).

Theorem A. The operators $T$ of the form $T(f)=f * \mathcal{K}$ form an algebra under composition.

Theorem B. The above operators are bounded on $L^{p}(G)$ for $1<p<\infty$.
Given the complexity of the material, in this introductory section we provide the reader with an outline of the main ideas that enter in the proofs of the above theorems. Moreover, in order to simplify the presentation we will often not state matters in the most general setting and sometimes describe the situation at hand a little imprecisely.

### 1.1. Flag kernels

We start with a direct sum decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, with $\sum_{j=1}^{n} a_{j}=N$, and we write $\mathbf{x}=\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)$, with $\mathbf{x}_{m} \in \mathbb{R}^{a_{m}}$. We also fix a one-parameter family of dilations $\delta_{r}$ on $\mathbb{R}^{N}$, given by $\delta_{r}(\mathbf{x})=\left(r^{d_{1}} \mathbf{x}_{1}, \ldots, r^{d_{n}} \mathbf{x}_{n}\right)$, with positive exponents $d_{1}<d_{2}<\cdots<d_{n} .{ }^{1}$ We denote by $Q_{k}=d_{k} a_{k}$ the homogeneous dimension of $\mathbb{R}^{a_{k}}$. We also define the partial "norms" $N_{k}(\mathbf{x})=\left|\mathbf{x}_{k}\right|_{e}^{1 / d_{k}}$, where $\left|\mathbf{x}_{k}\right|_{e}$ is the standard Euclidean norm on $\mathbb{R}^{a_{k}}$.

In this setting, a flag kernel $\mathcal{K}$ is a distribution on $\mathbb{R}^{N}$ which is given by integration against a $C^{\infty}$ function $K(\mathbf{x})$ away from $\mathbf{x}_{1}=0$ and which satisfies two types of conditions. The first are the differential inequalities for $\mathbf{x}_{1} \neq 0$ :

\left|\partial_{\mathbf{x}}^{\alpha} K(\mathbf{x})\right| \leq C_{\alpha} \prod_{k=1}^{n}\left(N_{1}(\mathbf{x})+N_{2}(\mathbf{x})+\cdots+N_{k}(\mathbf{x})\right)^{-Q_{k}-d_{k} \alpha_{k}} \tag{1.1}
\end{equation*}
$$

with $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right)$. The second are the cancellation conditions. These are most easily expressed recursively. Let $\langle\mathcal{K}, \varphi\rangle$ denote the action of the distribution $\mathcal{K}$ on a test function $\varphi$. At the beginning of the recursion there is the following condition, in many ways typical of the others:

\sup _{R}\left|\left\langle\mathcal{K}, \varphi_{R}\right\rangle\right|<\infty \tag{1.2}
\end{equation*}
$$

where $R=\left(R_{1}, R_{2}, \ldots, R_{n}\right), \varphi_{R}(x)=\varphi\left(R_{1}^{d_{1}} x_{1}, R_{2}^{d_{2}} x_{2}, \ldots, R_{n}^{d_{n}} x_{n}\right)$, and $\varphi$ is an arbitrary $C^{\infty}$ function which is supported in the unit ball. More generally, one requires that the action of $\mathcal{K}$ on a test function in some subset of variables $\left\{\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right\}$ produces a flag kernel in the remaining variables $\left\{\mathbf{x}_{l_{1}}, \ldots, \mathbf{x}_{l_{\alpha}}\right\}$. The precise formulation of these conditions is given in Section 2 and Definition 2.3 below.

### 1.2. Dyadic decomposition

A main tool used in studying flag kernels is their dyadic decomposition into sums of "bump functions". This proceeds as follows. Let $I=\left(i_{1}, i_{2}, \ldots, i_{n}\right)$ denote any indexing set of integers that satisfies.

i_{1} \leq i_{2} \leq \cdots \leq i_{n-1} \leq i_{n} \tag{1.3}
\end{equation*}
$$

[^0]Also let $\left\{\varphi^{I}\right\}$ be a family of $C^{\infty}$ functions supported in the unit ball that are uniformly bounded in the $C^{(m)}$ norm for each $m$. Set

$$
\left[\varphi^{I}\right]_{I}(\mathbf{x})=2^{-i_{1} Q_{1}-i_{2} Q_{2}-\cdots-i_{n} Q_{n}} \varphi^{I}\left(2^{-d_{1} i_{1}} \mathbf{x}_{1}, \ldots, 2^{-d_{n} i_{n}} \mathbf{x}_{n}\right)
$$

so that the $\left[\varphi^{I}\right]_{I}$ are $L^{1}$-normalized. We say that the $\varphi^{I}$ satisfy the "strong cancellation" condition if for each $k$ with $1 \leq k \leq n$,

\begin{equation*}
\int_{\mathbb{R}^{a_{k}}} \varphi^{I}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{k}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{k} \equiv 0 \tag{1.4}
\end{equation*}
$$

when all the inequalities (1.3) for $I$ are strict. In the case that there are some equalities in (1.3), say $i_{\ell-1}<i_{\ell}=i_{\ell+1}=\cdots=i_{k}<i_{k+1}$, then only cancellation in the collection of corresponding variables is required:

\int_{\mathbb{R}^{a^{e} \oplus \cdots} \oplus \mathbb{R}^{a_{k}}} \varphi^{I}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{\ell}, \ldots, \mathbf{x}_{k}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{\ell} \cdots d \mathbf{x}_{k} \equiv 0
$$

The first result needed is that any sum

$$
\begin{equation*}
\sum_{I}\left[\varphi^{I}\right]_{I} \tag{1.5}
\end{equation*}
$$

made up of such bump functions, with the cancellation conditions (1.4) and (1.4 ), converges in the sense of distributions to a flag kernel, and conversely, any flag kernel $\mathcal{K}$ can be written in this way (of course, not uniquely).

There are two parts to this result (which in effect is stated but not proved completely in [9]). The first is that the sum in (1.5) is indeed a flag kernel. To see this, one can use the estimate in Proposition 10.1 given in Appendix II below; one also notes from this that even without the cancellation conditions (1.4) and (1.4'), the sum (1.5) satisfies the differential inequalities (1.1). The converse part requires Theorem 6.1 below, and the observation that the parts of the sum (1.5) contributed by I's where there may be equality in (1.3) give flag distributions corresponding to various "coarser" flags.

However, what will be key in what follows is that the strong cancellation conditions (1.4) or (1.4 ) can be weakened, and still lead to the same conclusion. While these "weak" cancellation conditions are somewhat complicated to state (see Definition 5.5 below), they are easily illustrated in the special 2-step case. Here we have the decomposition $\mathbb{R}^{n}=\mathbb{R}^{a_{1}} \oplus \mathbb{R}^{a_{2}}, \mathbf{x}=\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right)$. The cancellation condition for the second variable is as before: $\int \varphi^{I}\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right) d \mathbf{x}_{2} \equiv 0$. For $\mathbf{x}_{1}$ the weak cancellation condition takes the form

$$
\begin{equation*}
\int_{\mathbb{R}^{a_{1}}} \varphi^{I}\left(\mathbf{x}_{1}, \mathbf{x}_{2}\right) d \mathbf{x}_{1}=2^{-\epsilon\left(i_{2}-i_{1}\right)} \eta^{I}\left(\mathbf{x}_{2}\right), \tag{1.6}
\end{equation*}
$$

for some $\epsilon>0$, with $I=\left(i_{1}, i_{2}\right)$ and $\eta^{I}$ an $L^{1}$ normalized bump in the $\mathbf{x}_{2}$ variable.
In this context, the main conclusion (Theorem 6.8) is that the sum (1.5) is still a flag kernel if the weak-cancellation conditions are assumed instead of (1.4)
and $\left(1.4^{\prime}\right)$, and the functions $\left\{\varphi^{I}\right\}$ are allowed to belong to the Schwartz class instead of being compactly supported. In understanding Definition 5.5, one should keep in mind that conditions like (1.4), which involve vanishing of integrals, are equivalent with expressions of the $\varphi^{I}$ as the sums of appropriate derivatives. (This is established in Lemma 5.1).

### 1.3. Other properties of flag kernels

Along with the results about decompositions of flag kernels, there are a number of other properties of these distributions that are worth mentioning and are discussed in Section 6. First, the class of flag kernels is invariant under changes of variables compatible with the structure of the flags. We have in mind transformations $\mathbf{x} \mapsto \mathbf{y}=F(\mathbf{x})$, with $\mathbf{y}_{k}=\mathbf{x}_{k}+P_{k}(\mathbf{x})$, and $P_{k}$ a homogeneous polynomial of $\mathbf{x}_{1}, \ldots, \mathbf{x}_{k-1}$, of the same homogeneity as $\mathbf{x}_{k}$. The fact that $\mathcal{K} \circ F$ satisfies the same differential inequalities (1.1) as $\mathcal{K}$ is nearly obvious, but the requisite cancellation conditions (such as (1.2)) are subtler and involve the weak cancellation of the bump functions. (See Theorem 6.15.)

A second fact is that the cancellations required in the definition of a flag kernel can be relaxed. For example, assuming that the differential inequalities (1.1) hold, then the less restrictive version of (1.2) requires that the supremum is taken only over those $R$ for which $R_{1} \geq R_{2} \geq \cdots \geq R_{n}>0$. The formulation and proof of the sufficiency of these restricted conditions is in Theorem 6.13.

Finally we should point out that at the basis of many of our arguments is an earlier characterization in [9] of flag kernels in terms of their Fourier transforms: these are bounded multipliers that satisfy the dual differential inequalities given in Definition 6.3.

### 1.4. Graded groups and compositions of flag kernels

Up to this point our discussion of flag kernels has focused on their definition as distributions on the Euclidean space $\mathbb{R}^{N}$. We now consider convolutions with flag kernels on graded nilpotent Lie groups $G$ whose underlying space is $\mathbb{R}^{N}$. The choice of an appropriate coordinate system on the group $G$, and its multiplication structure, induces a decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$ and allows us to find exponents $d_{1}<d_{2}<\cdots<d_{n}$ as above so that the dilations $\delta_{r}(\mathbf{x})=\left(r^{d_{1}} \mathbf{x}_{1}, \ldots, r^{d_{n}} \mathbf{x}_{n}\right)$, with $r>0$, are automorphisms of $G$.

The proof of Theorem A reduces to the statement that if $\mathcal{K}_{1}$ and $\mathcal{K}_{2}$ are a pair of flag kernels, then $\mathcal{K}_{1} * \mathcal{K}_{2}$ is a sum of flag kernels, where the convolution is taken with respect to $G$. Note that when $G$ is the abelian group $\mathbb{R}^{N}$, the result follows immediately from the characterization of flag kernels in terms of their Fourier transforms, cited earlier, and in fact the convolution of two flag kernels is a single flag kernel. In the non-commutative case the proof is not as simple and proceeds as follows. First write $\mathcal{K}_{1}=\sum_{I}\left[\varphi^{I}\right]_{I}, \mathcal{K}_{2}=\sum_{J}\left[\psi^{J}\right]_{J}$ in terms of decompositions with bump functions with strong cancellation. Now, formally,

$$
\begin{equation*}
\mathcal{K}_{1} * \mathcal{K}_{2}=\sum_{I} \sum_{J}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \tag{1.7}
\end{equation*}
$$

We look first at an individual term $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$ in the above sum. It has three properties:
(a) $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}=\left[\theta^{I, J}\right]_{K}$ with $\left[\theta^{I, J}\right]_{K}$ a "bump" scaled according to $K$, where $K=I \vee J$; that is $K=\left(k_{1}, k_{2}, \ldots, k_{n}\right)$, and $k_{m}=\max \left(i_{m}, j_{m}\right), 1 \leq m \leq n$. This conclusion holds even if we do not assume the cancellation conditions on $\left[\varphi^{I}\right]_{I}$ and $\left[\psi^{J}\right]_{J}$.
(b) Next, because we do have the cancellation conditions (1.4) and (1.4'), we have a gain: There exists $\epsilon>0$ so that $\left[\theta^{I, J}\right]_{K}$ can be written as a finite sum of terms of the form

$$
\prod_{l \in A} 2^{-\epsilon\left|i_{l}-j_{l}\right|} \prod_{m \in B} 2^{-\epsilon\left[\left(i_{m+1}-i_{m}\right)+\left(j_{m+1}-j_{m}\right)\right.}\left[\widetilde{\theta}^{I, J}\right]_{K}
$$

where $\left[\widetilde{\theta}^{I, J}\right]_{K}$ is another bump function scaled according to $K$, and $A$ and $B$ are disjoint sets with $A \cup B=\{1, \ldots, n\}$, with $n \notin B$.
(c) Strong cancellation fails in general for $\left[\theta^{I, J}\right]_{K}$, but weak cancellation holds.

Statements (a), (b), and (c) above are contained in Lemmas 6.17 and 6.18. With these assertions proved, one can proceed roughly ${ }^{2}$ as follows. We define

$$
\tilde{\theta}_{K}=\sum_{I \vee J=K}\left[\varphi^{I}\right]_{I} *\left[\varphi^{J}\right]_{J}
$$

where the sum is taken over all pairs $(I, J)$ for which $I \vee J=K$. Because of the exponential gain given in (b) this sum converges to a $K$-scaled bump function. Moreover, because of (c), $\tilde{\theta}_{K}$ satisfies the weak cancellation property. As a result, the sum $\sum_{K} \tilde{\psi}_{K}$ converges to a flag kernel, and hence $\mathcal{K}_{1} * \mathcal{K}_{2}$ is a flag kernel as was to be shown.

We comment briefly on the arguments needed to establish (b) and (c). Here we use the strong cancellation properties of $\left[\varphi^{I}\right]_{I}$ (or $\left[\psi^{J}\right]_{J}$ ). For (b) we express $\left[\varphi^{I}\right]_{I}$ as a sum of derivatives with respect to appropriate coordinates, then re-express these in terms of left-invariant vector fields, and finally pass these differentiation to $\left[\psi^{J}\right]_{J}$. The reverse may be done starting with cancellation of $\left[\psi^{J}\right]_{J}$. To obtain (c), the weak cancellation of $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$, we begin the same way, but express $\left[\varphi^{I}\right]_{I}$ in terms of right-invariant vector fields and then pass these differentiations onto the resulting convolution products. The mechanism underlying this technique is set out in the various lemmas of Section 3.

The argument is a little more complex when we are in the case of equality for some of the indices that arise in $I$ or $J$. This in effect involves convolutions with kernels belonging to coarser flags. The guiding principle for convolutions of such bump functions (or kernels) is that if $\mathcal{K}_{j}$ are flag kernels corresponding to the flags $\mathcal{F}_{j}, j=1,2$, then $\mathcal{K}_{1} * \mathcal{K}_{2}$ is a flag kernel for the coarsest flag $\mathcal{F}$ that is finer than $\mathcal{F}_{1}$ and $\mathcal{F}_{2}$. The combinatorics involved are illustrated by several examples given in Sections 7.3 and 7.5.

## 1.5. $L^{p}$ estimates via square functions

The proof of the $L^{p}$ estimates (Theorem 8.14) starts with the descending chain of subgroups $G=G_{1} \supset G_{2} \supset \cdots \supset G_{n}$, where

G_{m}=\left\{\mathbf{x}=\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right): \mathbf{x}_{1}=0, \mathbf{x}_{2}=0, \ldots, \mathbf{x}_{m-1}=0\right\}
$$

when $m \geq 2$. We observe that the dilations $\delta_{r}$ restrict to automorphisms of the $G_{m}$. We then proceed as follows:
(i) The standard (one-parameter) maximal functions and square functions on each group $G_{m}$, as given in [3], are then "lifted" (or "transferred") to the group $G$.
(ii) Compositions of these lifted objects lead to ( $n$-parameter) maximal functions and square functions on $G$. Among these is the "strong" maximal function

$$
M(f)(\mathbf{x})=\sup \frac{1}{m\left(R_{s}\right)} \int_{R_{s}}\left|f\left(\mathbf{x y}^{-1}\right)\right| d \mathbf{y}
$$

for which one can prove vector-valued $L^{p}$ inequalities. Here $R_{s}=\left\{\mathbf{x}:\left|\mathbf{x}_{k}\right| \leq\right.$ $\left.s_{k}^{d_{k}}\right\}$, with $\left(s_{1}, \ldots, s_{n}\right)$ restricted to $s_{1} \leq s_{2} \leq \cdots \leq s_{n}$. There are also a pair of square functions, $S$ and $\mathfrak{S}$, with the properties:
(1.8) $\|f\|_{L^{p}} \leq A_{p}\|S(f)\|_{L^{p}}$ and $\|\mathfrak{S}(f)\|_{L^{p}} \leq A_{p}^{\prime}\|f\|_{L^{p}}$, for $1<p<\infty$.
(iii) The connection of these square functions with our operators $T$, given by $T f=f * \mathcal{K}$ with $\mathcal{K}$ a flag kernel, comes about because of the pointwise estimate:

$$
\begin{equation*}
S(T f)(\mathbf{x}) \leq c \mathfrak{S}(f)(\mathbf{x}) \tag{1.9}
\end{equation*}
$$

which is Lemma 8.13 below.
Now, (1.8), together with (1.9), prove the $L^{p}$ boundedness of our operators.
Among the ideas used to prove (1.9) is the notion of a "truncated" flag kernel: such a kernel is truncated at "width $a$ ", $a \geq 0$, if it satisfies the conditions such as (1.1), but with $N_{1}+\cdots+N_{k}$ replaced by $a+N_{1}+\cdots+N_{k}$ throughout (see Definition 6.20). A key fact that is exploited is that a convolution of a bump of width $b$ with a truncated kernel of width $a$ yields a truncated kernel of width $a+b$. For this, see Theorem 8.7, and its consequence, Theorem 8.9.

### 1.6. Final remarks

The collection of operators with flag kernels contains both the automorphic (nonisotropic) Calderón-Zygmund operators as well as the usual isotropic CalderónZygmund operators with kernels of compact support (broadly speaking, the standard pseudo-differential operators of order 0 ). But flag kernels, by their definition, may have singularities away from the origin. Thus the algebra we are considering
consists of operators that are not necessarily pseudo-local. The study of a narrower algebra that arises naturally, which consists of pseudo-local operators and yet contains both types of Calderón-Zygmund operators, will be the subject of the second paper [10] in this series.

## 2. Dilations and flag kernels on $\mathbb{R}^{N}$

Throughout the paper we shall use standard multi-index notation. $\mathbb{Z}$ denotes the set of integers, and $\mathbb{N}$, the set of non-negative integers. If $\alpha=\left(\alpha_{1}, \ldots, \alpha_{N}\right) \in \mathbb{N}^{N}$, then $|\alpha|=\alpha_{1}+\cdots+\alpha_{N}$ and $\alpha!=\alpha_{1}!\cdots \alpha_{N}!$. If $\mathbf{x}=\left(x_{1}, \ldots, x_{N}\right) \in \mathbb{R}^{N}$, then $\mathbf{x}^{\alpha}=x_{1}^{\alpha_{1}} \cdots x_{N}^{\alpha_{N}}$. For $1 \leq j \leq N, \partial_{x_{j}}$ (or more simply $\partial_{j}$ ) denotes the differential operator $\frac{\partial}{\partial x_{j}}$. If $\alpha \in \mathbb{N}^{N}$, then $\partial^{\alpha}$ denotes the partial differential operator $\partial_{1}^{\alpha_{1}} \cdots \partial_{N}^{\alpha_{N}}$.

The space of infinitely differentiable real-valued functions on $\mathbb{R}^{N}$ with compact support is denoted by $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ and the space of Schwartz functions is denoted by $\mathcal{S}\left(\mathbb{R}^{N}\right)$. The basic semi-norms on these spaces are defined as follows:

\begin{array}{ll}
\text { if } \varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right), & \|\varphi\|_{(m)}=\sup \left\{\left|\partial_{\mathbf{x}}^{\alpha} \varphi(\mathbf{x})\right|:|\alpha| \leq m, \mathbf{x} \in \mathbb{R}^{N}\right\} \\
\text { if } \varphi \in \mathcal{S}\left(\mathbb{R}^{N}\right), & \|\varphi\|_{[M]}=\sup \left\{\left|\left(1+|\mathbf{x}|_{e}\right)^{\alpha} \partial_{\mathbf{x}}^{\beta} \varphi(\mathbf{x})\right|:|\alpha|+|\beta| \leq M, \mathbf{x} \in \mathbb{R}^{N}\right\}
\end{array}
$$

Here $|\mathbf{x}|_{e}$ denotes the usual Euclidean length of $\mathbf{x} \in \mathbb{R}^{N}$.

### 2.1. The basic family of dilations

Fix positive real numbers $0<d_{1} \leq d_{2} \leq \cdots \leq d_{N}$, and define a one-parameter family of dilations on $\mathbb{R}^{N}$ by setting

$$
\begin{equation*}
\delta_{r}[\mathbf{x}]=r \cdot \mathbf{x}=\left(r^{d_{1}} x_{1}, \ldots, r^{d_{N}} x_{N}\right) \tag{2.1}
\end{equation*}
$$

Also fix a smooth homogeneous norm $|\mathbf{x}|$ on $\mathbb{R}^{N}$ so that $|r \cdot \mathbf{x}|=r|\mathbf{x}|$. The homogeneous ball of radius $r$ is $B(r)=\left\{\mathbf{x} \in \mathbb{R}^{N}:|\mathbf{x}|<r\right\}$, and the homogeneous dimension of $\mathbb{R}^{N}$ (relative to this family of dilations) is $Q=d_{1}+\cdots+d_{N}$. Recall that $|\mathbf{x}|_{e}=\sqrt{x_{1}^{2}+\cdots+x_{N}^{2}}$ denotes the ordinary Euclidean length of a vector $\mathbf{x} \in \mathbb{R}^{N}$. If $m(\mathbf{x})=c \mathbf{x}^{\alpha}=c x_{1}^{\alpha_{1}} \cdots x_{N}^{\alpha_{N}}$ is a monomial, then $m(r \cdot \mathbf{x})=r^{\alpha_{1} d_{1}+\cdots+\alpha_{N} d_{N}} m(\mathbf{x})$,
and the homogeneous degree of $m$ is $\Delta(m)=\alpha_{1} d_{1}+\cdots+\alpha_{N} d_{N}$. In particular, the homogeneous degree of a constant is zero. We shall agree that if the homogeneous degree of a monomial is negative, the monomial itself must be identically zero. With this convention, if $m$ is any monomial, we have

$$
\begin{equation*}
\Delta\left(\partial_{j} m\right)=\Delta(m)-d_{j} . \tag{2.2}
\end{equation*}
$$

We denote by $\mathcal{H}_{d}$ the space of real-valued polynomials which are sums of monomials of homogeneous degree $d$. We have the following easy result:

Proposition 2.1. If $P$ is a polynomial, then $P \in \mathcal{H}_{d}$ if and only if $P(\mathbf{x})=$ $\sum_{\alpha \in \mathfrak{H}_{d}} c_{\alpha} \mathbf{x}^{\alpha}$, where $\mathfrak{H}_{d}=\left\{\alpha=\left(\alpha_{1}, \ldots, \alpha_{N}\right) \in \mathbb{N}^{n} \mid \sum_{j=1}^{N} \alpha_{j} d_{j}=d\right\}$. Moreover,
(1) if $P \in \mathcal{H}_{d}$, then $P(r \cdot \mathbf{x})=r^{d} P(\mathbf{x})$;
(2) if $P \in \mathcal{H}_{d_{1}}$ and $Q \in \mathcal{H}_{d_{2}}$, then $P Q \in \mathcal{H}_{d_{1}+d_{2}}$;
(3) if $P \in \mathcal{H}_{d}$, then $\partial_{k}(P)(\mathbf{x}) \equiv 0$ if $d_{k}>d$.

### 2.2. Standard flags and flag kernels in $\mathbb{R}^{N}$

If $X$ is an $N$-dimensional vector space, an $n$-step flag in $X$ is a collection of subspaces $X_{j} \subseteq X, 1 \leq j \leq n$, such that $(0) \subsetneq X_{1} \subsetneq X_{2} \subsetneq \cdots \subsetneq X_{n-1} \subsetneq X_{n}=X$. When $X=\mathbb{R}^{N}$ we single out a special class of standard flags. These are parameterized by partitions $N=a_{1}+\cdots+a_{n}$ (where each $a_{j}$ is a positive integer) as follows. We write

$$
\begin{equation*}
\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}, \tag{2.3}
\end{equation*}
$$

and we write $\mathbf{x} \in \mathbb{R}^{N}$ as $\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)$ with $\mathbf{x}_{j} \in \mathbb{R}^{a_{j}}$. With an abuse of notation, we identify $\mathbb{R}^{a_{k}}$ with vectors in $\mathbb{R}^{N}$ of the form $\left(\mathbf{0}, \ldots, \mathbf{0}, \mathbf{x}_{k}, \mathbf{0}, \ldots, \mathbf{0}\right)$. Then the standard flag $\mathcal{F}$ associated to the partition $N=a_{1}+\cdots+a_{n}$ and to the decomposition (2.3) is given by

$$
\begin{equation*}
(0) \subset \mathbb{R}^{a_{n}} \subset \mathbb{R}^{a_{n-1}} \oplus \mathbb{R}^{a_{n}} \subset \cdots \subset \mathbb{R}^{a_{2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}} \subset \mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}=\mathbb{R}^{N} \tag{2.4}
\end{equation*}
$$

In dealing with such decompositions and flags, it is important to make clear which variables in $\mathbb{R}^{N}$ appear in which factor $\mathbb{R}^{a_{l}}$. We can write $\mathbf{x} \in \mathbb{R}^{N}$ either as $\mathbf{x}=\left(x_{1}, \ldots, x_{N}\right)$ with each $x_{j} \in \mathbb{R}$, or as $\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)$ with $\mathbf{x}_{l}=$ $\left(x_{p_{l}}, \ldots, x_{q_{l}}\right) \in \mathbb{R}^{a_{l}}$ so that $q_{l}=p_{l}+a_{l}-1$. Denote by $J_{l}=\left\{p_{l}, p_{l}+1, \ldots, q_{l}\right\}$ the set of subscripts corresponding to the factor $\mathbb{R}^{a_{l}}$ so that $\{1, \ldots, N\}$ is the disjoint union $J_{1} \cup \cdots \cup J_{n}$. There is a mapping $\pi:\{1, \ldots, N\} \mapsto\{1, \ldots, n\}$ so that $j \in J_{\pi(j)}$ for $1 \leq j \leq N$. Thus for example $\pi(10)=3$ means that the variable $x_{10}$ belongs to the factor $\mathbb{R}^{a_{3}}$.

With the family of dilations defined in (2.1), the action on the subspace $\mathbb{R}^{a_{l}}$ is given by

$$
\begin{equation*}
r \cdot \mathbf{x}_{l}=\left(r^{d_{p_{l}}} x_{p_{l}}, \ldots, r^{d_{q_{l}}} x_{q_{l}}\right) \tag{2.5}
\end{equation*}
$$

The homogeneous dimension of $\mathbb{R}^{a_{l}}$ is

$$
\begin{equation*}
Q_{l}=d_{p_{l}}+\cdots+d_{q_{l}}=\sum_{j \in J_{l}} d_{j} . \tag{2.6}
\end{equation*}
$$

The function

$$
\begin{equation*}
N_{l}\left(\mathbf{x}_{l}\right)=\sup _{p_{l} \leq s \leq q_{l}}\left|x_{s}\right|^{1 / d_{s}} \tag{2.7}
\end{equation*}
$$

is a homogeneous norm on $\mathbb{R}^{a_{l}}$ so that $N_{l}\left(r \cdot \mathbf{x}_{l}\right)=r N_{l}\left(\mathbf{x}_{l}\right)$. If $\alpha=\left(\alpha_{1}, \ldots, \alpha_{N}\right) \in \mathbb{N}^{N}$, let $\bar{\alpha}_{l}=\left(\alpha_{p_{l}}, \ldots, \alpha_{q_{l}}\right)$, and set

$$
\begin{equation*}
\llbracket \bar{\alpha}_{l} \rrbracket=\alpha_{p_{l}} d_{p_{l}}+\cdots+\alpha_{q_{l}} d_{q_{l}}=\sum_{j \in J_{l}} \alpha_{j} d_{j} . \tag{2.8}
\end{equation*}
$$

We introduce a partial order on the set of all standard flags on $\mathbb{R}^{N}$.
Definition 2.2. Let $\mathcal{A}=\left(a_{1}, \ldots, a_{r}\right)$ and $\mathcal{B}=\left(b_{1}, \ldots, b_{s}\right)$ be two partitions of $N$ so that $N=a_{1}+\cdots+a_{r}=b_{1}+\cdots+b_{s}$.
(1) The partition $\mathcal{A}$ is finer than the partition $\mathcal{B}$ (or $\mathcal{B}$ is coarser than $\mathcal{A}$ ) if there are integers $1=\alpha_{1}<\alpha_{2}<\cdots<\alpha_{s+1}=r+1$ so that $b_{k}=\sum_{j=\alpha_{k}}^{\alpha_{k+1}-1} a_{j}$. We write $\mathcal{A} \preceq \mathcal{B}$ or $\mathcal{B} \succeq \mathcal{A}$. If $\mathcal{A} \preceq \mathcal{B}$ but $\mathcal{A} \neq \mathcal{B}$ we write $\mathcal{A} \prec \mathcal{B}$ or $\mathcal{B} \succ \mathcal{A}$.
(2) If $\mathcal{F}_{\mathcal{A}}$ and $\mathcal{F}_{\mathcal{B}}$ are the flags corresponding to the two partitions and if $\mathcal{A} \preceq \mathcal{B}$ (or $\mathcal{A} \prec \mathcal{B}$ ), we say that the flag $\mathcal{F}_{\mathcal{A}}$ is finer than $\mathcal{F}_{\mathcal{B}}$ (or $\mathcal{F}_{\mathcal{B}}$ is coarser than $\mathcal{F}_{\mathcal{A}}$ ) and we also write $\mathcal{F}_{\mathcal{A}} \preceq \mathcal{F}_{\mathcal{B}}$ and $\mathcal{F}_{\mathcal{B}} \succeq \mathcal{F}_{\mathcal{A}}$ (or $\mathcal{F}_{\mathcal{A}} \prec \mathcal{F}_{\mathcal{B}}$ and $\mathcal{F}_{\mathcal{B}} \succ \mathcal{F}_{\mathcal{A}}$ ).
We recall from [9] the concept of a flag kernel on the vector space $\mathbb{R}^{N}$ associated to the decomposition $\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, equipped with the family of dilations given in equation (2.1). Let $\mathcal{F}$ be the standard flag given in (2.4). In order to formulate the cancellation conditions on the flag kernel, we need notation which allows us to split the variables $\left\{\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right\}$ into two disjoint sets. Thus if $L=\left\{l_{1}, \ldots, l_{\alpha}\right\}$ and $M=\left\{m_{1}, \ldots, m_{\beta}\right\}$ are complementary subsets of $\{1, \ldots, n\}$ so that $\alpha+\beta=n$, let $N_{a}=a_{l_{1}}+\cdots+a_{l_{\alpha}}$ and $N_{b}=a_{m_{1}}+\cdots+a_{m_{\beta}}$. Write $\mathbf{x} \in \mathbb{R}^{N}$ as $\mathbf{x}=\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right)$ where $\mathbf{x}^{\prime}=\left(\mathbf{x}_{l_{1}}, \ldots, \mathbf{x}_{l_{\alpha}}\right)$ and $\mathbf{x}^{\prime \prime}=\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right)$. If $f$ is a function on $\mathbb{R}^{N_{a}}$ and $g$ is a function on $\mathbb{R}^{N_{b}}$, define a function $f \otimes g$ on $\mathbb{R}^{N}$ by setting

$$
f \otimes g\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)=f\left(\mathbf{x}_{l_{1}}, \ldots, \mathbf{x}_{l_{\alpha}}\right) g\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right) .
$$

Definition 2.3. A flag kernel adapted to the flag $\mathcal{F}$ is a distribution $\mathcal{K} \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$ which satisfies the following differential inequalities (part (a)) and cancellation conditions (part (b)):
(a) For test functions supported away from the subspace $\mathbf{x}_{1}=0$, the distribution $\mathcal{K}$ is given by integration against a $\mathcal{C}^{\infty}$-function $K$. Moreover, for every $\alpha=$ $\left(\alpha_{1}, \ldots, \alpha_{N}\right) \in \mathbb{Z}^{N}$ there is a constant $C_{\alpha}$ so that if $\bar{\alpha}_{k}=\left(\alpha_{p_{k}}, \ldots, \alpha_{q_{k}}\right)$, then for $\mathbf{x}_{1} \neq 0$,

$$
\left|\partial^{\alpha} K(\mathbf{x})\right| \leq C_{\alpha} \prod_{k=1}^{n}\left[N_{1}\left(\mathbf{x}_{1}\right)+\cdots+N_{k}\left(\mathbf{x}_{k}\right)\right]^{-Q_{k}-\llbracket \bar{\alpha}_{k} \rrbracket}
$$

(b) Let $\{1, \ldots, n\}=L \cup M$, with $L=\left\{l_{1}, \ldots, l_{\alpha}\right\}, M=\left\{m_{1}, \ldots, m_{\beta}\right\}$, and $L \cap M=\emptyset$ be any pair of complementary subsets. For any $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N_{b}}\right)$ and any positive real numbers $R_{1}, \ldots, R_{\beta}$, put

$$
\psi_{R}\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right)=\psi\left(R_{1} \cdot \mathbf{x}_{m_{1}}, \ldots, R_{\beta} \cdot \mathbf{x}_{m_{\beta}}\right)
$$

Define a distribution $\mathcal{K}_{\psi, R}^{\#} \in \mathcal{S}^{\prime}\left(\mathbb{R}^{a_{l_{1}}+\cdots+a_{l_{r}}}\right)$ by setting

$$
\left\langle\mathcal{K}_{\psi, R}^{\#}, \varphi\right\rangle=\left\langle\mathcal{K}, \psi_{R} \otimes \varphi\right\rangle
$$

for any test function $\varphi \in \mathcal{S}\left(\mathbb{R}^{a_{l_{1}}+\cdots+a_{l_{r}}}\right)$. Then the distribution $\mathcal{K}_{\psi, R}^{\#}$ satisfies the differential inequalities of part (a) for the decomposition $\mathbb{R}^{a_{l_{1}}} \oplus \cdots \oplus \mathbb{R}^{a_{l_{r}}}$. Moreover, the corresponding constants that appear in these differential inequalities are independent of the parameters $\left\{R_{1}, \ldots, R_{s}\right\}$, and depend only on the constants $\left\{C_{\alpha}\right\}$ from part (a), the semi-norms of $\psi$, and the support of $\psi$. The constants $\left\{C_{\alpha}\right\}$ in part (a) and the implicit constants in part (b) are called the flag kernel constants for the flag kernel $\mathcal{K}$.

Remarks 2.4. (a) This definition proceeds by induction on the length $n$ of the flag. The case $n=1$ corresponds to Calderón-Zygmund kernels, and the inductive definition is invoked in part (b).
(b) With an abuse of notation, the distribution $\mathcal{K}_{\psi, R}^{\#}$ is often written

$$
K_{\psi, R}^{\#}\left(\mathbf{x}_{l_{1}}, \ldots, \mathbf{x}_{l_{r}}\right)=\int \cdots \int_{\mathbb{R}^{a_{m_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{m_{s}}}}} K(\mathbf{x}) \psi_{R}\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{s}}\right) d \mathbf{x}_{m_{1}} \cdots d \mathbf{x}_{m_{s}}
$$

## 3. Homogeneous vector fields

In Section 6.6 below, where we consider a nilpotent Lie group $G$ whose underlying space is $\mathbb{R}^{N}$, we will need to consider the families of left and right invariant vector fields on $G$. At this stage, before we introduce the group structure, we consider instead two spanning sets of vector fields $\left\{X_{1}, \ldots, X_{N}\right\}$ and $\left\{Y_{1}, \ldots Y_{N}\right\}$ on $\mathbb{R}^{N}$ which are homogeneous with respect to the basic family of dilations given in (2.1); this means that if $Z_{j}$ is either $X_{j}$ or $Y_{j}$ for $1 \leq j \leq N$, then $Z_{j}$ can be written ${ }^{3}$

$$
\begin{equation*}
Z_{j}[\psi](\mathbf{x})=\partial_{j}[\psi](\mathbf{x})+\sum_{d_{l}>d_{j}} P_{j}^{l}(\mathbf{x}) \partial_{l}[\psi](\mathbf{x}), \tag{3.1}
\end{equation*}
$$

with $P_{j}^{l} \in \mathcal{H}_{d_{l}-d_{j}}$. It follows from part (3) of Proposition 2.1 that $\partial_{k}\left(P_{j}^{l}\right) \equiv 0$ if $d_{k}>d_{l}$. Thus we can commute the operators given by multiplication by the polynomial $P_{j}^{l}$ and differentiation with respect to $x_{l}$ and also write

$$
\begin{equation*}
Z_{j}[\psi](\mathbf{x})=\partial_{j}[\psi](\mathbf{x})+\sum_{d_{l}>d_{j}}^{N} \partial_{l}\left[P_{j}^{l} \psi\right](\mathbf{x}) \tag{3.2}
\end{equation*}
$$

It follows from (3.1) or (3.2) that $Z_{N}=\partial_{N}$.

[^2]Proposition 3.1. If $P \in \mathcal{H}_{d}$ and $Z_{j}$ is either $X_{j}$ or $Y_{j}$, then $Z_{j}[P] \in \mathcal{H}_{d-d_{j}}$, and if $d_{j}>d, Z_{j}[P] \equiv 0$.

Proof. It follows from (2.2) that if $P \in \mathcal{H}_{d}$, then $\partial_{l}[P] \in \mathcal{H}_{d-d_{l}}$, and since $P_{j}^{l} \in$ $\mathcal{H}_{d_{l}-d_{j}}$, it follows from part (2) of Proposition 2.1 that $P_{j}^{l} \partial_{x_{l}}[P] \in \mathcal{H}_{d-d_{j}}$. Thus $Z_{j}[P] \in \mathcal{H}_{d-d_{j}}$. The last conclusion then follows from part (3) of Proposition 2.1.

In equations (3.1) or (3.2), the vector fields $\left\{Z_{j}\right\}$ are written in terms of the Euclidean derivatives. Because these equations are in upper triangular form, it is easy to solve for the Euclidean derivatives in terms of the vector fields.

Proposition 3.2. For each $1 \leq j \leq N$, let $Z_{j}$ denote either $X_{j}$ or $Y_{j}$. Then there are polynomials $Q_{k}^{l} \in \mathcal{H}_{d_{l}-d_{k}}$ such that, for $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$,

$$
\partial_{k}[\psi](\mathbf{x})=Z_{k}[\psi](\mathbf{x})+\sum_{d_{l}>d_{k}}^{N} Q_{k}^{l}(\mathbf{x}) Z_{l}[\psi](\mathbf{x})=Z_{k}[\psi](\mathbf{x})+\sum_{d_{l}>d_{k}}^{N} Z_{l}\left[Q_{k}^{l} \psi\right](\mathbf{x}) .
$$

Proof. We argue by reverse induction on the index $k$. When $k=N$ it follows from equation (3.1) that $\partial_{N}=Z_{N}=X_{N}=Y_{N}$. To establish the induction step, suppose that the conclusion of the proposition is true for all indices greater than $k$. From equation (3.1) and the induction hypothesis, for either choice of $Z_{k}$ we have

$$
\begin{aligned}
\partial_{k}[\psi] & =Z_{k}[\psi]-\sum_{d_{m}>d_{k}}^{N} P_{k}^{m} \partial_{m}[\psi]=Z_{k}[\psi]-\sum_{d_{m}>d_{k}}^{N} P_{k}^{m}\left[Z_{m}[\psi]+\sum_{d_{l}>d_{m}}^{N} Q_{m}^{l} Z_{l}[\psi]\right] \\
& =Z_{k}[\psi]-\sum_{d_{m}>d_{k}}^{N} P_{k}^{m} Z_{m}[\psi]-\sum_{d_{l}>d_{k}}\left[\sum_{d_{k}<d_{m}<d_{l}} P_{k}^{m} Q_{m}^{l}\right] Z_{l}[\psi] .
\end{aligned}
$$

But according to part (2) of Proposition 2.1, $P_{k}^{m} Q_{m}^{l} \in \mathcal{H}_{d_{l}-d_{k}}$, and this completes the proof.

For $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ and $t>0$ set $\psi_{t}(\mathbf{x})=\psi\left(t^{-1} \cdot \mathbf{x}\right)$. Then multiplication by a polynomial $P \in \mathcal{H}_{d}$ is an operator homogeneous of degree $d$ in the sense that $P(\mathbf{x}) \psi_{t}(\mathbf{x})=t^{d}(P \psi)_{t}(\mathbf{x})$, and the vector fields $X_{j}$ and $Y_{j}$ are operators homogeneous of degree $-d_{j}$ in the sense that $X_{j}\left[\varphi_{t}\right](\mathbf{x})=t^{-d_{j}}\left(X_{j} \varphi\right)_{t}(\mathbf{x}), Y_{j}\left[\varphi_{t}\right](\mathbf{x})=$ $t^{-d_{j}}\left(Y_{j} \varphi\right)_{t}(\mathbf{x})$. In particular, the commutators $\left[X_{j}, X_{k}\right]$ and $\left[Y_{j}, Y_{k}\right]$ are vector fields which are homogeneous of degree $-\left(d_{j}+d_{k}\right)$. It follows that we can write

$$
\begin{gathered}
{\left[X_{j}, X_{k}\right]=\sum_{d_{m} \geq d_{j}+d_{k}} Q_{j, k}^{m}(\mathbf{x}) \partial_{m}=\sum_{d_{m} \geq d_{j}+d_{k}} R_{j, k}^{m}(\mathbf{x}) Z_{m}, \text { with } Q_{j, k}^{m}, R_{j, k}^{m} \in \mathcal{H}_{d_{m}-d_{j}-d_{k}},} \\
{\left[Y_{j}, Y_{k}\right]=\sum_{d_{m} \geq d_{j}+d_{k}} \widetilde{Q}_{j, k}^{m}(\mathbf{x}) \partial_{m}=\sum_{d_{m} \geq d_{j}+d_{k}} \widetilde{R}_{j, k}^{m}(\mathbf{x}) Z_{m}, \text { with } \widetilde{Q}_{j, k}^{m}, \widetilde{R}_{j, k}^{m} \in \mathcal{H}_{d_{m}-d_{j}-d_{k}}}
\end{gathered}
$$

If the operators $\left\{X_{j}\right\}$ and $\left\{Y_{j}\right\}$ are bases for a Lie algebra (as in the case of left or right invariant vector fields), the coefficients $\left\{R_{j, k}^{m}\right\}$ and $\left\{\widetilde{R}_{j, k}^{m}\right\}$ are constants.

Equations (3.1) or (3.2) express the vector fields $\left\{Z_{k}\right\}$ in terms of the standard derivatives $\left\{\partial_{j}\right\}$, and Proposition 3.2 expresses the standard derivatives in terms of the vector fields. We shall need analogous identities for products of $r$ vector fields $Z_{k_{1}} \cdots Z_{k_{r}}$ or products of $r$ Euclidean derivatives $\partial_{k_{1}} \cdots \partial_{k_{r}}$. The formulas are somewhat complicated, since they involve products of operators of various lengths. To help with the formulation of the results, it will be convenient to introduce the following notation:

Definition 3.3. Let $k_{1}, \ldots, k_{r} \in\{1, \ldots, N\}$ be a set of $r$ integers, possibly with repetitions.
(1) For any non-empty set $U \subset\{1, \ldots, r\}$, put $d_{U}=\sum_{\ell \in U} d_{k_{\ell}}$ and

$$
\mathfrak{I}(U)=\left\{m \in\{1, \ldots, N\}: d_{m} \geq d_{U}\right\}
$$

Note that if $U$ consists of two or more elements and $m \in \mathfrak{I}(U)$, then $d_{m}>$ $\sup _{\ell \in U} d_{k_{\ell}}$.
(2) For each integer $1 \leq s \leq r$, let $\mathcal{U}_{s}^{r}$ denote the set of partitions of the set $\{1, \ldots, r\}$ into $s$ non-empty disjoint subsets $\mathcal{U}=\left\{U_{1}, \ldots, U_{s}\right\}$.

The following proposition then shows how to write products of vector fields in terms of products of Euclidean derivatives.

Proposition 3.4. Let $k_{1}, \ldots, k_{r} \in\{1, \ldots, N\}$ be a set of $r$ integers, possibly with repetitions. For $1 \leq \ell \leq r$, let $Z_{k_{\ell}}$ denote either $X_{k_{\ell}}$ or $Y_{k_{\ell}}$. Then there are polynomials $P_{U_{\ell}}^{m_{\ell}} \in \mathcal{H}_{d_{m_{\ell}}-d_{U_{\ell}}}$ such that
$Z_{k_{1}} \cdots Z_{k_{r}}[\psi]=\sum_{s=1}^{r} \sum_{\left(U_{1}, \ldots, U_{s}\right) \in \mathcal{U}_{s}^{r}} \sum_{m_{1} \in \mathfrak{I}\left(U_{1}\right)} \ldots \sum_{m_{s} \in \mathfrak{I}\left(U_{s}\right)} \partial_{m_{1}} \cdots \partial_{m_{s}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}} \psi\right]$.
If $s=r$, so that $U_{j}=\left\{k_{j}\right\}$, the polynomial $P_{U_{j}}^{k_{j}}(\mathbf{x}) \equiv 1$.
Proof. We argue by induction on $r$. The case $r=1$ is contained in equation (3.2), so suppose we are given vector fields $\left\{Z_{k_{1}}, \ldots, Z_{k_{r+1}}\right\}$ where each $Z_{k_{\ell}}$ is either $X_{k_{\ell}}$ or $Y_{k_{\ell}}$. Then, by induction,

$$
\begin{align*}
& Z_{k_{1}} \cdots Z_{k_{r+1}}[\psi]=Z_{k_{1}} \cdots Z_{k_{r}}\left[Z_{k_{r+1}}[\psi]\right] \\
& =\sum_{s=1}^{r} \sum_{\left(U_{1}, \ldots, U_{s}\right) \in \mathcal{U}_{s}^{r}} \sum_{m_{1} \in \mathfrak{I}\left(U_{1}\right)} \cdots \sum_{m_{s} \in \mathfrak{I}\left(U_{s}\right)} \partial_{m_{1}} \cdots \partial_{m_{s}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\left[Z_{k_{r+1}}[\psi]\right]\right] \tag{3.3}
\end{align*}
$$

Since we can write

$$
Z_{k_{r+1}}[\psi]=\partial_{k_{r+1}}[\psi]+\sum_{\left\{m: d_{m}>d_{k_{r+1}}\right\}} \partial_{m}\left[P_{k_{r+1}}^{m} \psi\right]
$$

where $P_{k_{r+1}}^{m} \in \mathcal{H}_{d_{m}-d_{k_{r+1}}}$, the derivative $\partial_{m_{1}} \cdots \partial_{m_{s}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\left[Z_{k_{r+1}}[\psi]\right]\right]$ in the
last line of (3.3) can be written

$$
\begin{aligned}
& \partial_{m_{1}} \cdots \partial_{m_{s}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\left[Z_{k_{r+1}}[\psi]\right]\right] \\
&= \partial_{m_{1}} \cdots \partial_{m_{s}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\left[\partial_{k_{r+1}}[\psi]\right]\right] \\
&+\sum_{d_{m}>d_{k_{r+1}}} \partial_{m_{1}} \cdots \partial_{m_{s}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\left[\partial_{m}\left[P_{k_{r+1}}^{m} \psi\right]\right]\right] \\
&= \partial_{m_{1}} \cdots \partial_{m_{s}} \partial_{k_{r+1}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}} \psi\right] \\
&-\partial_{m_{1}} \cdots \partial_{m_{s}}\left[\partial_{k_{r+1}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\right] \psi\right] \\
&+\sum_{d_{m}>d_{k_{r+1}}} \partial_{m_{1}} \cdots \partial_{m_{s}} \partial_{m}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}} P_{k_{r+1}}^{m} \psi\right] \\
&-\sum_{d_{m}>d_{k_{r+1}}} \partial_{m_{1}} \cdots \partial_{m_{s}}\left[\partial_{m}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\right] P_{k_{r+1}}^{m} \psi\right]
\end{aligned}
$$

The terms in the first and third lines of the last expression have the right form for the case $r+1$. Thus in the term $\partial_{m_{1}} \cdots \partial_{m_{s}} \partial_{k_{r+1}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}} \psi\right], r$ has been replaced by $r+1$, and the set $\{1, \ldots, r, r+1\}$ has been decomposed into $s+1$ subsets $\left\{U_{1}, \ldots, U_{s}, U_{s+1}\right\}$ where $U_{s+1}=\left\{k_{r+1}\right\}$, and $P_{U_{s+1}}^{k_{r+1}}(\mathbf{x}) \equiv 1$. The same is true for each term $\partial_{m_{1}} \cdots \partial_{m_{s}} \partial_{m}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}} P_{k_{r+1}}^{m} \psi\right]$, except that $P_{U_{s+1}}^{m}=P_{k_{r+1}}^{m}$.

For the terms in the second and fourth lines, we use the product rule; we write $\partial_{k_{r+1}}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\right]$ and $\partial_{m}\left[P_{U_{1}}^{m_{1}} \cdots P_{U_{s}}^{m_{s}}\right]$ as a sum of $s$ terms. For example,

\begin{aligned}
\sum_{d_{m}>d_{k_{r+1}}} \partial_{m_{1}} \cdots \partial_{m_{s}} & {\left[\partial_{m}\left[P_{U_{1}}^{m_{1}}\right] P_{U_{2}}^{m_{2}} \cdots P_{U_{s}}^{m_{s}} P_{k_{r+1}}^{m} \psi\right] } \\
& =\partial_{m_{1}} \cdots \partial_{m_{s}}\left[\left(\sum_{d_{m}>d_{k_{r+1}}} \partial_{m}\left[P_{U_{1}}^{m_{1}}\right] P_{k_{r+1}}^{m}\right) P_{U_{2}}^{m_{2}} \cdots P_{U_{s}}^{m_{s}} \psi\right] \\
& =\partial_{m_{1}} \cdots \partial_{m_{s}}\left[\widetilde{P}_{\widetilde{U}_{1}}^{m_{1}} P_{U_{2}}^{m_{2}} \cdots P_{U_{s}}^{m_{s}} \psi\right]
\end{aligned}
$$

where $\widetilde{P}_{\widetilde{U}_{1}}^{m_{1}}=\sum_{d_{m}>d_{k_{r+1}}} \partial_{m}\left[P_{U_{1}}^{m_{1}}\right] P_{k_{r+1}}^{m} \in \mathcal{H}_{d_{m_{1}-d_{U_{1}}-d_{k_{r+1}}}}$. These terms also have the right form for the case $r+1$, since we now let $\widetilde{U}_{1}=U_{1} \cup\left\{k_{r+1}\right\}$, so that $\left\{k_{1}, \ldots, k_{r+1}\right\}=\widetilde{U}_{1} \cup U_{2} \cup \cdots \cup U_{s}$. This establishes the proposition.

The next result shows how to write products of Euclidean derivatives in terms of products of vector fields. Since the proof is similar to that of Proposition 3.4, we omit it.

Proposition 3.5. Let $k_{1}, \ldots, k_{r} \in\{1, \ldots, N\}$ be a set of $r$ integers, possibly with repetitions, chosen from the set $\{1, \ldots, N\}$. There are polynomials $Q_{U_{\ell}}^{m_{\ell}} \in \mathcal{H}_{d_{m_{\ell}}-d_{U_{\ell}}}$ such that
$\partial_{k_{1}} \cdots \partial_{k_{r}}[\psi]=\sum_{s=1}^{r} \sum_{\left(U_{1}, \ldots, U_{s}\right) \in \mathcal{U}_{s}^{r}} \sum_{m_{1} \in \mathfrak{I}\left(U_{1}\right)} \cdots \sum_{m_{s} \in \mathfrak{J}\left(U_{s}\right)} Z_{m_{1}} \cdots Z_{m_{s}}\left[Q_{U_{1}}^{m_{1}} \cdots Q_{U_{s}}^{m_{s}} \psi\right]$.
Here each $Z_{j}$ is either $X_{j}$ or $Y_{j}$. If $s=r$, so that $U_{\ell}=\left\{k_{\ell}\right\}$, the polyno$\operatorname{mial} Q_{U_{\ell}}^{m_{\ell}}(\mathbf{x}) \equiv 1$.

## 4. Normalized bump functions and their dilations

### 4.1. Families of dilations

Fix the family of dilations on $\mathbb{R}^{N}$ given in equation (2.1). We introduce an $N$-parameter family of dyadic ${ }^{4}$ dilations. For $f \in L^{1}\left(\mathbb{R}^{N}\right)$ and $I \in \mathbb{Z}^{N}$ set

$$
2^{I} \cdot \mathbf{x}=\left(2^{-d_{1} i_{1}} x_{1}, \ldots, 2^{-d_{N} i_{N}} x_{N}\right)
$$

$$
\begin{equation*}
[f]_{I}(\mathbf{x})=2^{-\sum_{\ell=1}^{N} d_{\ell} i_{\ell}} f\left(2^{I} \cdot \mathbf{x}\right) \tag{4.1}
\end{equation*}
$$

Then $\left\|[f]_{I}\right\|_{L^{1}\left(\mathbb{R}^{N}\right)}=\|f\|_{L^{1}\left(\mathbb{R}^{N}\right)}$. The set of monotone increasing indices is denoted by

$$
\begin{equation*}
E_{N}=\left\{I=\left(i_{1}, \ldots, i_{N}\right) \in \mathbb{Z}^{N} \mid i_{1} \leq i_{2} \leq \cdots \leq i_{N}\right\} \tag{4.2}
\end{equation*}
$$

When we consider flag kernels corresponding to the decomposition $\mathfrak{A}$ given by $N=a_{1}+\cdots+a_{n}$ and $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, we consider the $n$-parameter family of dilations parameterized by $n$-tuples $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{Z}^{n}$ :

$$
\begin{align*}
2^{I} \cdot \mathbf{x} & =\left(2^{i_{1}} \cdot \mathbf{x}_{1}, \ldots, 2^{i_{n}} \cdot \mathbf{x}_{n}\right), \quad \text { where } \\
2^{i_{\ell}} \cdot \mathbf{x}_{\ell} & =\left(2^{-d_{p_{\ell}} i_{\ell}} x_{p_{\ell}}, \ldots, 2^{-d_{q_{\ell}} \ell_{\ell}} x_{q_{\ell}}\right), \quad \text { and }  \tag{4.3}\\
{[f]_{I}(\mathbf{x}) } & =2^{-\sum_{\ell=1}^{n} Q_{\ell} i_{\ell}} f\left(2^{I} \cdot \mathbf{x}\right) .
\end{align*}
$$

The set of monotone increasing indices in this case is denoted by

$$
\begin{equation*}
\mathcal{E}_{n}=\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{Z}^{n} \mid i_{1} \leq i_{2} \leq \cdots \leq i_{n}\right\} \tag{4.4}
\end{equation*}
$$

Given the decomposition $\mathfrak{A}$, there is a mapping $p_{\mathfrak{A}}: \mathcal{E}_{n} \mapsto E_{N}$ given by

$$
\begin{equation*}
p_{\mathfrak{A}}\left(i_{1}, \ldots, i_{n}\right)=(\overbrace{i_{1}, \ldots, i_{1}}^{a_{1}}, \overbrace{i_{2}, \ldots, i_{2}}^{a_{2}}, \ldots, \overbrace{i_{n}, \ldots, i_{n}}^{a_{n}}) . \tag{4.5}
\end{equation*}
$$

We shall want to write flag kernels as sums of dilates $[\varphi]_{I}$ of normalized bump functions $\varphi$. Roughly speaking, a family of functions $\left\{\varphi_{\alpha}\right\}$ in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ or $\mathcal{S}\left(\mathbb{R}^{N}\right)$ is normalized if one has uniform control of the supports (in the case of $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ ) and of the semi-norms $\left\|\varphi_{\alpha}\right\|_{(m)}$ or $\left\|\varphi_{\alpha}\right\|_{[M]}$. The following definition will simplify the precise statements of our results.

Definition 4.1. (1) If $\varphi, \widetilde{\varphi} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{n}\right)$, then $\widetilde{\varphi}$ is normalized in terms of $\varphi$ if ${ }^{5}$ there are constants $C, C_{m}>0$ and integers $p_{m} \geq 0$ so that:
(a) If the support of $\varphi$ is contained in the ball $B(\rho)$, then the support of $\widetilde{\varphi}$ is contained in the ball $B(C \rho)$.
(b) For every non-negative integer $m,\|\widetilde{\varphi}\|_{(m)} \leq C_{m}\|\varphi\|_{\left(m+p_{m}\right)}$.

[^3](2) If $\psi, \widetilde{\psi} \in \mathcal{S}\left(\mathbb{R}^{n}\right)$, then $\widetilde{\psi}$ is normalized in terms of $\psi$ if there are constants $C_{N}>0$ and integers $p_{N} \geq 0$ so that $\|\widetilde{\psi}\|_{[N]} \leq C_{N}\|\psi\|_{\left[N+p_{N}\right]}$ for every nonnegative integer $N$.
(3) If $P, \widetilde{P}$ are polynomials, then $\widetilde{P}$ is normalized in terms of $P$ if $\widetilde{P}$ is obtained from $P$ by multiplying each coefficient by a constant of modulus less than or equal to 1 .

If $\varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, it is sometimes convenient to write $\varphi$ as a sum of products of functions of a single variable. That this is possible follows from the following fact:

Proposition 4.2. Let $\varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$. Then for each $\alpha \in \mathbb{N}^{N}$ and $1 \leq k \leq N$ there are functions $\varphi_{\alpha, k} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ so that

$$
\varphi\left(x_{1}, \ldots, x_{N}\right)=\sum_{\alpha \in \mathbb{N}^{N}} c_{\alpha} \varphi_{\alpha, 1}\left(x_{1}\right) \cdots \varphi_{\alpha, n}\left(x_{n}\right)
$$

where for any $M>0$, there is a constant $C_{M}$ such that $\left|c_{\alpha}\right| \leq C_{M}(1+|\alpha|)^{-M}$.
Proposition 4.2 follows easily by appropriately periodizing $\varphi$, expanding $\varphi$ in a rapidly converging Fourier series, and then multiplying by appropriate cutoff functions $\psi\left(x_{1}\right) \cdots \psi\left(x_{N}\right)$.

### 4.2. Differentiation and multiplication of dilates of bump functions

In this section we study the action of differentiation or multiplication by a homogeneous polynomial on dilates of bump functions. The key results are Proposition 4.7 and Corollary 4.8 below. We begin with the following result, which follows easily from the definitions and the chain rule:

Proposition 4.3. Let $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. Then

$$
\begin{equation*}
2^{+d_{k} i_{k}} \partial_{k}[\psi]_{I}(\mathbf{x})=\left[\partial_{k} \psi\right]_{I}(\mathbf{x}) \quad \text { and } \quad 2^{-d_{k} i_{k}} x_{k}[\psi]_{I}(\mathbf{x})=\left[x_{k} \psi\right]_{I}(\mathbf{x}) \tag{4.6}
\end{equation*}
$$

More generally, if $I=\left(i_{1}, \ldots, i_{N}\right) \in \mathbb{Z}^{N}$, and $\alpha \in \mathbb{N}^{N}$, then

$$
\begin{equation*}
2^{+\llbracket \alpha \cdot I \rrbracket} \partial^{\alpha}[\psi]_{I}=\left[\partial^{\alpha} \psi\right]_{I} \quad \text { and } \quad 2^{-\llbracket \alpha \cdot I \rrbracket} \mathbf{x}^{\alpha}[\psi]_{I}=\left[\mathbf{x}^{\alpha} \psi\right]_{I}, \tag{4.7}
\end{equation*}
$$

where $\llbracket \alpha \cdot I \rrbracket=\sum_{k=1}^{N} \alpha_{k} d_{k} i_{k}$.
We will frequently use the following generalization of the second identity in equation (4.7):

Proposition 4.4. Let $P \in \mathcal{H}_{d}$ where $d<d_{l}$. If $I \in E_{N}$, there is a polynomial $P_{I} \in \mathcal{H}_{d}$, normalized in terms of $P$, so that

$$
P(\mathbf{x})[\psi]_{I}(\mathbf{x})=2^{d i_{l}}\left[P_{I} \psi\right]_{I}(\mathbf{x})
$$

for $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$.

Proof. Write $P(\mathbf{x})=\sum_{\alpha \in \mathfrak{H}_{d}} c_{\alpha} \mathbf{x}^{\alpha}$ with

$$
\mathfrak{H}_{d}=\left\{\alpha=\left(\alpha_{1}, \ldots, \alpha_{N}\right) \in \mathbb{N}^{N}: \alpha_{1} d_{1}+\cdots+\alpha_{N} d_{N}=d\right\} .
$$

Since $d<d_{l}$, if $\alpha \in \mathfrak{H}_{d}$ we have $\alpha_{j}=0$ for $j \geq l$. According to Proposition 4.3, it follows that $P(\mathbf{x})[\psi]_{I}(\mathbf{x})=\sum_{\alpha \in \mathfrak{H}_{d}} c_{\alpha} 2^{\llbracket \alpha \cdot I \rrbracket}\left[\mathbf{x}^{\alpha} \psi\right]_{I}(\mathbf{x})$, and
$\llbracket \alpha \cdot I \rrbracket=\sum_{m=1}^{l-1} \alpha_{m} d_{m} i_{m}=i_{l} \sum_{m=1}^{l-1} \alpha_{m} d_{m}-\sum_{m=1}^{l-1} \alpha_{m} d_{m}\left(i_{l}-i_{m}\right)=d i_{l}-\sum_{m=1}^{l-1} \alpha_{m} d_{m}\left(i_{l}-i_{m}\right)$.
Thus

$$
P(\mathbf{x})[\psi]_{I}(\mathbf{x})=2^{d i_{l}}\left[\sum_{\alpha \in \mathfrak{H}_{d}} c_{\alpha} 2^{-\sum_{m=1}^{l-1} \alpha_{m} d_{m}\left(i_{l}-i_{m}\right)} \mathbf{x}^{\alpha} \psi\right]_{I}(\mathbf{x}) .
$$

Since $I \in E_{N}$, each exponent $-\sum_{m=1}^{l-1} \alpha_{m} d_{m}\left(i_{l}-i_{m}\right) \leq 0$. The proof is complete if we set $P_{I}(\mathbf{x})=\sum_{\alpha \in \mathfrak{H}_{d}} c_{\alpha} 2^{-\sum_{m=1}^{l-1} \alpha_{m} d_{m}\left(i_{l}-i_{m}\right)} \mathbf{x}^{\alpha}$.

Remark. Equation (4.6) shows that the operator $2^{d_{k} i_{k}} \partial_{x_{k}}$, applied to the $I$-dilate of a function $\varphi$, is the $I$-dilate of a function $\widetilde{\varphi}$ normalized in terms of $\varphi$, and multiplying the $I$-dilate of function $\varphi$ by $2^{-d_{k} i_{k}} x_{k}$ is the $I$-dilate of a function $\widetilde{\varphi}$ normalized in terms of $\varphi$. Thus at 'scale $I$ ', the operators $2^{d_{k} i_{k}} \partial_{x_{k}}$ and $2^{-d_{k} i_{k}} x_{k}$ are 'invariant'; they map the collection of $I$-dilates of normalized functions to itself.

A key observation, which is used when we consider convolution on homogeneous nilpotent groups, is that we can replace the operator $2^{d_{k} i_{k}} \partial_{x_{k}}$ with the operator $2^{d_{k} i_{k}} Z_{k}$, or conversely the operator $2^{d_{k} i_{k}} Z_{k}$ by the operator $2^{d_{k} i_{k}} \partial_{x_{k}}$, at the cost of introducing an error involving terms $2^{d_{l} i_{l}} Z_{l}$ or $2^{d_{l} i_{l}} \partial_{l}$, where $l>k$, multiplied by a 'gain' $2^{-d_{k}\left(i_{l}-i_{k}\right)}$. The precise statement is given in Proposition 4.5 below.

Let $P_{k}^{l} \in \mathcal{H}_{d_{l}-d_{k}}$ be the homogeneous polynomials that are coefficients of a vector field $Z_{k}$ as in equations (3.1) or (3.2), and let $Q_{k}^{l} \in \mathcal{H}_{d_{l}-d_{k}}$ be the polynomials in Proposition 3.2. Since $d_{l}-d_{k}<d_{l}$, we can use Proposition 4.4 to write

$$
\begin{align*}
P_{k}^{l}(\mathbf{x})[\psi]_{I}(\mathbf{x}) & =2^{i_{l}\left(d_{l}-d_{k}\right)}\left[P_{k, I}^{l} \psi\right]_{I}(\mathbf{x}) \\
Q_{k}^{l}(\mathbf{x})[\psi]_{I}(\mathbf{x}) & =2^{i_{l}\left(d_{l}-d_{k}\right)}\left[Q_{k, I}^{l} \psi\right]_{I}(\mathbf{x}) \tag{4.8}
\end{align*}
$$

where $P_{k, I}^{l}, Q_{k, I}^{l} \in \mathcal{H}_{d_{l}-d_{k}}$ are normalized relative to $P_{k}^{l}$ and $Q_{k}^{l}$
Proposition 4.5. Let $I \in E_{N}$, and let $\left\{P_{k, I}^{l}\right\}$ and $\left\{Q_{k, I}^{l}\right\}$ be the homogeneous polynomials defined in equation (4.8). Let $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ (respectively $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ ). Then,

$$
\begin{aligned}
& \left(2^{d_{k} i_{k}} Z_{k}\right)[\psi]_{I}=\left(2^{d_{k} i_{k}} \partial_{k}\right)[\psi]_{I}+\sum_{d_{l}>d_{k}}^{N} 2^{-d_{k}\left(i_{l}-i_{k}\right)}\left(2^{d_{l} i_{l}} \partial_{l}\right)\left[P_{k, I}^{l} \psi\right]_{I} \\
& \left(2^{d_{k} i_{k}} \partial_{k}\right)[\psi]_{I}=\left(2^{d_{k} i_{k}} Z_{k}\right)[\psi]_{I}+\sum_{d_{l}>d_{k}}^{N} 2^{-d_{k}\left(i_{l}-i_{k}\right)}\left(2^{d_{l} i_{l}} Z_{l}\right)\left[Q_{k, I}^{l} \psi\right]_{I}
\end{aligned}
$$

The functions $\left\{P_{k, I}^{l} \psi\right\}$ and $\left\{Q_{k, I}^{l} \psi\right\}$ are normalized with respect to $\psi$ in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ (respectively in $\mathcal{S}\left(\mathbb{R}^{N}\right)$ ).

Proof. The first identity follows immediately from equations (3.2) and (4.8). To obtain the second, use Proposition 3.2 and equation (4.8); we have

& =2^{d_{k} i_{k}} Z_{k}[\psi]_{I}+\sum_{l=k+1}^{N} 2^{-d_{k}\left(i_{l}-i_{k}\right)}\left(2^{d_{l} i_{l}} Z_{l}\right)\left[Q_{k, I}^{l} \psi\right]_{I},
\end{aligned}
$$

which is the desired formula.
Corollary 4.6. If $\varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ (respectively $\left.\varphi \in \mathcal{S}\left(\mathbb{R}^{N}\right)\right)$ and if $I \in E_{N}$, then there is a function $\widetilde{\varphi} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ (respectively $\widetilde{\varphi} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ ), normalized with respect to $\varphi$, such that $2^{d_{k} i_{k}} Z_{k}[\varphi]_{I}=[\widetilde{\varphi}]_{I}$.

We shall need an analogue of Proposition 4.5 for $r$-fold products of vector fields or Euclidean derivatives. If $\left\{P_{U_{l}}^{m_{l}}\right\}$ and $\left\{Q_{U_{l}}^{m_{l}}\right\}$ are the polynomials appearing in Propositions 3.4 and 3.5, we use Proposition 4.4 to define polynomials $P_{U_{l}, I}^{m_{l}}$ and $Q_{U_{l}, I}^{m_{l}}$ by the formulas

Proposition 4.7. Let $k_{1}, \ldots, k_{r} \in\{1, \ldots, N\}$ be a set of $r$ integers, possibly with repetitions, and let $I \in E_{N}$. Let $Z_{\ell}$ denote either $X_{\ell}$ or $Y_{\ell}$. Then

&\left(2^{d_{k_{1}} i_{k_{1}}} Z_{k_{1}}\right) \cdots\left(2^{d_{k_{r}} i_{k_{r}}} Z_{k_{r}}\right)[\psi]_{I} \\
&=\sum_{s=1}^{r} \sum_{\left(U_{1}, \ldots, U_{s}\right) \in \mathcal{U}_{s}^{r}} \sum_{m_{1} \in \mathcal{I}\left(U_{1}\right)} \cdots \sum_{m_{s} \in \mathcal{I}\left(U_{s}\right)} 2^{\sum_{\ell=1}^{r} d_{k_{\ell}} i_{k_{\ell}}-\sum_{\ell=1}^{s} i_{m_{\ell}} d_{U_{\ell}}} \\
& \cdot\left(2^{d_{m_{1}} i_{m_{1}}} \partial_{m_{1}}\right) \cdots\left(2^{d_{m_{s}} i_{m_{s}}}\right. \\
&\left.\partial_{m_{s}}\right)\left[P_{U_{1}, I}^{m_{1}} \cdots P_{U_{s}, I}^{m_{s}} \psi\right]_{I},
\end{aligned}

and

&=\sum_{s=1}^{r} \sum_{\left(U_{1}, \ldots, U_{s}\right) \in \mathcal{U}_{s}^{r}} \sum_{m_{1} \in \mathfrak{J}\left(U_{1}\right)} \cdots \sum_{m_{s} \in \mathcal{I}\left(U_{s}\right)} 2^{\sum_{\ell=1}^{r} d_{k_{\ell}} i_{k_{\ell}}-\sum_{\ell=1}^{s} i_{m_{\ell}} d_{U_{\ell}}} \\
& \cdot\left(2^{d_{m_{1}} i_{m_{1}}} Z_{m_{1}}\right) \cdots\left(2^{d_{m_{s}} i_{m_{s}}} Z_{m_{s}}\right)\left[Q_{U_{1}, I}^{m_{1}} \cdots Q_{U_{s}, I}^{m_{s}} \psi\right]_{I} .

In either identity, if $s=r$ so that $U_{\ell}=\left\{k_{\ell}\right\}, 1 \leq \ell \leq r$, the polynomials

Proof. Using Proposition 3.4, we have

& =2^{\sum_{==1}^{r} d_{k_{\ell}} i_{k_{\ell}}} \sum_{s=1}^{r} \sum_{\mathcal{U} \in \mathcal{U}_{s}^{r}} \sum_{j=1}^{s} \sum_{m_{j} \in \mathcal{T}\left(U_{j}\right)} Z_{m_{1}} \cdots Z_{m_{s}}\left[Q_{U_{1}}^{m_{1}} \cdots Q_{U_{s}}^{m_{s}}[\psi]_{I}\right] \\
& =2^{\sum_{e=1}^{r} d_{k_{\ell}} i_{k_{\ell}}} \sum_{s=1}^{r} \sum_{\mathcal{U} \in \mathcal{U}_{s}^{r}} \sum_{j=1}^{s} \sum_{m_{j} \in \mathcal{T}\left(U_{j}\right)} 2^{\sum_{e=1}^{s} i_{m_{\ell}}\left(d_{m_{\ell}}-d_{U_{\ell}}\right)} Z_{m_{1}} \cdots Z_{m_{s}}\left[Q_{U_{1}, I}^{m_{1}} \cdots Q_{U_{s}, I}^{m_{s}} \psi\right]_{I} \\
& =\sum_{s=1}^{r} \sum_{\mathcal{U} \in \mathcal{U}_{s}^{r}} \sum_{j=1}^{s} \sum_{m_{j} \in \mathcal{J}\left(U_{j}\right)} 2^{2^{r} \sum_{=1}^{r} d_{k_{\ell}} i_{k_{\ell}}-\sum_{\ell=1}^{s} i_{m_{\ell}} d_{U_{\ell}}} \\

This completes the proof of the first identity. The second identity is established in the same way.

In Proposition 4.7, we can rewrite the exponent of the power of 2 as follows. Having chosen $\mathcal{U}=\left(U_{1}, \ldots, U_{s}\right) \in \mathcal{U}_{s}^{r}$, there is a unique mapping $\sigma=\sigma_{\mathcal{U}}$ : $\{1, \ldots, r\} \rightarrow\{1, \ldots, s\}$ so that $\ell \in U_{\sigma(\ell)}$ for $1 \leq \ell \leq r$. Then

$$
\sum_{\ell=1}^{r} d_{k_{\ell}} i_{k_{\ell}}-\sum_{\ell=1}^{s} i_{m_{\ell}} d_{U_{\ell}}=\sum_{\ell=1}^{r} d_{k_{\ell}} i_{k_{\ell}}-\sum_{\ell=1}^{r} i_{m_{\sigma(\ell)}} d_{k_{\ell}}=-\sum_{\ell=1}^{r} d_{k_{\ell}}\left(i_{m_{\sigma(\ell)}}-i_{k_{\ell}}\right)

Since $\ell \in U_{\sigma(\ell)}$ and $m_{\sigma(\ell)} \in \Im\left(U_{\sigma(\ell)}\right)$, it follows that $d_{m_{\sigma(\ell)}} \geq d_{U_{\sigma(\ell)}} \geq d_{k_{\ell}}$, with equality only possible if $U_{\sigma(\ell)}=\{\sigma(\ell)\}$. Thus if $I \in E_{N}$, it follows that $i_{m_{\sigma(\ell)}} \geq i_{k_{\ell}}$, in which case

where we can take $\epsilon=d_{1}>0$.
We can now recast the identities in Proposition 4.7 in a way which, although losing some information, makes them more useful and easier to work with when dealing with flag kernels.

Corollary 4.8. Fix a decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$. Let $k_{1}, \ldots, k_{r} \in$ $\{1, \ldots, N\}$ be a set of $r$ integers, possibly with repetitions, with $k_{\ell} \in J_{\pi(\ell)}{ }^{6}$ For $1 \leq \ell \leq r$, let $Z_{k_{\ell}}$ denote either $X_{k_{\ell}}$ or $Y_{k_{\ell}}$. Let $I \in \mathcal{E}_{n}$, and let $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ or $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$.
(1) The function $\left(2^{d_{k_{1}} i_{\pi(1)}} Z_{k_{1}}\right) \cdots\left(2^{d_{k_{r}} i_{\pi(r)}} Z_{k_{r}}\right)[\psi]_{I}$ can be written as a finite sum of terms of the following form. Decompose the set $\{1, \ldots, r\}$ into two disjoint complementary subsets $A$ and $B$ with $\pi(j) \neq n$ for any $j \in A$ and $B \neq \emptyset$. Let

Decompose the set $\{1, \ldots, r\}$ into two disjoint complementary subsets $A$ and $B$ with $\pi(j) \neq n$ for any $j \in A$ and $B \neq \emptyset$. where $\psi_{A, B, \bar{m}}$ is normalized relative to $\psi$.
Remarks 4.9. (a) The essential point of part (1) in the corollary is that, when replacing the operator
$$
\left(2^{d_{k_{1}} i_{\pi(1)}} Z_{k_{1}}\right) \cdots\left(2^{d_{k_{r}} i_{\pi(r)}} Z_{k_{r}}\right)[\psi]_{I}
$$
with a sum of terms of the form

2^{-\epsilon \sum_{j \in A}\left(i_{\pi(j)+1}-i_{\pi(j)}\right)}\left(2^{d_{m_{1}} i_{\pi(1)}} \partial_{m_{1}}\right) \cdots\left(2^{d_{m_{s}} i_{\pi(s)}} \partial_{m_{s}}\right)\left[\psi_{A, B, \bar{m}}\right]_{I}
$$
either the factor $\left(2^{d_{k_{\ell}} i_{\pi(\ell)}} Z_{k_{\ell}}\right)$ is replaced by a term $\left(2^{d_{m_{\ell}} i_{\pi(\ell)}} \partial_{m_{\ell}}\right)$, where the coordinate $x_{m_{\ell}}$ belongs to the same subspace as $x_{k_{\ell}}$ and hence has the same dilation $i_{\pi(\ell)}$, or it is replaced by the gain $2^{-\epsilon\left(i_{\pi(\ell)+1}-i_{\pi(\ell)}\right)}$. Part (2) is the same assertion with the roles of the vector fields and Euclidean differentiation interchanged.
(b) One term in the expansion of $\left(2^{d_{k_{1}} i_{\pi(1)}} Z_{k_{1}}\right) \cdots\left(2^{d_{k_{r}} i_{\pi(r)}} Z_{k_{r}}\right)[\psi]_{I}$ in part (1) arises by letting $A=\emptyset$ so that $B=\{1, \ldots, r\}$, and then choosing $m_{r}=k_{r}$. We have seen that in this case the function $\psi_{A, B, \bar{m}}=\psi$, so we get the term

Every other term in the expansion then involves either a gain $2^{-\epsilon\left(i_{\pi(\ell)+1}-i_{\pi(\ell)}\right)}$ or the replacement of a variable $x_{k_{\ell}}$ by a different variable $x_{m_{\ell}}$ with $d_{m_{\ell}}>d_{k_{\ell}}$. We shall say that any term of the form

where either $A \neq \emptyset$ or some $d_{m_{\ell}}>d_{k_{\ell}}$ is an allowable error. Thus the difference

$$
\left(2^{d_{k_{1}} i_{\pi(1)}} Z_{k_{1}}\right) \cdots\left(2^{d_{k_{r}} i_{\pi(r)}} Z_{k_{r}}\right)[\psi]_{I}-\left(2^{d_{k_{1}} i_{\pi(1)}} \partial_{k_{1}}\right) \cdots\left(2^{d_{k_{r} r} i_{\pi(r)}} \partial_{k_{r}}\right)[\psi]_{I}
$$

is a sum of allowable errors.
(c) Since Euclidean derivatives commute, it follows that if $\sigma$ is any permutation of the set $\{1, \ldots, r\}$, then the difference

$$
\left(2^{d_{k_{1}} i_{\pi(1)}} Z_{k_{1}}\right) \cdots\left(2^{d_{k_{r}} i_{\pi(r)}} Z_{k_{r}}\right)[\psi]_{I}-\left(2^{d_{k_{1}} i_{\pi(1)}} Z_{k_{\sigma(1)}}\right) \cdots\left(2^{d_{k_{r}} i_{\pi(r)}} Z_{k_{\sigma(r)}}\right)[\psi]_{I}
$$

is a sum of allowable errors.

## 5. Cancellation

A function is often said to have cancellation if its average or integral is zero. For our purposes, we shall need a more refined notion involving integrals in some subset of variables. Let $J=\left\{j_{1}, \ldots, j_{s}\right\} \subseteq\{1, \ldots, N\}$. If $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, write

$$
\begin{equation*}
\int \psi(\mathbf{x}) d \mathbf{x}_{J}=\int_{\mathbb{R}^{s}} \psi\left(x_{1}, \ldots, x_{N}\right) d x_{j_{1}} \cdots d x_{j_{s}} \tag{5.1}
\end{equation*}
$$

Note that $\int \psi(\mathbf{x}) d \mathbf{x}_{J}$ is then a function of the variables $x_{k}$ for which $k \notin J$. We say that a function $\psi$ has cancellation in the variables $\left\{x_{j_{1}}, \ldots, x_{j_{s}}\right\}$ if $\int_{\mathbb{R}^{s}} \psi(\mathbf{x}) d \mathbf{x}_{J} \equiv 0$, where $J=\left\{j_{1}, \ldots, j_{s}\right\}$. Later, in Section 5.2, we shall give additional definitions of 'strong cancellation' and 'weak cancellation' for a function $\psi$.

### 5.1. Cancellation and the existence of primitives

We begin by showing that cancellation in certain collections of variables is equivalent to the existence of appropriate primitives.

Lemma 5.1. Let $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, and let $J_{k} \subseteq\{1, \ldots, n\}$ be non-empty subsets for $1 \leq k \leq r$. If the sets $\left\{J_{k}\right\}$ are mutually disjoint, then the following two statements are equivalent:
(a) For $1 \leq k \leq r, \int \psi(\mathbf{x}) d \mathbf{x}_{J_{k}}=0$.
(b) There are functions $\psi_{j_{1}, \ldots, j_{r}} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, normalized with respect to $\psi$, such that

$$
\psi(\mathbf{x})=\sum_{j_{1} \in J_{1}} \cdots \sum_{j_{r} \in J_{r}} \partial_{j_{1}} \cdots \partial_{j_{r}} \psi_{j_{1}, \ldots, j_{r}}(\mathbf{x})
$$

Moreover, if the function $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, then we can choose the functions $\psi_{j_{1}, \ldots, j_{r}} \in$ $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ normalized with respect to $\psi$.

It follows easily from the Fundamental Theorem of Calculus that (b) implies (a). The main content of the lemma is thus the opposite implication. This will follow by induction on $r$ from the following assertion:

Proposition 5.2. Let $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$. Suppose that $J_{1}, J_{2} \subset\{1, \ldots, N\}$ are nonempty and disjoint. If $\int \psi(\mathbf{x}) d \mathbf{x}_{J_{1}}=\int \psi(\mathbf{x}) d \mathbf{x}_{J_{2}}=0$, then for each $k \in J_{1}$ there is a function $\psi_{k} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, normalized relative to $\psi$, so that:
(i) we can write $\psi=\sum_{k \in J_{1}} \partial_{k} \psi_{k}$;
(ii) for each $k \in J_{1}$ we still have $\int \psi_{k}(\mathbf{x}) d \mathbf{x}_{J_{2}}=0$.

If $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, the same conclusions hold except that the functions $\psi_{k} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ and are normalized relative to $\psi$.

Proof. By relabeling the coordinates, we can assume that $J_{1}=\{1, \ldots, k\}$, and that $J_{2} \subseteq\{k+1, \ldots, N\}$. Suppose that $\psi$ has compact support in the set $B=$ $\left\{\mathbf{x} \in \mathbb{R}^{N}:\left|x_{j}\right|<a_{j}\right\}$. Choose $\chi \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ with support in $[-1,+1]$ such that $\int_{\mathbb{R}} \chi(s) d s=1$, and put $\chi_{j}(t)=a_{j}^{-1} \chi\left(a_{j}^{-1} t\right)$ so that $\chi_{j}$ is supported in $\left[-a_{j},+a_{j}\right]$ and still has integral equal to 1 . Put

$$
\varphi_{1}(\mathbf{x})=\psi(\mathbf{x})-\chi_{1}\left(x_{1}\right) \int_{\mathbb{R}} \psi\left(s, x_{2}, \ldots, x_{N}\right) d s
$$

and for $2 \leq j \leq k$, put

$$
\begin{aligned}
\varphi_{j}(\mathbf{x})= & {\left[\prod_{l=1}^{j-1} \chi_{l}\left(x_{l}\right)\right] \int_{\mathbb{R}^{j-1}} \psi\left(s_{1}, \ldots, s_{j-1}, x_{j}, \ldots, x_{N}\right) d s_{1} \cdots d s_{j-1} } \\
& -\left[\prod_{l=1}^{j} \chi_{l}\left(x_{l}\right)\right] \int_{\mathbb{R}^{j}} \psi\left(s_{1}, \ldots, s_{j}, x_{j+1}, \ldots, x_{N}\right) d s_{1} \cdots d s_{j}
\end{aligned}
$$

Then the functions $\left\{\varphi_{j}\right\}$ have the following properties. First, since $\int \psi(\mathbf{x}) d \mathbf{x}_{J_{1}}=0$, the second integral in the definition of the last function $\varphi_{k}$ is zero, and hence $\psi(\mathbf{x})=\sum_{j=1}^{k} \varphi_{j}(\mathbf{x})$. Next, it is clear that each $\varphi_{j}$ is supported in the set $B$. Finally, for $1 \leq j \leq k$,

$$
\int_{\mathbb{R}} \varphi_{j}\left(x_{1}, \ldots, x_{j-1}, s, x_{j+1}, \ldots, x_{N}\right) d s=0
$$

so if we put

$$
\begin{align*}
\psi_{j}(\mathbf{x}) & =\int_{-\infty}^{x_{j}} \varphi_{j}\left(x_{1}, \ldots, x_{j-1}, s, x_{j+1}, \ldots, x_{N}\right) d s \\
& =-\int_{x_{j}}^{\infty} \varphi_{j}\left(x_{1}, \ldots, x_{j-1}, s, x_{j+1}, \ldots, x_{N}\right) d s \tag{5.2}
\end{align*}
$$

then $\psi_{j}$ is supported on the set $B$, and $\varphi_{j}(\mathbf{x})=\partial_{j} \psi_{j}(\mathbf{x})$. It is clear that one can estimate the size of the derivatives of the functions $\left\{\psi_{j}\right\}$ in terms of the derivatives of $\psi$, so $\psi_{j}$ is normalized in terms of $\psi$. Moreover, since $\int \psi(\mathbf{x}) d \mathbf{x}_{J_{2}}=0$, it follows from their definitions that $\int \varphi_{j}(\mathbf{x}) d \mathbf{x}_{J_{2}}=0$, and hence $\int \psi_{j}(\mathbf{x}) d \mathbf{x}_{J_{2}}=0$. This completes the proof if $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$. If $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, the proof goes the same way. One only has to observe from equation (5.2) that the functions $\psi_{j} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. This completes the proof of Proposition 5.2, and hence Lemma 5.1 is also established.

### 5.2. Strong and weak cancellation

In this section we introduce two kinds of cancellation conditions that can be imposed on functions in $\mathcal{S}\left(\mathbb{R}^{N}\right)$ or $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$. As discussed in Section 1.1, these concepts are used in the context of the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$ given in (2.3), where $a_{1}+\cdots+a_{n}=N$ and each $a_{j} \geq 1$. Recall that if $\mathbf{x} \in \mathbb{R}^{N}$, we write
$\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)$ where $\mathbf{x}_{l}=\left(x_{p_{l}}, x_{p_{l}+1}, \ldots, x_{q_{l}}\right) \in \mathbb{R}^{a_{l}}$. We then let $J_{l}$ denote the set of integers $\left\{p_{l}, p_{l}+1, \ldots, q_{l}\right\}$. If $\varphi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, set

$$
\begin{equation*}
\int_{\mathbb{R}^{a_{l}}} \varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{l}=\int_{\mathbb{R}^{a_{l}}} \varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) d x_{p_{l}} \cdots d x_{q_{l}} \tag{5.3}
\end{equation*}
$$

Definition 5.3. Fix the decomposition (2.3), and let $\varphi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. The function $\varphi$ has strong cancellation if and only if

$$
\int_{\mathbb{R}^{a_{l}}} \varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{\ell} \equiv 0, \quad 1 \leq \ell \leq n
$$

That is, $\varphi$ has strong cancellation if and only if it has cancellation in each collection of variables $\left\{x_{p_{l}}, \ldots, x_{q_{l}}\right\}$ for $1 \leq l \leq n$.

Remark 5.4. It follows from Proposition 5.2 that $\varphi$ has strong cancellation if and only if there are functions $\varphi_{j_{1}, \ldots, j_{n}}$ normalized with respect to $\varphi$ so that

$$
\varphi=\sum_{j_{1} \in J_{1}} \cdots \sum_{j_{n} \in J_{n}} \partial_{j_{1}} \cdots \partial_{j_{n}} \varphi_{j_{1}, \ldots, j_{n}}
$$

We now introduce a weaker cancellation condition.
Definition 5.5. Fix the decomposition (2.3) of $\mathbb{R}^{N}$. Let $\varphi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ or $\varphi \in$ $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, and let $I=\left(i_{1}, \ldots i_{n}\right) \in \mathcal{E}_{n}$. The function $\varphi$ has weak cancellation with parameter $\epsilon>0$ relative to the multi-index $I$ if and only if

$$
\varphi=\sum_{\substack{A \cup B=\{1, \ldots, n\} \\ A=\left\{\alpha_{1}, \ldots, \alpha_{r}\right\} \\ n \notin B}}\left(\prod_{s \in B} 2^{-\epsilon\left(i_{s+1}-i_{s}\right)}\right) \sum_{j_{1} \in J_{\alpha_{1}}} \cdots \sum_{j_{r} \in J_{\alpha_{r}}}\left(\partial_{j_{1}} \cdots \partial_{j_{r}}\right)\left[\varphi_{\left.A, B, j_{1}, \ldots, j_{r}\right]}\right]
$$

where each $\varphi_{A, B, j_{1}, \ldots, j_{r}}$ is normalized relative to $\varphi$. Here the outer sum is taken over all decompositions of the set $\{1, \ldots, n\}$ into two disjoint subsets $A$ and $B$ such that $n \in A$.

According to Remark 5.4, $\varphi$ has strong cancellation if it can be written as a sum of functions of the form $\partial_{j_{1}} \cdots \partial_{j_{n}} \varphi$; i.e., as $n^{\text {th }}$-derivatives of functions where there is one derivative in a variable from each of the $n$ subspaces $\mathbb{R}^{a_{l}}$. Definition 5.5 imposes a weaker condition; a function $\varphi$ has weak cancellation if again it is a sum of terms, but the term $\partial_{j_{1}} \cdots \partial_{j_{n}} \varphi_{j_{1}, \ldots, j_{n}}$ is itself replaced by a new sum of terms. If a derivative $\partial_{j_{l}}$ does not appear, so that the term does not have cancellation in the subspace $\mathbb{R}^{a_{l}}$, there is instead a gain given by $2^{-\epsilon\left(i_{l+1}-i_{l}\right)}$.

Remarks 5.6. There will be occasions when we will use the fact that a function $\varphi$ has weak cancellation with respect to $I \in \mathcal{E}_{n}$ to draw inferences about existence of primitives and smallness in only some of the subspaces $\left\{\mathbb{R}^{a_{l}}\right\}$. In particular, the following assertions follow easily from Definition 5.5:
(1) Suppose that $I \in \mathcal{E}_{n}$ and that $\varphi$ has weak cancellation relative to $I$. Let $M \subset\{1, \ldots, n\}$. Then

$$
\varphi=\sum_{\substack{A \cup B=M \\ A=\left\{\alpha_{1}, \ldots, \alpha_{r}\right\} \\ n \notin B}}\left(\prod_{s \in B} 2^{-\epsilon\left(i_{s+1}-i_{s}\right)}\right) \sum_{\substack{j_{1} \in J_{\alpha_{1}}}} \cdots \sum_{j_{r} \in J_{\alpha_{r}}}\left(\partial_{j_{1}} \cdots \partial_{j_{s}}\right)\left[\widetilde{\varphi}_{\left.A, B, j_{1}, \ldots, j_{r}\right]}\right.
$$

where each $\widetilde{\varphi}_{A, B, j_{1}, \ldots, j_{r}}$ is normalized relative to $\varphi$, and where the outer sum is over all subsets $B \subset M$, with the understanding that if $n \in M$ then $n \notin B$.
(2) In particular, if we take $M=\{1\}$, it follows that if $\varphi$ has weak cancellation relative to $I \in \mathcal{E}_{n}$, we can write

$$
\varphi=\sum_{r=1}^{a_{1}} \partial_{r}\left[\varphi_{r}\right]+2^{-\epsilon\left(i_{2}-i_{1}\right)} \varphi_{0}
$$

where $\left\{\varphi_{0}, \varphi_{1}, \ldots, \varphi_{a_{1}}\right\}$ are normalized relative to $\varphi$. Here, the derivatives are with respect to the variables in the first subspace $\mathbb{R}^{a_{1}}$.

We can also characterize weak cancellation in terms of the "smallness" of integrals, to be compared with the characterization of strong cancellation in terms of the vanishing of integrals given in Lemma 5.1. For any partition $\{1, \ldots, n\}=A \cup B$ with $A=\left\{j_{1}, \ldots, j_{a}\right\}$ and $B=\left\{k_{1}, \ldots, k_{b}\right\}$, write $\mathbf{x} \in \mathbb{R}^{N}$ as $\mathbf{x}=\left(\mathbf{x}_{A}, \mathbf{x}_{B}\right)$ where $\mathbf{x}_{A}=\left(\mathbf{x}_{j_{1}}, \ldots, \mathbf{x}_{j_{a}}\right), \mathbf{x}_{B}=\left(\mathbf{x}_{k_{1}}, \ldots, \mathbf{x}_{k_{b}}\right)$. Let $d \mathbf{x}_{A}=d \mathbf{x}_{j_{1}} \cdots d \mathbf{x}_{j_{a}}$, and let $d \mathbf{x}_{B}=d \mathbf{x}_{k_{1}} \cdots d \mathbf{x}_{k_{b}}$.
Proposition 5.7. Let $\epsilon>0$ and $I \in \mathcal{E}_{n}$. A function $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ has weak cancellation with parameter $\epsilon$ relative to $I$ if and only if for every partition $\{1, \ldots, n\}=$ $A \cup B$ into disjoint subsets we have

$$
\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} \psi\left(\mathbf{x}_{A}, \mathbf{x}_{B}\right) d \mathbf{x}_{B}=\left\{\begin{array}{cl}
0 & \text { if } n \in B \\
{\left[\prod_{k \in B} 2^{-\epsilon\left(i_{k+1}-i_{k}\right)}\right] \psi_{A}\left(\mathbf{x}_{A}\right)} & \text { if } n \notin B
\end{array}\right.
$$

where $\psi_{A} \in \mathcal{S}\left(\bigoplus_{j \in A} \mathbb{R}^{a_{j}}\right)$ is normalized relative to $\psi$. If $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, the functions $\psi_{A} \in C_{0}^{\infty}\left(\bigoplus_{j \in A} \mathbb{R}^{a_{j}}\right)$.
Proof. It is clear that if $\psi$ has weak cancellation, then it satisfies the condition of Proposition 5.7, so the main content is the opposite implication.

Let $\chi_{l} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{a_{l}}\right)$ have support in the set where $\left|\mathbf{x}_{l}\right| \leq 1$, with $\int_{\mathbb{R}^{a_{l}}} \chi\left(\mathbf{x}_{l}\right) d \mathbf{x}_{l}=1$. For $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ and $1 \leq l \leq N$, define

$$
\begin{aligned}
L_{l}[\psi](\mathbf{x}) & =\psi(\mathbf{x})-\chi_{l}\left(\mathbf{x}_{l}\right) \int_{\mathbb{R}^{a_{l}}} \psi(\mathbf{x}) d \mathbf{x}_{l} \\
M_{l}[\psi](\mathbf{x}) & =\chi_{l}\left(\mathbf{x}_{l}\right) \int_{\mathbb{R}^{a_{l}}} \psi(\mathbf{x}) d \mathbf{x}_{l} .
\end{aligned}
$$

It is easy to check that the operators $\left\{L_{1}, \ldots, L_{n}, M_{1}, \ldots, M_{n}\right\}$ all commute, and that

$$
\int_{\mathbb{R}^{a_{l}}} M_{l}[\psi](\mathbf{x}) d \mathbf{x}_{l}=\int_{\mathbb{R}^{a_{l}}} \psi(\mathbf{x}) d \mathbf{x}_{l} \quad \text { and } \quad \int_{\mathbb{R}^{a_{l}}} L_{l}[\psi](\mathbf{x}) d \mathbf{x}_{l}=0 .
$$

Since $L_{l}+M_{l}$ is the identity operator, if $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$,

$$
\begin{aligned}
\psi(\mathbf{x}) & =\prod_{l=1}^{n}\left(L_{l}+M_{l}\right)[\psi](\mathbf{x}) \\
& =\sum_{A \cup B=\{1, \ldots, n\}}\left(\prod_{j \in A} L_{l}\right)\left(\prod_{k \in B} M_{k}\right)[\psi](\mathbf{x})=\sum_{A \cup B=\{1, \ldots, n\}} \psi_{A, B}(\mathbf{x}) .
\end{aligned}
$$

It is clear that the functions $\left\{\psi_{A, B}\right\}$ are normalized relative to $\psi$.
Now suppose that $\psi$ satisfies the hypotheses of Proposition 5.7. Since

$$
\left(\prod_{k \in B} M_{k}\right)[\psi](\mathbf{x})=\left(\prod_{k \in B} \chi_{k}\left(\mathbf{x}_{k}\right)\right) \int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} \psi\left(\mathbf{x}_{A}, \mathbf{x}_{B}\right) d \mathbf{x}_{B}
$$

it follows that $\psi_{A, B} \equiv 0$ if $n \in B$. Also, for every $j \in A$ we have

$$
\int_{\mathbb{R}^{a_{j}}} \psi_{A, B}(\mathbf{x}) d \mathbf{x}_{j}=0
$$

Thus for every decomposition $\{1, \ldots, n\}=A \cup B$ with $n \in A$, it follows that

$$
\left(\prod_{k \in B} M_{k}\right)[\psi](\mathbf{x})=\left[\prod_{k \in B} 2^{-\epsilon\left(i_{k+1}-i_{k}\right)}\right] \psi_{A}\left(\mathbf{x}_{A}\right)\left(\prod_{k \in B} \chi_{k}\left(\mathbf{x}_{k}\right)\right)
$$

where $\psi_{A}$ is normalized relative to $\psi$. But then

$$
\begin{aligned}
\psi_{A, B}(\mathbf{x}) & =\left(\prod_{j \in A} L_{l}\right)\left(\prod_{k \in B} M_{k}\right)[\psi](\mathbf{x}) \\
& =\left[\prod_{k \in B} 2^{-\epsilon\left(i_{k+1}-i_{k}\right)}\right]\left(\prod_{j \in A} L_{l}\right)\left[\psi_{A}\right]\left(\mathbf{x}_{A}\right)\left(\prod_{k \in B} \chi_{k}\left(\mathbf{x}_{k}\right)\right) .
\end{aligned}
$$

Now the function $\left(\prod_{j \in A} L_{l}\right)\left[\psi_{A}\right]\left(\mathbf{x}_{A}\right)\left(\prod_{k \in B} \chi_{k}\left(\mathbf{x}_{k}\right)\right)$ has cancellation in each of the subspaces $\mathbb{R}^{a_{j}}$ for $j \in A$. If we write $A=\left\{\alpha_{1}, \ldots \alpha_{r}\right\}$, it follows from Lemma 5.1 that this function can be written as a sum of terms of the form $\partial_{j_{1}} \cdots \partial_{j_{r}}\left[\psi_{A, B, \sigma}\right]$, where the variable $x_{j_{k}}$ belongs to the subspace $\mathbb{R}^{a_{\alpha_{k}}}$. This then makes it clear that $\psi$ has weak cancellation, and completes the proof.

## 6. The structure of flag kernels

In this section we establish four important properties of flag kernels. The first (Theorem 6.1) shows how to decompose a given flag kernel into a sum of dilates of compactly supported functions with strong cancellation. The second (Theorem 6.8) shows conversely that a sum of dilates of Schwartz functions with weak cancellation converges to a flag kernel. The third (Theorem 6.13) shows that the cancellation conditions imposed in part (b) of Definition 2.3 can be relaxed. The fourth (Theorem 6.15) shows that the family of flag kernels is invariant under appropriately chosen changes of variables.

### 6.1. Dyadic decomposition of flag kernels

Every flag kernel is a product kernel in the sense of Definition 2.1.1 of [9]. (This is proved in [9]). Then Corollary 2.2.2 in that reference implies that if $\mathcal{K}$ is a flag kernel, then there are functions $\varphi^{I} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right), I \in \mathbb{Z}^{n}$ with strong cancellation and uniformly bounded seminorms $\left\|\varphi^{I}\right\|_{(m)}$, supported in the set where $\frac{1}{2} \leq N_{j}\left(\mathbf{x}_{j}\right) \leq 4$ for every $j$, such that $\mathcal{K}=\sum_{I \in \mathbb{Z}^{n}}\left[\varphi^{I}\right]_{I}$ in the sense of distributions. Recall that $\mathcal{E}_{n}=\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{Z}^{n}: i_{1} \leq i_{2} \leq \cdots \leq i_{n}\right\}$. Since a flag kernel satisfies better differential inequalities than a general product kernel, one expects that it should be possible to write $\mathcal{K}$ as a sum of dilates of functions $\varphi^{I} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ where the dilations range only over the set $\mathcal{E}_{n}$ instead of over all of $\mathbb{Z}^{n}$. Such a result is stated in Corollary 2.2.4 of [9], but the precise statement there is not correct because one must allow additional terms involving flag kernels adapted to coarser flags. This section provides a correct statement and proof.

Theorem 6.1. Let $\mathcal{K}$ be a flag kernel adapted to the standard flag $\mathcal{F}$

$$
\begin{equation*}
(0) \subseteq \mathbb{R}^{a_{n}} \subseteq \mathbb{R}^{a_{n-1}} \oplus \mathbb{R}^{a_{n}} \subseteq \cdots \subseteq \mathbb{R}^{a_{3}} \oplus \cdots \oplus \mathbb{R}^{a_{n}} \subseteq \mathbb{R}^{a_{2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}} \subseteq \mathbb{R}^{N} \tag{2.4}
\end{equation*}
$$

Then there is a decomposition $\mathcal{K}=\mathcal{K}_{0}+\mathcal{K}_{1}+\cdots+\mathcal{K}_{n}$ with the following properties:
(1) For each $I \in \mathcal{E}_{n}$ there is a function $\varphi^{I} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ so that $\mathcal{K}_{0}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$ with convergence in the sense of distributions. Moreover,
(a) the support of each function $\varphi^{I}$ is contained in the unit ball $B=\left\{\mathbf{x} \in \mathbb{R}^{N}\right.$ : $|\mathbf{x}| \leq 1\} ;$
(b) there are constants $C_{m}>0$ (depending on the constants for the flag kernel $\mathcal{K})$ so that for each $I \in \mathcal{E}_{n}$ and all $m \geq 0,\left\|\varphi^{I}\right\|_{(m)} \leq C_{m}$;
(c) each function $\varphi^{I}$ has strong cancellation in the sense of Definition 5.3: for $1 \leq j \leq n$,

$$
\int_{\mathbb{R}^{a_{j}}} \varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{j}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{j}=0
$$

(d) for each $I \in \mathcal{E}_{n}, \varphi^{I}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)=0$ for $\left|\mathbf{x}_{1}\right|<\frac{1}{8}$.
(2) For $1 \leq j \leq n$, each $\mathcal{K}_{j}$ is a flag kernel adapted to a flag which is strictly coarser than $\mathcal{F}$.

Recall that in Section 1.2 we distinguished between elements $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$ where we have strict inequality $i_{1}<i_{2}<\cdots<i_{n-1}<i_{n}$, and elements where some of the entries are equal. Underlying this dichotomy is the fact that $\mathcal{E}_{n}$ is a polyhedral cone in $\mathbb{Z}^{n}$, the set of elements with strict inequality form the 'open' $n$-dimensional interior, and elements with various sets of equal elements correspond to lower dimensional faces. In Theorem 6.1, we may as well assume that the dyadic sum representing $\mathcal{K}_{0}$ extends over the interior $n$-tuples with strictly increasing components, leaving the "boundary $n$-tuples" with repeated indices to parametrize the dyadic terms of the sums representing the other $\mathcal{K}_{j}$ 's.

Using induction on the number of steps in a flag, Theorem 6.1 immediately gives us the following corollary:

Corollary 6.2. Let $\mathcal{K}$ be a flag kernel adapted to a standard flag $\mathcal{F}$ of length $n$. There is a finite collection of flags $\left\{\mathcal{F}_{k, s}\right\}, 1 \leq k \leq n$ and $1 \leq s \leq b_{k}$, with the following properties:
(1) For $k=n, b_{n}=1$ and $\mathcal{F}_{n, 1}=\mathcal{F}$.
(2) For each $k<n$, the flag $\mathcal{F}_{k, s}$ has length $k$ and is strictly coarser than $\mathcal{F}$.
(3) For each $(k, s)$ there is a uniformly bounded family of functions $\left\{\varphi_{k, s}^{J}\right\} \subset$ $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right), J \in \mathcal{E}_{k}$, all supported in the unit ball and having strong cancellation relative to the decomposition of $\mathbb{R}^{N}$ corresponding to the flag $\mathcal{F}_{k, s}$ so that in the sense of distributions,

$$
\begin{equation*}
\mathcal{K}=\sum_{k=1}^{n} \sum_{s=1}^{b_{k}} \sum_{J \in E_{k}}\left[\varphi_{k, s}^{J}\right]_{J} . \tag{6.1}
\end{equation*}
$$

The proof of Theorem 6.1 relies on three preliminary results. The first, which gives the characterization of flag kernels in terms of their Fourier transforms, was established in [9]. We briefly recall the relevant definitions. Let $\left(\mathbb{R}^{N}\right)^{*}$ denote the space of linear functionals on $\mathbb{R}^{N}$, and for a subspace $W \subseteq \mathbb{R}^{N}$, let $W^{\perp} \subset\left(\mathbb{R}^{N}\right)^{*}$ be the subspace of linear functions which are zero on $W$. If $\mathcal{F}$ is the flag in $\mathbb{R}^{N}$ given in (2.4), the dual flag is $\mathcal{F}^{*}$ given by

$$
(0)^{\perp} \supseteq\left(\mathbb{R}^{a_{n}}\right)^{\perp} \supseteq\left(\mathbb{R}^{a_{n-1}} \oplus \mathbb{R}^{a_{n}}\right)^{\perp} \supseteq \cdots \supseteq\left(\mathbb{R}^{a_{2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}\right)^{\perp}=\left(\mathbb{R}^{N}\right)^{\perp}
$$

If we identify $\left(\mathbb{R}^{a_{k}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}\right)^{\perp}$ with $\left(\mathbb{R}^{a_{1}}\right)^{*} \oplus \cdots \oplus\left(\mathbb{R}^{a_{k-1}}\right)^{*}$, the dual flag becomes

$$
\begin{equation*}
(0) \subseteq\left(\mathbb{R}^{a_{1}}\right)^{*} \subseteq\left(\mathbb{R}^{a_{1}}\right)^{*} \oplus\left(\mathbb{R}^{a_{2}}\right)^{*} \subseteq \cdots \subseteq\left(\mathbb{R}^{a_{1}}\right)^{*} \oplus \cdots \oplus\left(\mathbb{R}^{a_{n-1}}\right)^{*} \subseteq\left(\mathbb{R}^{N}\right)^{*} \tag{6.2}
\end{equation*}
$$

If $\xi \in\left(\mathbb{R}^{N}\right)^{*}$, we write $\xi=\left(\xi_{1}, \ldots, \xi_{n}\right)$ where $\xi_{j}=\left(\xi_{j, 1}, \ldots, \xi_{j, a_{j}}\right) \in\left(\mathbb{R}^{a_{j}}\right)^{*}$. The family of dilations on $\mathbb{R}^{N}$ defined in equation (2.1) induce a family of dilations on $\left(\mathbb{R}^{N}\right)^{*}$ so that $\langle r \cdot \mathbf{x}, \xi\rangle=\langle\mathbf{x}, r \cdot \xi\rangle$. We let $|\xi|$ be a smooth homogeneous norm on $\left(\mathbb{R}^{N}\right)^{*}$, and if $\xi_{j} \in\left(\mathbb{R}^{a_{j}}\right)^{*}$, we let $\left|\xi_{j}\right|$ be the restriction of the norm to this subspace.

Definition 6.3. A flag multiplier relative to the flag $\mathcal{F}^{*}$ given in (6.2) is a function $m(\xi)$ which is infinitely differentiable away from the subspace $\xi_{n}=0$, and which satisfies the differential inequalities

$$
\left|\partial_{\xi_{1}}^{\bar{\alpha}_{1}} \cdots \partial_{\xi_{n}}^{\bar{\alpha}_{n}} m(\xi)\right| \leq C_{\alpha} \prod_{j=1}^{n}\left(\left|\xi_{j}\right|+\cdots+\left|\xi_{n}\right|\right)^{-\llbracket \bar{\alpha}_{j} \rrbracket} .
$$

We can now state Theorem 2.3.9 of [9] as follows:
Lemma 6.4. Let $\mathcal{K}$ be a flag kernel adapted to the flag $\mathcal{F}$. Then the Fourier transform of $\mathcal{K}$ is a flag multiplier relative to the dual flag $\mathcal{F}^{*}$. Conversely, every flag multiplier relative to the flag $\mathcal{F}^{*}$ is the Fourier transform of a flag kernel adapted to the flag $\mathcal{F}$.

The next preliminary result provides a decomposition of test functions in $\mathcal{S}\left(\mathbb{R}^{N}\right)$.
Lemma 6.5. Let $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. Then there are functions $\left\{\psi^{k}\right\} \subset \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right), k=$ $0,1,2, \ldots$, such that

$$
\psi(\mathbf{x})=\sum_{k=0}^{\infty} 2^{-k Q} \psi^{k}\left(2^{-k} \cdot \mathbf{x}\right)
$$

where $Q$ is the homogeneous dimension of $\mathbb{R}^{N}$. Moreover these functions have the following properties:
(a) each $\psi^{k}$ is supported in the unit ball;
(b) for any $\delta>0$ and any $\alpha \in \mathbb{N}^{N}$, there exists $M \in \mathbb{N}$ depending on $\delta$ and $\alpha$ so that

$$
\sup _{\mathbf{x} \in \mathbb{R}^{N}}\left|\partial^{\alpha} \psi^{k}(\mathbf{x})\right| \leq\|\psi\|_{[M]} 2^{-k \delta}
$$

(c) if $\psi$ has strong cancellation, then each $\psi^{k}$ has strong cancellation.

Proof. Choose $\eta \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ supported in $\left[-1,-\frac{1}{8}\right] \cup\left[\frac{1}{8}, 1\right]$ with $\eta(t)=\eta(-t)$ such that

$$
\sum_{k=-\infty}^{+\infty} \eta\left(2^{-k} t\right)=1
$$

for all $t \neq 0$. For any $t \in \mathbb{R}$, including $t=0$, set $\eta_{0}(t)=1-\sum_{k=1}^{\infty} \eta\left(2^{-k} t\right)$. Then $\eta_{0} \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ is supported in $[-1,+1]$, and $\eta_{0}(t)+\sum_{k=1}^{\infty} \eta\left(2^{-k} t\right) \equiv 1$ for all $t \in \mathbb{R}$. Recall that $\mathbf{x} \rightarrow|\mathbf{x}|$ is a smooth homogeneous norm on $\mathbb{R}^{N}$. Set

$$
\psi^{k}(\mathbf{x})= \begin{cases}\psi(\mathbf{x}) \eta_{0}(|\mathbf{x}|) & \text { if } k=0 \\ 2^{k Q} \psi\left(2^{k} \cdot \mathbf{x}\right) \eta(|\mathbf{x}|) & \text { if } k \geq 1\end{cases}
$$

Then $2^{-k Q} \psi^{k}\left(2^{-k} \cdot \mathbf{x}\right)=\psi(\mathbf{x}) \eta\left(2^{-k}|\mathbf{x}|\right)$ for $k \geq 1$, and so $\psi(\mathbf{x})=\sum_{k=0}^{\infty} 2^{-k Q}$ $\psi^{k}\left(2^{-k} \cdot \mathbf{x}\right)$. From the choice of $\eta$ and the definition of $\eta_{0}$ it follows that each $\psi^{k}$ is supported on the set where $|\mathbf{x}| \leq 1$, and this gives the assertion (a).

Since $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, it follows that for every $M \in \mathbb{N}$ and every $\alpha \in \mathbb{N}^{N}$ with $|\alpha| \leq M$ we have

$$
\begin{equation*}
\left|\partial^{\alpha} \psi(\mathbf{x})\right| \leq\|\psi\|_{[M]}\left(1+|\mathbf{x}|_{e}\right)^{-M} \tag{6.3}
\end{equation*}
$$

where $|\mathbf{x}|_{e}$ is the Euclidean length of the vector $\mathbf{x} \in \mathbb{R}^{N}$. If $\mathbf{x}$ belongs to the support of $\psi^{k}$ when $k \geq 1$, we have $|\mathbf{x}| \geq 2^{-3}$, and so $\left|2^{k} \cdot \mathbf{x}\right| \geq 2^{k-3}$. Assertion (b) then follows easily from equation (6.3) and the fact that $|\mathbf{x}|^{\overline{d_{1}}} \lesssim|\mathbf{x}|_{e}$ if $|\mathbf{x}|_{e} \geq 1$.

Finally, suppose that $\psi$ has strong cancellation, so that $\int_{\mathbb{R}^{a_{k}}} \psi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{k}$ $=0$ for $1 \leq k \leq n$. It follows from Lemma 5.1 that we can write $\psi$ as a finite sum of terms of the form $\partial_{j_{1}} \cdots \partial_{j_{n}} \psi_{j_{1}, \ldots, j_{n}}$ where $x_{j_{k}}$ is a coordinate in $\mathbf{x}_{k}$ for $1 \leq k \leq n$, and each function $\psi_{j_{1}, \ldots, j_{n}} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ is normalized relative to $\psi$. Using assertions (a) and (b), we can write

$$
\psi_{j_{1}, \ldots, j_{n}}(\mathbf{x})=\sum_{k=0}^{\infty} 2^{-k Q} \psi_{j_{1}, \ldots, j_{n}}^{k}\left(2^{-k} \cdot \mathbf{x}\right)
$$

and so

$$
\partial_{j_{1}} \cdots \partial_{j_{n}} \psi_{j_{1}, \ldots, j_{n}}(\mathbf{x})=\sum_{k=0}^{\infty} 2^{-k\left(d_{j_{1}}+\cdots+d_{j_{n}}+Q\right)} \partial_{j_{1}} \cdots \partial_{j_{n}} \psi_{j_{1}, \ldots, j_{n}}^{k}\left(2^{-k} \cdot \mathbf{x}\right)
$$

Since each term $2^{-k\left(d_{j_{1}}+\cdots+d_{j_{n}}\right)} \partial_{j_{1}} \cdots \partial_{j_{n}} \psi_{j_{1}, \ldots, j_{n}}^{k}$ has strong cancellation, summing over a finite number of such terms establishes (c), and completes the proof.

Finally, we will need the following result, which provides a decomposition of test functions in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ :
Lemma 6.6. Let $\varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ have compact support in the unit ball, and suppose that $\varphi$ has cancellation in $\mathbf{x}_{1}$, i.e., $\int_{\mathbb{R}^{a_{1}}} \varphi\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{1}=0$. Then there are functions $\left\{\varphi^{j}\right\} \subseteq \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ such that

$$
\varphi\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)=\sum_{j=-\infty}^{0} 2^{-k Q_{1}} \varphi^{j}\left(2^{-j} \cdot \mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right),
$$

where $Q_{1}$ is the homogeneous dimension of $\mathbb{R}^{a_{1}}$. Moreover, these functions have the following properties:
(a) each $\varphi^{j}$ is supported in the unit ball;
(b) each $\varphi^{j}$ is normalized relative to the function $\varphi$;
(c) for $-\infty<j \leq 0$ we have $\varphi^{j}\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)=0$ if $\left|\mathbf{x}_{1}\right| \leq \frac{1}{8}$;
(d) if $\varphi$ has strong cancellation, then each function $\varphi^{j}$ has strong cancellation.

Proof. Choose $\eta \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ such that $\eta(t)$ vanishes if $t \geq 2$ or $t \leq \frac{1}{4}$, and such that $\sum_{l \leq 0} \eta\left(2^{-l} t\right)=1$ for $0<t \leq 1$. Put $A_{1}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)=0$, and for $j \leq 0$, put

$$
\begin{aligned}
\chi_{j}\left(\mathbf{x}_{1}\right) & =\eta\left(2^{-j}\left|\mathbf{x}_{1}\right|\right) \\
\tilde{\chi}_{j}\left(\mathbf{x}_{1}\right) & =\chi_{j}\left(\mathbf{x}_{1}\right)\left[\int_{\mathbb{R}^{a_{1}}} \chi_{j}\left(\mathbf{x}_{1}\right) d \mathbf{x}_{1}\right]^{-1} \\
a_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) & =\int_{\mathbb{R}^{a_{1}}} \varphi\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) \chi_{j}\left(\mathbf{x}_{1}\right) d \mathbf{x}_{1}, \\
A_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) & =\sum_{s=j}^{0} a_{s}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) .
\end{aligned}
$$

We have $\sum_{j \leq 0} \chi_{j}\left(\mathbf{x}_{1}\right) \equiv 1$ for $0<\left|\mathbf{x}_{1}\right| \leq 1$, and since $\varphi$ is supported in the unit ball, we can sum by parts for $\mathbf{x}_{1} \neq 0$ to get

$$
\begin{aligned}
\varphi(\mathbf{x})= & \sum_{j \leq 0} \varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \chi_{j}\left(\mathbf{x}_{1}\right) \\
= & \sum_{j \leq 0}\left[\varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \chi_{j}\left(\mathbf{x}_{1}\right)-\widetilde{\chi}_{j}\left(\mathbf{x}_{1}\right) a_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)\right] \\
& +\sum_{j \leq 0}\left(\widetilde{\chi}_{j}\left(\mathbf{x}_{1}\right)-\widetilde{\chi}_{j-1}\left(\mathbf{x}_{1}\right)\right) A_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)=\sum_{j \leq 0} \widetilde{\varphi}_{j}(\mathbf{x}) .
\end{aligned}
$$

Let

$$
\varphi^{j}\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)=2^{j Q_{1}} \widetilde{\varphi}_{j}\left(2^{j} \cdot \mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)
$$

Then

$$
\begin{align*}
\varphi^{j}(\mathbf{x})=2^{j Q_{1}}\left[\varphi \left(2^{j}\right.\right. & \left.\cdot \mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \chi_{0}\left(\mathbf{x}_{1}\right)-2^{-j Q_{1}} \widetilde{\chi}_{0}\left(\mathbf{x}_{1}\right) a_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) \\
& \left.+2^{j Q_{1}}\left(\widetilde{\chi}_{0}\left(\mathbf{x}_{1}\right)-2^{-Q_{1}} \widetilde{\chi}_{0}\left(2 \cdot \mathbf{x}_{1}\right)\right) A_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)\right] \tag{6.4}
\end{align*}
$$

and

$$
\begin{equation*}
\varphi\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)=\sum_{j=-\infty}^{0} 2^{-j Q_{1}} \varphi^{j}\left(2^{-j} \cdot \mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) \tag{6.5}
\end{equation*}
$$

The functions $\left\{a_{j}\right\}$ and hence also the functions $\left\{A_{j}\right\}$ are infinitely differentiable functions supported in the unit ball of $\mathbb{R}^{a_{2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$. Moreover, it follows from the fact that $\chi_{j}\left(\mathbf{x}_{1}\right)$ is supported on the set $\left|\mathbf{x}_{1}\right| \leq 2^{j+1}$ that there is a constant $C$ so that for each integer $m$, we have

$$
\begin{equation*}
\left\|a_{j}\right\|_{(m)} \leq C 2^{j Q_{1}}\|\varphi\|_{(m)} . \tag{6.6}
\end{equation*}
$$

The function $\sum_{s=-\infty}^{j} \chi_{s}\left(\mathbf{x}_{1}\right)$ is also supported on the set $\left|\mathbf{x}_{1}\right| \leq 2^{j+1}$, and is bounded independently of $j$. We have

$$
A_{j}\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)+\int_{\mathbb{R}^{a_{1}}} \varphi\left(\mathbf{x}_{1}\right) \sum_{s=-\infty}^{j+1} \chi_{s}\left(\mathbf{x}_{1}\right) d \mathbf{x}_{1}=\int_{\mathbb{R}^{a_{1}}} \varphi\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{1}=0
$$

and it thus follows that we also have

$$
\begin{equation*}
\left\|A_{j}\right\|_{(m)} \leq C 2^{j Q_{1}}\|\varphi\|_{(m)} \tag{6.7}
\end{equation*}
$$

It is clear from our construction that each function $\varphi^{j}$ has compact support in the unit ball. It follows from equation (6.4) that each $\varphi^{j}$ vanishes when $\left|\mathbf{x}_{1}\right| \leq \frac{1}{8}$, and also that if $\varphi$ has strong cancellation, then $\int_{\mathbb{R}^{a_{k}}} \varphi^{j}\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{k}=0$ for $1 \leq k \leq n$. Finally, equations (6.4), (6.6), and (6.7) show that $\left\|\varphi^{j}\right\|_{(m)} \leq$ $C 2^{-j Q_{1}}\|\varphi\|_{(m)}$. This completes the proof.

Let $\mathcal{K}$ be a flag kernel adapted to the flag $\mathcal{F}$, and let $m=\widehat{\mathcal{K}}$ be the flag multiplier on the flag $\mathcal{F}^{*}$ which is the Fourier transform of $\mathcal{K}$. Choose a function $\eta \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ supported in $\left[\frac{1}{2}, 4\right]$ such that $\sum_{j \in \mathbb{Z}} \eta\left(2^{j} t\right) \equiv 1$ for all $t>0$. For each $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$, set

$$
\begin{equation*}
\eta_{I}(\xi)=\eta\left(2^{i_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{i_{n}}\left|\xi_{n}\right|\right) \tag{6.8}
\end{equation*}
$$

Note that $\eta_{I}$ is supported where $\left|\xi_{j}\right| \approx 2^{-i_{j}}$ for $1 \leq j \leq n$. We shall establish the following result:

Lemma 6.7. Let $m$ be a flag multiplier relative to the flag $\mathcal{F}^{*}$ given in (6.2). Then

$$
\begin{equation*}
m(\xi)=\sum_{I \in \mathcal{E}_{n}} m_{0}(\xi) \eta_{I}(\xi)+\sum_{k=1}^{n} m_{k}(\xi) \tag{6.9}
\end{equation*}
$$

where $m_{0}$ is the Fourier transform of a flag kernel relative to the flag $\mathcal{F}$, and for $1 \leq k \leq n$, the function $m_{k}$ is the Fourier transform of a flag kernel adapted to a flag strictly coarser than $\mathcal{F}$.

Proof. Let $\theta$ be a smooth function on $\mathbb{R}$ supported where $t \geq 10$ such that $\theta(t)=1$ for $t \geq 20$. Write

$$
m(\xi)=m(\xi) \theta\left(\left|\xi_{n-1}\right|\left|\xi_{n}\right|^{-1}\right)+m(\xi)\left[1-\theta\left(\left|\xi_{n-1}\right|\left|\xi_{n}\right|^{-1}\right)\right]=n_{1}(\xi)+m_{1}(\xi)
$$

On the support of $\theta^{\prime}\left(\left|\xi_{n-1}\right|\left|\xi_{n}\right|^{-1}\right)$ we have $\left|\xi_{n-1}\right| \sim\left|\xi_{n}\right|$. Also, by homogeneity we have

$$
\left|\partial_{\xi_{n-1}}^{\alpha_{n-1}}\left(\left|\xi_{n-1}\right|\right)\right| \leq C\left|\xi_{n-1}\right|^{1-\left|\alpha_{n-1}\right|} \quad \text { and } \quad\left|\partial_{\xi_{n}}^{\alpha_{n}}\left(\left|\xi_{n}\right|\right)\right| \leq C\left|\xi_{n}\right|^{1-\left|\alpha_{n}\right|}
$$

Thus Lemma 6.4 implies that $n_{1}(\xi)$ and $m_{1}(\xi)$ are flag multipliers relative to the flag (6.2). On the support of $m_{1}$ we have $\left|\xi_{n-1}\right|\left|\xi_{n}\right|^{-1} \leq 20$. Thus we can group together the variables $\xi_{n}$ and $\xi_{n-1}$, and it follows that $m_{1}(\xi)$ is a flag kernel relative to a flag coarser than $\mathcal{F}^{*}$. Also $\left|\xi_{n-1}\right| \geq 10\left|\xi_{n}\right|$ on the support of $n_{1}$.

Next write
$n_{1}(\xi)=n_{1}(\xi) \theta\left(\left|\xi_{n-2}\right|\left|\xi_{n-1}\right|^{-1}\right)+n_{1}(\xi)\left[1-\theta\left(\left|\xi_{n-2}\right|\left|\xi_{n-1}\right|^{-1}\right)\right]=n_{2}(\xi)+m_{2}(\xi)$.
Since $\theta^{\prime}\left(\left|\xi_{n-2}\right|\left|\xi_{n-1}\right|^{-1}\right)$ is supported where $\left|\xi_{n-2}\right| \sim\left|\xi_{n-1}\right|$ and $\left|\xi_{n-1}\right| \geq 10\left|\xi_{n}\right|$, it again follows that $n_{2}$ and $m_{2}$ are Fourier transforms of flag kernels relative to the flag $\mathcal{F}^{*}$. On the support of $m_{2}$ we have $\left|\xi_{n-2}\right|\left|\xi_{n-1}\right|^{-1} \leq 20$ and $\left|\xi_{n-1}\right|\left|\xi_{n}\right|^{-1} \leq 20$. Thus we can group together the variables $\xi_{n}, \xi_{n-1}$ and $\xi_{n-2}$, and it follows that $m_{2}(\xi)$ is a flag kernel relative to a flag coarser than $\mathcal{F}^{*}$. Also $\left|\xi_{n-1}\right| \geq 10\left|\xi_{n-1}\right|$, and $\left|\xi_{n-1}\right| \geq 10\left|\xi_{n}\right|$ on the support of $n_{2}$.

We proceed inductively to see that

$$
m(\xi)=m_{0}(\xi)+\sum_{k=1}^{n} m_{k}(\xi)
$$

where each $m_{k}(\xi)$ is the Fourier transform of a coarser flag kernel and $m_{0}(\xi)=$ $n_{n}(\xi)$ is supported where $\left|\xi_{j}\right| \geq 10\left|\xi_{j+1}\right|$ for $1 \leq j \leq n-1$.

From our choice of $\eta$, it follows that

$$
\begin{aligned}
1 & =\sum_{J=\left(j_{1}, \ldots, j_{n}\right) \in \mathbb{Z}^{n}} \eta\left(2^{j_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{j_{n}}\left|\xi_{n}\right|\right) \\
& =\sum_{J \in \mathcal{E}_{n}} \eta\left(2^{j_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{j_{n}}\left|\xi_{n}\right|\right)+\sum_{J \in \mathbb{Z}^{n}-\mathcal{E}_{n}} \eta\left(2^{j_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{j_{n}}\left|\xi_{n}\right|\right)
\end{aligned}
$$

Thus if $\sum_{J \in \mathcal{E}_{n}} \eta\left(2^{j_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{j_{n}}\left|\xi_{n}\right|\right) \neq 1$, there is an $n$-tuple $J=\left(j_{1}, \ldots, j_{n}\right)$ and integers $1 \leq r<s \leq n$ such that $j_{r}>j_{s}$ and $\eta\left(2^{j_{r}}\left|\xi_{r}\right|\right) \eta\left(2^{j_{s}}\left|\xi_{s}\right|\right) \neq 0$. Since $\eta$ is supported on $\left[\frac{1}{2}, 4\right]$, it follows that $\left|\xi_{r}\right| \leq 42^{-j_{r}} \leq 42^{-j_{s}} \leq 8\left|\xi_{s}\right|$. However, on the support of $m_{0}$ we have $\left|\xi_{r}\right|>10\left|\xi_{s}\right|$. Thus on the support of $m_{0}$ we have

$$
1=\sum_{J \in \mathcal{E}_{n}} \eta\left(2^{j_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{j_{n}}\left|\xi_{n}\right|\right),
$$

and so

$$
m(\xi)=\sum_{J \in \mathcal{E}_{n}} m_{0}(\xi) \eta\left(2^{j_{1}}\left|\xi_{1}\right|\right) \cdots \eta\left(2^{j_{n}}\left|\xi_{n}\right|\right)+\sum_{k=1}^{n} m_{k}(\xi)
$$

which completes the proof.
We now turn to the proof of Theorem 6.1. If we write $\mathcal{K}_{j}$ as the inverse Fourier transform of the flag multiplier $m_{j}$ of Lemma 6.7, we have shown that

$$
\mathcal{K}=\mathcal{K}_{0}+\sum_{j=1}^{n} \mathcal{K}_{j},
$$

and for $1 \leq j \leq n, \mathcal{K}_{j}$ is a flag kernel adapted to a flag which is coarser than $\mathcal{F}$. Also since $m_{0}(\xi)=\sum_{J \in \mathcal{E}_{n}} m_{0}(\xi) \eta_{I}(\xi)$, we can write

$$
\begin{equation*}
\mathcal{K}_{0}=\sum_{J \in \mathcal{E}_{n}}\left[\Psi^{I}\right]_{I} \tag{6.10}
\end{equation*}
$$

where

$$
\widehat{\Psi^{I}}(\xi)=m_{0}\left(2^{-i_{1}} \cdot \xi_{1}, \ldots, 2^{-i_{n}} \cdot \xi_{n}\right) \cdot \eta\left(\left|\xi_{1}\right|\right) \cdots \eta\left(\left|\xi_{n}\right|\right),
$$

and the sum converges in the sense of distributions. The differential inequalities for $m_{0}$ imply that each function $\Psi^{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, with Schwartz norms uniformly bounded in $I$. Also since $\Psi^{I}$ vanishes on the coordinate axes, for $1 \leq k \leq n$ we have

$$
\begin{equation*}
\int \Psi^{I}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) d \mathbf{x}_{k}=0 \tag{6.11}
\end{equation*}
$$

In order to complete the proof of Theorem 6.1, it remains to show that we can replace the Schwartz functions $\Psi^{I}$ in equation (6.10) by functions in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, all supported in the unit ball with strong cancellation, and which vanish when $\left|\mathbf{x}_{1}\right|<\epsilon$. This is done in two steps, using Lemmas 6.5 and 6.6.

First, according to Lemma 6.5, for each $I \in \mathcal{E}_{n}$ there are functions $\psi^{k, I} \in$ $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, each supported in the unit ball and having strong cancellation, so that

$$
\psi^{I}(\mathbf{x})=\sum_{k=0}^{\infty} 2^{-k Q} \psi^{k, I}\left(2^{-k} \cdot \mathbf{x}\right)
$$

and for every $\Delta>0$ and every positive integer $m$ there is an integer $p_{m}$ so that

$$
\left\|\psi^{k, I}\right\|_{(m)} \leq 2^{-k \Delta}\left\|\psi^{I}\right\|_{\left[m+p_{m}\right]}
$$

Thus

$$
\left[\psi^{I}\right]_{I}(\mathbf{x})=\sum_{k=0}^{\infty} 2^{-Q_{1}\left(k+i_{1}\right)-\cdots-Q_{n}\left(k+i_{n}\right)} \psi^{k, I}\left(2^{-\left(i_{1}+k\right)} \cdot \mathbf{x}_{1}, \ldots, 2^{-\left(i_{n}+k\right)} \cdot \mathbf{x}_{n}\right)
$$

and so formally

$$
\begin{aligned}
\sum_{I \in \mathcal{E}_{n}}\left[\psi^{I}\right]_{I}(\mathbf{x}) & =\sum_{k=0}^{\infty} \sum_{I \in \mathcal{E}_{n}} 2^{-Q_{1}\left(k+i_{1}\right)-\cdots-Q_{n}\left(k+i_{n}\right)} \psi^{k, I}\left(2^{-\left(i_{1}+k\right)} \cdot \mathbf{x}_{1}, \ldots, 2^{-\left(i_{n}+k\right)} \cdot \mathbf{x}_{n}\right) \\
& =\sum_{k=0}^{\infty} \sum_{J \in \mathcal{E}_{n}} 2^{-Q_{1}\left(j_{1}\right)-\cdots-Q_{n}\left(j_{n}\right)} \psi^{k, I}\left(2^{-j_{1}} \cdot \mathbf{x}_{1}, \ldots, 2^{-j_{n}} \cdot \mathbf{x}_{n}\right) \\
& =\sum_{J \in \mathcal{E}_{n}} 2^{-Q_{1}\left(j_{1}\right)-\cdots-Q_{n}\left(j_{n}\right)}\left[\sum_{k=0}^{\infty} \psi^{k, I}\right]\left(2^{-j_{1}} \cdot \mathbf{x}_{1}, \ldots, 2^{-j_{n}} \cdot \mathbf{x}_{n}\right) \\
& =\sum_{J \in \mathcal{E}_{n}}\left[\sum_{k=0}^{\infty} \psi^{k, I}\right]_{J}(\mathbf{x}) .
\end{aligned}
$$

The estimates we have on the functions $\left\{\psi^{k, I}\right\}$ show that the series $\sum_{k=0}^{\infty} \psi^{k, I}=\widetilde{\varphi}^{I}$ converges in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ to a function supported in the unit ball which has strong cancellation. This formal calculation is easily justified by applying it to finite sums of dilates. Thus we have shown $\mathcal{K}_{0}=\sum_{I \in \mathcal{E}_{n}}\left[\widetilde{\varphi}^{I}\right]_{I}$, with convergence in the sense of distributions, where the functions $\widetilde{\varphi}^{I} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ all have support in the unit ball, have strong cancellation, and are uniformly bounded in each semi-norm $\|\cdot\|_{(m)}$.

Finally, Lemma 6.6 shows that for each $I \in \mathcal{E}_{n}$, there exist functions $\varphi^{j, I} \in$ $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ with strong cancellation, each supported in the unit ball, normalized relative to $\widetilde{\varphi}^{I}$, and vanishing when $\left|\mathbf{x}_{1}\right| \leq \frac{1}{8}$ so that

$$
\widetilde{\varphi}^{I}\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)=\sum_{j=-\infty}^{0} 2^{-j Q_{1}} \varphi^{j, I}\left(2^{-j} \cdot \mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)
$$

We then have

$$
\begin{aligned}
& {\left[\widetilde{\varphi}^{I}\right]_{I}\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)} \\
& \quad=\sum_{j=-\infty}^{0} 2^{-\left(j+i_{1}\right) Q_{1}-i_{2} Q_{2}-\cdots-i_{n} Q_{n}} \varphi^{j, I}\left(2^{-\left(j+i_{1}\right)} \cdot \mathbf{x}_{1}, 2^{-i_{2}} \cdot \mathbf{x}_{2}, \ldots, 2^{-i_{n}} \cdot \mathbf{x}_{n}\right),
\end{aligned}
$$

and so, since we are summing only over non-positive indices $j$, we have

$$
\begin{aligned}
\sum_{I \in \mathcal{E}_{n}}\left[\widetilde{\varphi}^{I}\right]_{I}(\mathbf{x}) & =\sum_{j=-\infty}^{0} \sum_{I \in \mathcal{E}_{n}} 2^{-\left(j+i_{1}\right) Q_{1}-i_{2} Q_{2}-\cdots-i_{n} Q_{n}} \varphi^{j, I}\left(2^{-\left(j+i_{1}\right)} \cdot \mathbf{x}_{1}, \ldots, 2^{-i_{n}} \cdot \mathbf{x}_{n}\right) \\
& =\sum_{j=-\infty}^{0} \sum_{I \in \mathcal{E}_{n}} 2^{-i_{1} Q_{1}-i_{2} Q_{2}-\cdots-i_{n} Q_{n}} \varphi^{j, I}\left(2^{-i_{1}} \cdot \mathbf{x}_{1}, \ldots, 2^{-i_{n}} \cdot \mathbf{x}_{n}\right) \\
& =\sum_{I \in \mathcal{E}_{n}} 2^{-i_{1} Q_{1}-i_{2} Q_{2}-\cdots-i_{n} Q_{n}}\left[\sum_{j=-\infty}^{0} \varphi^{j, I}\right]\left(2^{-i_{1}} \cdot \mathbf{x}_{1}, \ldots, 2^{-i_{n}} \cdot \mathbf{x}_{n}\right) \\
& =\sum_{I \in \mathcal{E}_{n}}\left[\sum_{j=-\infty}^{0} \varphi^{j, I}\right]_{I}(\mathbf{x}) .
\end{aligned}
$$

The estimates we have on the functions $\left\{\varphi^{j, I}\right\}$ show that the series $\sum_{j=-\infty}^{0} \varphi^{j, I}=\varphi^{I}$ converges in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ to a function supported in the unit ball which has strong cancellation, and which vanishes when $\left|\mathbf{x}_{1}\right| \leq \frac{1}{8}$. This at last completes the proof of Theorem 6.1.

### 6.2. Dyadic sums with weak cancellation

The main result of this section, Theorem 6.8, is a strengthening of the converse to Theorem 6.1 which would assert that sums of dilates of appropriate compactly supported bump functions with strong cancellation are flag kernels; we consider sums of Schwartz functions instead of compactly supported functions, and more critically, we assume only weak cancellation instead of strong cancellation relative to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$.
Theorem 6.8. For each $I \in \mathcal{E}_{n}$, let $\varphi^{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, and suppose
(a) there are constants $C_{N}>0$ so that $\left\|\varphi^{I}\right\|_{[N]} \leq C_{N}$ for each $I \in \mathcal{E}_{n}$ and for each $N \geq 0$;
(b) there is a constant $\epsilon>0$ so that each $\varphi^{I}$ has weak cancellation with respect to $I$ with parameter $\epsilon$ relative to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$.
Then we have the following conclusions:
(1) For any finite set $F \subset \mathcal{E}_{n}$, the function $K_{F}=\sum_{I \in F}\left[\varphi^{I}\right]_{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ defines a flag kernel $\mathcal{K}_{F}$ for the flag $\mathcal{F}$ with bounds which are independent of the set $F$.
(2) Let $F_{1} \subset F_{2} \subset \cdots \subset F_{m} \subset \cdots$ be any increasing sequence of finite subsets of $E_{N}$ with $E_{N}=\bigcup_{m=1}^{\infty} F_{m}$. Then for any test function $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$,

$$
\lim _{m \rightarrow \infty}\left\langle K_{F_{m}}, \psi\right\rangle=\lim _{m \rightarrow \infty} \sum_{I \in F_{m}} \int_{\mathbb{R}^{N}}\left[\varphi^{I}\right]_{I}(\mathbf{x}) \psi(\mathbf{x}) d x
$$

exists and defines a flag kernel $\mathcal{K} \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$ which is independent of the choice of the finite subsets. We write this limit as

$$
\mathcal{K}=\lim _{F \nearrow E_{N}} \sum_{I \in F}\left[\varphi^{I}\right]_{I}
$$

Since the proof of this result is somewhat involved, let us indicate the main steps. If $F \subset \mathcal{E}_{n}$ is any finite set, let $\mathcal{K}_{F}=\sum_{I \in F}\left[\varphi^{I}\right]_{I}$. We show (in Proposition 6.9) that $K_{F}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$ satisfies the correct size estimates, and also (in Proposition 6.11) that $K_{F}$ satisfies the cancellation conditions with constants independent of $F$ of Definition 2.3. This will establish part (1) of Theorem 6.8. To establish the existence of the limit in part (2), we use the weak cancellation of the functions $\left\{\varphi^{I}\right\}$ to show that for any test function $\psi$, the bracket $\left\langle\mathcal{K}_{F}, \psi\right\rangle$ can be rewritten as the integral of $\psi$ and its derivatives against locally integrable functions. The existence of the limit then follows from the Lebesgue dominated convergence theorem.

We now turn to the proofs. Note that in the next proposition we impose no cancellation conditions on the functions $\left\{\varphi^{I}\right\}$.

Proposition 6.9. For each $I \in \mathcal{E}_{n}$, let $\varphi^{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, and suppose there are constants $C_{M}$ so that for all $I \in \mathcal{E}_{n}$ and all $M,\left\|\varphi^{I}\right\|_{[M]} \leq C_{M}$. Let $F \subset \mathcal{E}_{n}$ be a finite subset, and let $K_{F}(\mathbf{x})=\sum_{I \in F}\left[\varphi^{I}\right]_{I}(\mathbf{x})$. For any $\alpha=\left(\bar{\alpha}_{1}, \ldots, \bar{\alpha}_{n}\right) \in \mathbb{N}^{a_{1}} \times \cdots \times \mathbb{N}^{a_{n}}$ with $|\alpha| \leq M$, there is a constant $A_{M}$ independent of the finite set $F$ so that

$$
\left|\partial_{\mathbf{x}}^{\alpha} K_{F}(\mathbf{x})\right| \leq A_{M} \prod_{j=1}^{n}\left[N_{1}\left(\mathbf{x}_{1}\right)+N_{2}\left(\mathbf{x}_{2}\right)+\cdots+N_{j}\left(\mathbf{x}_{j}\right)\right]^{-\left(Q_{j}+\llbracket \bar{\alpha}_{j} \rrbracket\right)}
$$

Proof. It follows from Proposition 4.3 that

$$
\left|\partial_{\mathbf{x}}^{\alpha} K_{F}(\mathbf{x})\right|=\left|\sum_{I \in F} 2^{-\sum_{j=1}^{n} i_{j}\left(Q_{j}+\llbracket \bar{\alpha}_{j} \rrbracket\right)} \partial_{\mathbf{x}}^{\bar{\alpha}}\left[\varphi^{I}\right]\left(2^{-i_{1}} \cdot \mathbf{x}_{1}, \ldots, 2^{-i_{n}} \cdot \mathbf{x}_{n}\right)\right| .
$$

Since $\varphi^{I} \in \mathcal{S}\left(\mathbb{R}^{n}\right)$, for any $M$ we have the estimate

$$
\left|\partial_{\mathbf{x}}^{\bar{\alpha}}\left[\varphi^{I}\right]\left(2^{-i_{1}} \mathbf{x}_{1}, \ldots, 2^{-i_{n}} \mathbf{x}_{n}\right)\right| \leq C_{M}\left(1+\sum_{k=1}^{N} 2^{-i_{k}} N_{k}\left(\mathbf{x}_{k}\right)\right)^{-M}
$$

Thus

$$
\left|\partial_{\mathbf{x}}^{\bar{\alpha}} K_{F}(\mathbf{x})\right| \leq C_{M} \sum_{I \in F} 2^{-\sum_{j=1}^{n} i_{k}\left(Q_{k}+\llbracket \bar{\alpha}_{k} \rrbracket\right)}\left(1+\sum_{k=1}^{N} 2^{-i_{k}} N_{k}\left(\mathbf{x}_{k}\right)\right)^{-M}
$$

Proposition 6.9 thus follows from estimate (10.2) in Prop. 10.1 in Appendix II.
The next result provides estimates that will be used in establishing the cancellation conditions (part (b) of Definition 2.3) for finite sums $\mathcal{K}_{F}=\sum_{I \in F}\left[\varphi^{I}\right]_{I}$. Recall that these cancellation conditions involve integrals of the form

$$
\int K\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \psi\left(R_{1} \cdot \mathbf{x}_{m_{1}}, \ldots, R_{\beta} \cdot \mathbf{x}_{m_{\beta}}\right) d \mathbf{x}_{m_{1}} \cdots d \mathbf{x}_{m_{\beta}}
$$

where $\left\{m_{1}, \ldots, m_{\beta}\right\}$ is a non-empty subset of $\{1, \ldots, n\}$. Let $M=\left\{m_{1}, \ldots, m_{\beta}\right\}$, and let $L=\left\{l_{1}, \ldots, l_{\alpha}\right\}=\{1, \ldots, n\} \backslash M$. Let $N_{\alpha}=a_{l_{1}}+\cdots+a_{l_{\alpha}}$ and $N_{\beta}=$ $a_{m_{1}}+\cdots+a_{m_{\beta}}$ so that $N_{\alpha}+N_{\beta}=N$. For $\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \in \mathbb{R}^{N}$, write

$$
\mathrm{x}=\left(\mathrm{x}^{\prime}, \mathrm{x}^{\prime \prime}\right) \quad \text { with } \quad\left\{\begin{array}{l}
\mathrm{x}^{\prime}=\left(\mathrm{x}_{l_{1}}, \ldots, \mathrm{x}_{l_{\alpha}}\right) \in \mathbb{R}^{N_{\alpha}} \\
\mathrm{x}^{\prime \prime}=\left(\mathrm{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right) \in \mathbb{R}^{N_{\beta}}
\end{array}\right.
$$

For $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$, write

$$
I=\left(I^{\prime}, I^{\prime \prime}\right) \quad \text { where } \quad\left\{\begin{array}{l}
I^{\prime}=\left(i_{l_{1}}, \ldots, i_{l_{\alpha}}\right) \in E_{\alpha} \\
I^{\prime \prime}=\left(i_{m_{1}}, \ldots, i_{m_{\beta}}\right) \in E_{\beta}
\end{array}\right.
$$

If $R=\left(R_{1}, \ldots, R_{\beta}\right)$ is a $\beta$-tuple of positive real numbers, write

$$
\begin{aligned}
R \cdot \mathbf{x}^{\prime \prime} & =\left(R_{1} \cdot \mathbf{x}_{m_{1}}, \ldots, R_{\beta} \cdot \mathbf{x}_{m_{\beta}}\right) \\
2^{I^{\prime \prime}} R \cdot \mathbf{x}^{\prime \prime} & =\left(2^{i_{m_{1}}} R_{1} \cdot \mathbf{x}_{m_{1}}, \ldots, 2^{i_{m_{\beta}}} R_{\beta} \cdot \mathbf{x}_{m_{\beta}}\right)
\end{aligned}
$$

Finally, let $P(M)$ denote the set of all partitions of the set $M=\left\{m_{1}, \ldots, m_{\beta}\right\}$ into two disjoint (possibly empty) subsets $A$ and $B$.

Proposition 6.10. With the above notation, let $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$, and let $\varphi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. Let $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N_{\beta}}\right)$ so that $\psi$ can be regarded as a function of the variables $\mathbf{x}^{\prime \prime}=\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right)$. Let $R=\left(R_{1}, \ldots, R_{\beta}\right)$ be a $\beta$-tuple of positive real numbers. Define $\Phi$ on $\mathbb{R}^{N_{\alpha}}$ by setting

$$
\Phi\left(\mathbf{x}^{\prime}\right)=\int_{\mathbb{R}^{N_{\beta}}}[\varphi]_{I}\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right) \psi\left(R_{1} \cdot \mathbf{x}_{m_{1}}, \ldots, R_{\beta} \cdot \mathbf{x}_{m_{\beta}}\right) d \mathbf{x}_{m_{1}} \cdots d \mathbf{x}_{m_{\beta}} .
$$

(1) There exists $\Theta \in \mathcal{S}\left(\mathbb{R}^{N_{\alpha}}\right)$, normalized relative to $\varphi$ and $\psi$ (with constants independent of $\left.\left(R_{1}, \ldots, R_{\beta}\right)\right)$ such that $\Phi\left(\mathbf{x}^{\prime}\right)=[\Theta]_{I^{\prime}}\left(\mathbf{x}^{\prime}\right)$.
(2) If $\varphi$ has weak cancellation with respect to $I$, there are constants $C$ and $\epsilon$ independent of $R=\left(R_{1}, \ldots, R_{\beta}\right)$ so that $\Theta=\sum_{(A, B) \in P(M)} \Theta_{A, B}$, where for each partition $M=A \cup B$ and $n \notin A$,

$$
\left|\Theta_{A, B}\left(\mathbf{x}^{\prime}\right)\right| \leq C \prod_{m_{r} \in A} 2^{-\epsilon\left(i_{m_{r}+1}-i_{m_{r}}\right)} \prod_{m_{s} \in B} \min \left\{\left(R_{s} 2^{i_{m_{s}}}\right)^{+\epsilon},\left(R_{s} 2^{i_{m_{s}}}\right)^{-\epsilon}\right\}
$$

Thus for each partition $M=A \cup B$ of the set of variables $\left\{\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right\}$, $\left|\Theta_{A, B}\left(\mathbf{x}^{\prime}\right)\right|$ is small due to two kinds of gains: there is a gain $2^{-\epsilon\left(i_{m_{r}+1}-i_{m_{r}}\right)}$ for every index $m_{r} \in A$, and there is a gain $\min \left\{\left(R_{r} 2^{i_{m_{r}}}\right)^{+\epsilon},\left(R_{r} 2^{i_{m_{r}}}\right)^{-\epsilon}\right\}$ for every index $m_{r} \in B$.

Proof. Make the change of variables

& =\int_{\mathbb{R}^{N_{\beta}}}[\varphi]_{I^{\prime}}\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right) \psi\left(R_{1} 2^{i_{m_{1}}} \cdot \mathbf{x}_{m_{1}}, \ldots, R_{\beta} 2^{i_{m_{\beta}}} \cdot \mathbf{x}_{m_{\beta}}\right) d \mathbf{x}_{m_{1}} \cdots d \mathbf{x}_{m_{\beta}} \\
& =[\Theta]_{I^{\prime}}\left(\mathbf{x}^{\prime}\right)
\end{aligned}
$$

where

$$
\begin{equation*}
\Theta\left(\mathbf{x}^{\prime}\right)=\int_{\mathbb{R}^{N_{\beta}}} \varphi\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right) \psi\left(R_{1} 2^{i_{m_{1}}} \cdot \mathbf{x}_{m_{1}}, \ldots, R_{\beta} 2^{i_{m_{\beta}}} \cdot \mathbf{x}_{m_{\beta}}\right) d \mathbf{x}_{m_{1}} \cdots d \mathbf{x}_{m_{\beta}} \tag{6.12}
\end{equation*}
$$

Now

\left(1+\left|\mathbf{x}^{\prime}\right|\right)^{M} \partial_{\mathbf{x}^{\prime}}^{\bar{\alpha}} \Theta\left(\mathbf{x}^{\prime}\right)=\int_{\mathbb{R}^{N_{\beta}}}\left(1+\left|\mathbf{x}^{\prime}\right|\right)^{M} \partial_{\mathbf{x}^{\prime}}^{\bar{\alpha}} \varphi\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right) \psi\left(2^{I^{\prime \prime}} R \cdot \mathbf{x}^{\prime \prime}\right) d \mathbf{x}^{\prime \prime}
$$

and we can estimate the $\mathcal{S}\left(\mathbb{R}^{N_{\alpha}}\right)$-seminorms of $\Theta$ in terms of those of $\varphi$ and the supremum of $|\psi|$, independent of the choice of $R$. This establishes assertion (1).

To prove the decomposition and additional size estimates for $\Theta$ asserted in part (2), assume that $\varphi$ has weak cancellation relative to $I$. Since the definiton (6.12) of $\Theta$ involves integration with respect to the variables $\left\{\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right\}$, we will only use the weak cancellation in these variables. We can use the first of the Remarks 5.6 to write $\varphi$ as a sum of terms of the form

where $\left\{m_{1}, \ldots, m_{\beta}\right\}=A \cup B$ with $A \cap B=\emptyset$ and $n \in B$ if $n \in\left\{m_{1}, \ldots, m_{\beta}\right\}$. Also, $\sigma: B \rightarrow\{1, \ldots, N\}$ so that $\sigma\left(m_{\ell}\right) \in J_{m_{\ell}}$, and each $\widetilde{\varphi}_{A, B, \sigma}$ is normalized relative to $\varphi$.

If we write $B=\left\{m_{\ell_{1}}, \ldots, m_{\ell_{s}}\right\}$, it follows that $\Theta\left(\mathbf{x}^{\prime}\right)$ is a finite sum of terms of the form

\end{aligned}
$$

We can use integration by parts to move the differentiations $\partial_{\sigma\left(m_{\ell_{1}}\right)} \cdots \partial_{\sigma\left(m_{\ell_{s}}\right)}$ from $\widetilde{\varphi}_{A ; B ; \sigma}$ to $\psi$. Differentiating the function $\psi\left(R_{1} 2^{i_{m_{1}}} \cdots \mathbf{x}_{m_{1}}, \ldots, R_{\beta} 2^{i_{m_{\beta}}} \cdot \mathbf{x}_{m_{\beta}}\right)$ with respect to the variable $x_{\sigma\left(m_{\ell_{k}}\right)}$ with $\sigma\left(m_{\ell_{k}}\right) \in J_{m_{\ell_{k}}}$ brings out a factor $\left(R_{m_{\ell_{k}}} 2^{i_{m_{\ell_{k}}}}\right)^{d_{\sigma\left(m_{\ell_{k}}\right)}}$, and so we have the estimate

On the other hand, without integrating by parts, since $\psi$ has compact support, the integral in the variables $\left\{\mathbf{x}_{m_{r}} \mid r \in B\right\}$ is taken over the set where $\left|\mathbf{x}_{m_{r}}\right| \lesssim$ $\left(R_{r} 2^{i_{m_{r}}}\right)^{Q_{m_{r}}}$ for $r \in B$, and this set has volume bounded by a constant times $\prod_{r \in B}\left(R_{r} 2^{i_{m_{r}}}\right)^{-Q_{m_{r}}}$. It follows that there exists $\epsilon>0$ so that

We now show that if the functions $\left\{\varphi^{I}\right\}$ have weak cancellation, then the sum $K_{F}(\mathbf{x})$ satisfies the cancellation condition (condition (b)) of Definition 2.3. We use the same notation as in Proposition 6.10. Thus $L=\left\{l_{1}, \ldots, l_{\alpha}\right\}$ and $M=$ $\left\{m_{1}, \ldots, m_{\beta}\right\}$ are complementary subsets of $\{1,2, \ldots, n\}$, and we set $N_{\alpha}=a_{l_{1}}+$ $\cdots+a_{l_{\alpha}}$ and $N_{\beta}=a_{m_{1}}+\cdots+a_{m_{\beta}}$. If $\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \in \mathbb{R}^{N}$, we write $\mathbf{x}=\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right)$, with $\mathbf{x}^{\prime}=\left(\mathbf{x}_{l_{1}}, \ldots, \mathbf{x}_{l_{\alpha}}\right)$ and $\mathbf{x}^{\prime \prime}=\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right)$. If $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$, write $I^{\prime}=\left(i_{l_{1}}, \ldots, i_{l_{\alpha}}\right) \in E_{\alpha}$ and $I^{\prime \prime}=\left(i_{m_{1}}, \ldots, i_{m_{\beta}}\right) \in E_{\beta}$
Proposition 6.11. For each $I \in \mathcal{E}_{n}$ let $\varphi^{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, and suppose there are constants $C_{M}$ so that that for all $I \in \mathcal{E}_{n}$ and all $M,\left\|\varphi^{I}\right\|_{[M]} \leq C_{M}$. Let $F \subset \mathcal{E}_{n}$ be a finite subset, and let $K_{F}(\mathbf{x})=\sum_{I \in F}\left[\varphi^{I}\right]_{I}(\mathbf{x})$. Let $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N_{\beta}}\right)$ be a bump function in the variables $\mathbf{x}^{\prime \prime}=\left(\mathbf{x}_{m_{1}}, \ldots, \mathbf{x}_{m_{\beta}}\right)$. Let $R=\left(R_{1}, \ldots, R_{\beta}\right)$ be a $\beta$-tuple
of positive real numbers, and let $\bar{\gamma}=\left(\gamma_{l_{1}}, \ldots, \gamma_{l_{\alpha}}\right) \in \mathbb{N}^{a_{l_{1}}} \oplus \cdots \oplus \mathbb{N}^{a_{l_{\alpha}}}$. There exists a constant $C_{\bar{\gamma}}$, independent of $R$ so that

& \mid \partial_{\mathbf{x}_{l_{1}}}^{\gamma_{1}} \cdots \partial_{\mathbf{x}_{l_{\alpha}}}^{\gamma_{l_{\alpha}}} \int_{\mathbb{R}^{N_{\beta}}} K_{F}\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right) \psi\left(R \cdot \mathbf{x}^{\prime \prime}\right) d \mathbf{x}^{\prime \prime} \mid \\
& \leq C_{\bar{\gamma}} \prod_{p=1}^{\alpha}\left[N_{l_{1}}\left(\mathbf{x}_{l_{1}}\right)+\cdots N_{l_{p}}\left(\mathbf{x}_{l_{p}}\right)\right]^{-Q_{l_{p}}-\llbracket \gamma_{l_{p}} \rrbracket} .
\end{aligned}
$$

Proof. Recall the definitions of $I^{\prime}$ and $I^{\prime \prime}$ from just before the statement of the proposition. Using Proposition 6.10 to write $\int\left[\varphi^{I}\right]_{I^{\prime}}\left(\mathbf{x}^{\prime}, \mathbf{x}^{\prime \prime}\right) \psi\left(R \cdot \mathbf{x}^{\prime \prime}\right) d \mathbf{x}^{\prime \prime}=\left[\Theta^{I}\right]_{I^{\prime}}\left(\mathbf{x}^{\prime}\right)$, we have

Each $\Theta^{I}$ is normalized relative to $\varphi$. We write the sum over $I \in F$ as an iterated sum as follows. Let

We must show that this sum satisfies the differential inequalities for flags on the space $\mathbb{R}^{a_{l_{1}}} \oplus \cdots \oplus \mathbb{R}^{a_{l_{\alpha}}}$, with constants independent of the finite set $F$. This will follow from Proposition 6.9 provided we can show that for each $I^{\prime} \in E_{1}$, the sum $\sum_{I^{\prime \prime} \in E_{2}\left(I^{\prime}\right)} \Theta^{\left(I^{\prime}, I^{\prime \prime}\right)}$ converges to a normalized Schwartz function. However, this follows from the estimates in part (2) of Proposition 6.10.

We now turn to the proof of Theorem 6.8. As already indicated on page 663, just before the statement of Proposition 6.9, part (1) is an immediate consequence of Proposition 6.9 and Proposition 6.11, so we only need to establish part (2). Let $\psi \in \mathcal{S}\left(\mathbb{R}^{n}\right)$, and for each $I \in \mathcal{E}_{n}$, let $\varphi^{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ have weak cancellation relative to $I$. According to the second of the two Remarks 5.6, we can write

Thus if $F \subset \mathcal{E}_{n}$ is a finite subset, and $K_{F}(\mathbf{x})=\sum_{I \in F}\left[\varphi^{I}\right]_{I}(\mathbf{x})$, we have

=- & \sum_{\ell=1}^{a_{1}} \int_{\mathbb{R}^{N}} K_{F}^{\ell}(\mathbf{x}) \frac{\partial \psi}{\partial x_{\ell}}(\mathbf{x}) d \mathbf{x}+\int_{\mathbb{R}^{N}} K_{F}^{0}(\mathbf{x}) \psi(\mathbf{x}) d \mathbf{x}
\end{aligned}
$$

where

\begin{aligned}
K_{F}^{\ell}(\mathbf{x}) & =\sum_{I \in F} 2^{i_{1} d_{\ell}}\left[\varphi_{\ell}^{I}\right]_{I}(\mathbf{x}), \quad 1 \leq \ell \leq a_{1} \\
K_{F}^{0}(\mathbf{x}) & =\sum_{I \in F} 2^{-\epsilon\left(i_{2}-i_{1}\right)}\left[\varphi_{0}^{I}\right]_{I}
\end{aligned}
$$

If $\alpha=\left(\alpha_{1}, \ldots, \alpha_{N}\right) \in \mathbb{N}^{N}$, we have

& \partial^{\alpha} K_{F}^{0}(\mathbf{x})=\sum_{I \in F} 2^{-\epsilon\left(i_{2}-i_{1}\right)} 2^{-\sum_{j=1}^{n} i_{j}\left(Q_{j}+\llbracket \alpha_{j} \rrbracket\right)} \partial^{\alpha}\left[\varphi_{0}^{I}\right]\left(2^{-I} \cdot \mathbf{x}\right) .
\end{aligned}
$$

It follows from Proposition 10.1 in Appendix II that (at least if $d_{\ell}<Q_{1}+\llbracket \alpha_{1} \rrbracket$ )

& \left|\partial^{\alpha} K_{F}^{0}(\mathbf{x})\right| \leq C N_{1}\left(\mathbf{x}_{1}\right)^{\epsilon}\left(N_{1}\left(\mathbf{x}_{1}\right)+N_{2}\left(\mathbf{x}_{2}\right)\right)^{-\epsilon} \prod_{j=1}^{n}\left[N_{1}\left(\mathbf{x}_{1}\right)+\cdots+N_{j}\left(\mathbf{x}_{j}\right)\right]^{-\left(Q_{j}+\llbracket \alpha_{j} \rrbracket\right)} .
\end{aligned}

The functions on the right hand side of the last two inequalities are integrable on $\mathbb{R}^{N}$. The proof of (2) then follows from the dominated convergence theorem:

### 6.3. Rewriting sums of bump functions with weak cancellation

It follows from Theorem 6.8 that a sum of dilates of normalized bump functions with weak cancellation converges to a flag kernel, and it follows from Theorem 6.1 that a flag kernel can be written as a sum of dilates of normalized bump functions with strong cancellation plus a sum of flag kernels adapted to strictly coarser flags. It follows that a sum of dilates of functions with weak cancellation can be rewritten as sums of dilates of functions with strong cancellation relative to coarser flags. In this section we give a direct proof of this fact. The basic idea is to use telescoping series to replace a function with weak cancellation by a sum of functions with strong cancellation plus an error term which belongs to a flag which is coarser than the original flag. Aside from its intrinsic interest, we shall need this observation in the forthcoming paper [10].

Thus consider the standard flag $\mathcal{F}_{\mathcal{A}}$ on $\mathbb{R}^{N}$ of step $n$ associated to the decomposition

Any strictly coarser flag $\mathcal{F}_{\mathcal{B}} \succ \mathcal{F}_{\mathcal{A}}$ then arises from a decomposition

where $m<n$ and each $\mathbb{R}^{b_{j}}=\mathbb{R}^{a_{r_{j}}} \oplus \cdots \oplus \mathbb{R}^{a_{s_{j}}}$ where $1=r_{1}, n=s_{m}, r_{j} \leq s_{j}$ for $1 \leq j \leq m$, and $r_{j+1}=s_{j}+1$ for $1 \leq j \leq m-1$. As usual we let $\mathcal{E}_{n}$ denote the set of $n$-tuples of integers $I=\left(i_{1}, \ldots, i_{n}\right)$ with $i_{1} \leq \cdots \leq i_{n}$. For any strictly coarser flag $\mathcal{F}_{\mathcal{B}}$ of step $m<n$ as above, we let $\mathcal{E}_{\mathcal{B}}$ denote the set of $m$-tuples of integers $J=\left(j_{1}, \ldots, j_{m}\right)$ with $j_{1} \leq \cdots \leq j_{m}$. Given the argument for part (2) of Theorem 6.8 , we shall only concern ourselves with finite sums, and thus will not need to worry about convergence questions.

Proposition 6.12. Let $\mathcal{F}_{\mathcal{A}}$ denote the standard flag associated to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$. Suppose that

$$
\begin{equation*}
K(\mathbf{x})=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}(\mathbf{x}) \tag{6.14}
\end{equation*}
$$

is a finite sum, where each $\varphi^{I}$ is a normalized bump function for the flag $\mathcal{F}_{\mathcal{A}}$, with weak cancellation relative to $I \in \mathcal{E}_{n}$ with parameter $\epsilon$. Then we can write

$$
\begin{equation*}
K(\mathbf{x})=\sum_{\mathcal{B} \succeq \mathcal{A}} \sum_{J \in \mathcal{E}_{\mathcal{B}}}\left[\eta_{\mathcal{B}}^{J}\right]_{J}(\mathbf{x}), \tag{6.15}
\end{equation*}
$$

where the outer sum is taken over decompositions equal to or coarser than $\mathcal{A}$, and each $\eta_{\mathcal{B}}^{J}$ is a normalized bump function which has strong cancellation relative to the flag $\mathcal{F}_{\mathcal{B}}$ associated to the decomposition $\mathcal{B}$.

Proof. We argue by induction on the number of steps $n$ in the original flag $\mathcal{A}$. For $n=1$ there is nothing to prove, because then there is no distinction between weak and strong cancellation.

Thus suppose the proposition has been established for all flags of step less than or equal to $n-1$, and consider the flag of step $n$ corresponding to the decomposition $\mathcal{A}$. The inductive step itself requires an induction. Let the function $K$ be given by (6.14). Since each $\varphi^{I}$ has weak cancellation with respect to $I$ with parameter $\epsilon$, we can write

$$
\varphi^{I}=\sum_{S \subset\{1,2, \ldots, n-1\}} 2^{-\epsilon \sum_{l \in B}\left(j_{l+1}-j_{l}\right)} \eta_{S}^{I}
$$

where the sum is over all subsets $S$ of $\{1, \ldots, n-1\}$ and each $\eta_{S}^{I}$ is a normalized bump function which has integral zero in each multi-variable $\mathbf{x}_{r}$ with $r \notin S$. Thus we have

$$
\begin{equation*}
K=\sum_{I \in \mathcal{E}_{n}} \sum_{S \subset\{1,2, \ldots, n-1\}} 2^{-\epsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{I}\right]_{I} \tag{6.16}
\end{equation*}
$$

We will prove by induction on $k$, for $1 \leq k \leq n$, that $K$ can be written

$$
\begin{equation*}
K=\sum_{I \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k\}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{I}\right]_{I}+\sum_{\mathcal{B} \succ \mathcal{A}} K^{\mathcal{B}}, \tag{6.17}
\end{equation*}
$$

where the functions $\left\{\eta_{S}^{I}\right\}$ and $\left\{K^{\mathcal{B}}\right\}$ have the following properties:
(i) Each normalized bump function $\eta_{S}^{I}$ has integral zero with respect to each variable $\mathbf{x}_{r}$ with $r \notin S$.
(ii) For each $\mathcal{B} \succ \mathcal{A}$, (i.e., for each decomposition $\mathcal{B}$ strictly coarser than $\mathcal{A}$ and hence whose corresponding flag has step strictly less than $n$ ), the function $K^{\mathcal{B}}$ can be written as a finite sum

$$
K^{\mathcal{B}}=\sum_{J \in \mathcal{E}(\mathcal{B})}\left[\theta_{\mathcal{B}}^{J}\right]_{J}
$$

where each $\theta_{\mathcal{B}}^{J}$ is a normalized bump function with weak cancellation with some parameter $\epsilon^{\prime}>0$ relative to the flag arising from the decomposition $\mathcal{B}$. (It follows from the induction hypothesis that each such function can be rewritten as a sum of dilates of normalized bump functions with strong cancellation.)
(iii) The bump functions $\left\{\eta_{S}^{I}\right\}$ and the $\left\{\theta_{\mathcal{B}}^{J}\right\}$ are uniformly normalized relative to the normalized bump functions $\left\{\varphi^{I}\right\}^{\mathcal{B}}$ defined in (6.14).

Clearly equation (6.16) gives the desired conclusion in (6.17) for $k=1$. Moreover, when $k=n$ the set $S$ must be empty and thus we will have written $K$ as an appropriate sum of dilates of normalized bump functions with strong cancellation.

Thus we turn to the induction step. Suppose that equation (6.17) holds for a given $k<n$. We must show that (6.17) also holds with $k$ replaced by $k+1$. We split the first sum into two parts depending on whether or not the subset $S$
contains the element $n-k$ :

$$
K=\sum_{\substack{J \in \mathcal{E}_{n} \\ S \subseteq\{1,2, \ldots, n-k\} \\ n-k \in S}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{J}\right]_{J}+\sum_{\substack{I \in \mathcal{E}_{n} \\ S \subseteq\{1,2, \ldots, n-(k+1)\}}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{I}\right]_{I}+\sum_{\mathcal{B} \succ \mathcal{A}} K^{\mathcal{B}}
$$

(6.18) $=K_{1}+K_{2}+K_{3}$.

Now $K_{2}+K_{3}$ is already of the form in (6.17) with $k$ replaced by $k+1$, so we only need to deal with $K_{1}$.

Thus let $n-k \in S \subset\{1,2, \ldots, n-k\}$, and consider the corresponding term $\eta=\eta_{S}^{J}$ in $K_{1}$. Let $Q_{n-k}$ denote the homogeneous dimension of the space $\mathbb{R}^{a_{n-k}}$. Then the function
$\left(\eta_{S}^{J}\right)^{\prime}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)=2^{Q_{n-k}} \eta_{S}^{J}\left(\mathbf{x}_{1}, \ldots, 2 \cdot \mathbf{x}_{n-k}, \ldots, \mathbf{x}_{n}\right)-\eta_{S}^{J}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n-k}, \ldots, \mathbf{x}_{n}\right)$
has cancellation in the variables $\mathbf{x}_{r}$ for all $r \notin S^{\prime}=S \backslash\{n-k\}$. Note that $S^{\prime} \subset\{1,2, \ldots, n-(k+1)\}$. Let $J=\left(j_{1}, \ldots, j_{n}\right)$. Using a telescoping series we have

$$
\begin{aligned}
\eta_{S}^{J}(\mathbf{x})= & \sum_{i=1}^{j_{n-k+1}-j_{n-k}} 2^{-i Q_{n-k}}\left(\eta_{S}^{J}\right)^{\prime}\left(\mathbf{x}_{1}, \ldots, 2^{-i} \cdot \mathbf{x}_{n-k}, \ldots, \mathbf{x}_{n}\right) \\
& +2^{-\left(j_{n-k+1}-j_{n-k}\right) Q_{n-k}} \eta_{S}^{J}\left(\mathbf{x}_{1}, \ldots, 2^{-\left(j_{n-k+1}-j_{n-k}\right)} \cdot \mathbf{x}_{n-k}, \ldots, \mathbf{x}_{n}\right),
\end{aligned}
$$

and hence
$\left[\eta_{S}^{J}\right]_{J}=\sum_{i=j_{n-k}+1}^{j_{n-k+1}}\left[\left(\eta_{S}^{J}\right)^{\prime}\right]_{\left(j_{1}, \ldots, j_{n-k-1}, i, j_{n-k+1}, \ldots, j_{s}\right)}+\left[\eta_{S}^{J}\right]_{\left(j_{1}, \ldots, j_{n-k-1}, j_{n-k+1}, j_{n-k+1}, \ldots, j_{s}\right)}$.
We regard the last term as associated to the coarser flag of step $(n-1)$ associated to the decomposition

$$
\text { (B) } \quad \mathbb{R}^{a_{1}} \oplus \mathbb{R}^{a_{n-k-1}} \oplus\left[\mathbb{R}^{a_{n-k}} \oplus \mathbb{R}^{a_{n-k+1}}\right] \oplus \mathbb{R}^{a_{n-k+2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}
$$

where $\mathbb{R}^{a_{n-k}} \oplus \mathbb{R}^{a_{n-k+1}}$ is now considered one factor. If we set
$J_{i}^{(n-k)}=\left(j_{1}, \ldots, j_{n-k-1}, i, j_{n-k+1}, \ldots, j_{n}\right), \widehat{J^{n-k}}=\left(j_{1}, \ldots, j_{n-k-1}, j_{n-k+1}, \ldots, j_{n}\right)$, then $J_{i}^{(n-k)} \in \mathcal{E}_{n}$ for $j_{n-k}+1 \leq i \leq j_{n-k+1}$ and $\widehat{J^{n-k}} \in \mathcal{E}_{\mathcal{B}}$. Moreover, $\eta_{S}^{J}$ has weak cancellation with respect to the flag $(\mathcal{B})$ with parameter $\epsilon$. Formula (6.19) then becomes

$$
\begin{equation*}
\left[\eta_{S}^{J}\right]_{J}=\sum_{i=j_{n-k}+1}^{j_{n-k+1}}\left[\left(\eta_{S}^{J}\right)^{\prime}\right]_{J_{i}^{(n-k)}}+\left[\eta_{S}^{J}\right]_{J^{n-k}} . \tag{6.20}
\end{equation*}
$$

Applying the identity (6.20), we obtain

$$
\begin{aligned}
K_{1}= & \sum_{J \in \mathcal{E}_{n}} \sum_{\substack{S \subseteq\{1,2, \ldots, n-k\} \\
n-k \in S}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{J}\right]_{J} \\
= & \sum_{J \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-1\}} 2^{-\varepsilon \sum_{l \in S \cup\{n-k\}}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S \cup\{n-k\}}^{J}\right]_{J} \\
= & \sum_{J \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-1\}} 2^{-\varepsilon \sum_{l \in S \cup\{n-k\}}\left(j_{l+1}-j_{l}\right)} \sum_{i=j_{n-k+1}}^{j_{n-k}-1}\left[\left(\eta_{S^{\prime}}^{J_{i}^{(n-k)}}\right)^{\prime}\right]_{J_{i}^{(n-k)}} \\
& +\sum_{J \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-1\}} 2^{-\varepsilon \sum_{l \in S \cup\{n-k\}}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{J^{n-k}}\right]_{J^{\widehat{n-k}}} \\
= & \Sigma_{1}+\Sigma_{2} .
\end{aligned}
$$

In $\Sigma_{1}$ we change the order of summation, grouping together all the terms for which $J_{i}^{(n-k)}$ is a given $J^{\prime}=\left(j_{1}^{\prime}, \ldots, j_{n}^{\prime}\right) \in \mathcal{E}_{n}$. Clearly, this condition forces $J$ to differ from $J^{\prime}$ only in its component $j_{n-k}$, and we have $j_{n-k-1}^{\prime} \leq j_{n-k}<j_{n-k}^{\prime}$. In order to express the factor $2^{-\varepsilon \sum_{l \in S \cup\{n-k\}}\left(j_{l+1}-j_{l}\right)}$ in terms of $J^{\prime}$, we split the summation over the subsets $S$ into two parts; the first consists of subsets $S$ not containing $n-k-1$ and the second consists of the subsets which do contain $n-k-1$. We then have

$$
\begin{aligned}
\Sigma_{1}= & \sum_{J^{\prime} \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-2\}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)}\left(\sum_{i=j_{n-k-1}^{\prime}}^{j_{n-k}^{\prime}-1} 2^{-\varepsilon\left(j_{n-k+1}^{\prime}-i\right)}\left[\left(\eta_{S}^{J^{\prime}}\right)^{\prime}\right]_{J^{\prime}}\right) \\
& +\sum_{J^{\prime} \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-2\}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)} 2^{-\varepsilon\left(j_{n-k+1}^{\prime}-j_{n-k-1}^{\prime}\right)}\left(\sum_{i=j_{n-k-1}^{\prime}}^{j_{n-k}^{\prime}-1}\left[\left(\eta_{S \cup\{n-k-1\}}^{J^{\prime}}\right)^{\prime}\right]_{J^{\prime}}\right) \\
= & \Sigma_{1,1}+\Sigma_{1,2} .
\end{aligned}
$$

Each function appearing in $\Sigma_{1,1}$ has integral zero in each variable $\mathbf{x}_{r}$ with $r \notin$ $B \subset\{1, \ldots, n-k-2\}$, and each function appearing in $\Sigma_{1,2}$ has integral zero in each variable $\mathbf{x}_{r}$ with $r \notin B \cup\{n-k-1\} \subset\{1, \ldots, n-k-1\}$. All the $\eta^{\prime}$ in the above formula are normalized relative to the initial data. Hence, the term in $\Sigma_{1,1}$ indexed by $\left(J^{\prime}, S\right)$ contains a function $\tilde{\eta}_{S}^{J^{\prime}}$ normalized relative to the initial data, and multiplied by a factor

$$
2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)} \sum_{j_{n-k-1}^{\prime}}^{j_{n-k}^{\prime}-1} 2^{-\varepsilon\left(j_{n-k+1}^{\prime}-i\right)} \lesssim 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)}
$$

whereas the corresponding term in $\Sigma_{1,2}$ is a bump function $\tilde{\eta}_{S \cup\{n-k-1\}}^{J^{\prime}}$ normalized relative to the initial data and multiplied by

$$
2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)} 2^{-\varepsilon\left(j_{n-k}^{\prime}-j_{n-k-1}^{\prime}\right)}\left(j_{n-k}^{\prime}-j_{n-k-1}^{\prime}\right) \lesssim 2^{-\varepsilon^{\prime} \sum_{l \in S \cup\{n-k-1\}}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)}
$$

with $\varepsilon^{\prime}<\varepsilon$. Hence,

$$
\Sigma_{1}=\sum_{J^{\prime} \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-1\}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)}\left[\tilde{\eta}_{S}^{J^{\prime}}\right]_{J^{\prime}}
$$

and $\Sigma_{1}$ together with $K_{2}$ gives the first sum in (6.17) with $k$ replaced by $k+1$.
It remains to prove that $\Sigma_{2}$ can be absorbed in the remainder term (second sum) of (6.17). We group together the terms at the same scale and separate the sets $S$ containing $n-k-1$ from the others. Indexing the elements $J^{\prime}$ of $\mathcal{E}_{\mathcal{B}}$ as $J^{\prime}=\left(j_{1}^{\prime}, \ldots, j_{n-k-1}^{\prime}, j_{n-k}^{\prime}, \ldots, j_{n-1}^{\prime}\right) \in \mathcal{E}_{n-1}$, we have

$$
\begin{aligned}
& \Sigma_{2}=\sum_{J \in \mathcal{E}_{n}} \sum_{S \subseteq\{1,2, \ldots, n-k-1\}} 2^{-\varepsilon \sum_{l \in S \cup\{n-k\}}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{\widehat{J^{n-k}}}\right]_{J^{n-k}} \\
& =\sum_{J^{\prime} \in \mathcal{E}_{n-1}} \sum_{S \subseteq\{1,2, \ldots, n-k-2\}}\left(\sum_{J \in \mathcal{E}_{n}: J^{n-k}=J^{\prime}} 2^{-\varepsilon \sum_{l \in S \cup\{n-k\}}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{\widehat{J^{n-k}}}\right]_{J^{\widehat{n-k}}}\right) \\
& +\sum_{J^{\prime} \in \mathcal{E}_{n-1}} \sum_{S \subseteq\{1,2, \ldots, n-k-2\}}\left(\sum_{J \in \mathcal{E}_{n}: J^{\widehat{n-k}}=J^{\prime}} 2^{-\varepsilon \sum_{l \in S \cup\{n-k-1, n-k\}}\left(j_{l+1}-j_{l}\right)}\left[\eta_{S}^{\widehat{J^{n-k}}}\right]_{J^{\widehat{n-k}}}\right) \\
& =\Sigma_{2,1}+\Sigma_{2,2} .
\end{aligned}
$$

As in the previous discussion, each term in parentheses is a function normalized relative to the initial data, multiplied by a factor controlled by

$$
2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)} \sum_{i=j_{n-k-1}^{\prime}}^{j_{n-k}^{\prime}} 2^{-\varepsilon\left(j_{n-k}^{\prime}-i\right)} \lesssim 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)},
$$

for the terms in $\Sigma_{2,1}$ and by

$$
2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}-j_{l}\right)} 2^{-\varepsilon\left(j_{n-k}^{\prime}-j_{n-k-1}^{\prime}\right)}\left(j_{n-k}^{\prime}-j_{n-k-1}^{\prime}\right) \lesssim 2^{-\varepsilon^{\prime} \sum_{l \in S \cup\{n-k-1\}}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)},
$$

with $\varepsilon^{\prime}<\varepsilon$, for the terms in $\Sigma_{2,2}$. It follows that

$$
\Sigma_{3}=\sum_{J^{\prime} \in \mathcal{E}_{n-1}} \sum_{S \subseteq\{1,2, \ldots, n-k-1\}} 2^{-\varepsilon \sum_{l \in S}\left(j_{l+1}^{\prime}-j_{l}^{\prime}\right)}\left[\tilde{\eta}_{S}^{J^{\prime}}\right]_{J^{\prime}}
$$

and this concludes the proof.

### 6.4. Restricted cancellation conditions

Our next result shows that the cancellation conditions in the definition of a flag kernel can be relaxed. As usual, let $\mathcal{F}$ denote the standard flag

$$
(0) \subset \mathbb{R}^{a_{n}} \subset \mathbb{R}^{a_{n-1}} \oplus \mathbb{R}^{a_{n}} \subset \cdots \subset \mathbb{R}^{a_{2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}} \subset \mathbb{R}^{N}
$$

Theorem 6.13. Let $\mathcal{K}$ be a distribution in $\mathcal{S}\left(\mathbb{R}^{N}\right)$ which satisfies the conditions of Definition 2.3 for the flag $\mathcal{F}$, except that in condition (b), the values of the parameters $R_{1}, \ldots, R_{s}$ are restricted to $R_{1} \geq R_{2} \geq \cdots \geq R_{s}$. Then $\mathcal{K}$ is a flag kernel.

Before giving the formal proof, let us explain what needs to be done. We are asserting that if the cancellation conditions in part (b) of Definition 2.3 are satisfied when $R_{1} \geq R_{2} \geq \cdots \geq R_{s}$, then they are satisfied for all values of the scaling parameters. To do this we fix a non-empty subset $I \subseteq\{1, \ldots, n\}$, and a constant $\rho_{i}>0$ for every $i \in I$. For each $i \in I$ we choose $\psi_{i} \in C_{0}^{\infty}\left(\mathbb{R}^{a_{i}}\right)$ equal to 1 on the $N_{i}$-ball of radius 1 and supported on the $N_{i}$-ball of radius 2 , and with bounds on the norms $\left\{\left\|\psi_{i}\right\|_{(m)}\right\}$. We set $\mathbf{x}_{I}=\left(\mathbf{x}_{i}\right)_{i \in I}$ and $\mathbf{x}_{I}^{\prime}=\left(\mathbf{x}_{i}\right)_{i \notin I}$, and put

$$
\Psi_{\rho}\left(\mathbf{x}_{I}\right)=\prod_{i \in I} \psi_{i}\left(\rho_{i} \cdot \mathbf{x}_{i}\right)
$$

Let

$$
\mathcal{K}_{\Psi, \rho}^{\#}=\mathcal{K}_{\Psi, \rho}^{\#}\left(\mathbf{x}_{I}^{\prime}\right)=\left\langle\mathcal{K}, \Psi_{\rho}\right\rangle
$$

denote the distribution in the variables $\mathbf{x}_{I}^{\prime}$ such that

$$
\left\langle\mathcal{K}_{\Psi, \rho}^{\#}, \varphi\right\rangle=\left\langle\mathcal{K}, \Psi_{\rho} \otimes \varphi\right\rangle
$$

for every test function $\varphi$ in the variables $\mathbf{x}_{I}^{\prime}$. We must then prove the following: Suppose that $\mathcal{K}$ satisfies the hypotheses of Theorem 6.13. Then
(a) If $I=\{1, \ldots, n\}$, then $\left|\left\langle\mathcal{K}, \Psi_{\rho}\right\rangle\right| \leq C$ where $C$ is independent of the choice of $\left\{\rho_{i}\right\}$ and $\left\{\psi_{i}\right\}$.
(b) If I is a proper, non-empty subset of $\{1, \ldots, n\}$, let $i_{0}=\min \{j \mid j \notin I\}$. Then $\mathcal{K}_{\Psi, \rho}^{\#}$ coincides with a smooth function for $\mathbf{x}_{i_{0}} \neq 0$, and for every multi-index $\bar{\alpha}$,

$$
\begin{equation*}
\left|\partial_{\mathbf{x}_{I}^{\prime}}^{\bar{\alpha}} \mathcal{K}_{\Psi, \rho}^{\#}\left(\mathrm{x}_{I}^{\prime}\right)\right| \leq C_{\alpha} \prod_{i \notin I}\left(\sum_{\substack{l \notin I \\ l \leq i}} N_{l}\left(\mathbf{x}_{l}\right)\right)^{-Q_{i}-\llbracket \bar{\alpha}_{i} \rrbracket} \tag{6.21}
\end{equation*}
$$

where $\left\{C_{\alpha}\right\}$ are independent of the choice of $\left\{\rho_{i}\right\}$ and $\left\{\psi_{i}\right\}$.
In proving (a) or (b), we may assume that $\mathcal{K}$ has compact support, and look for non-restricted cancellation estimates that only depend on the constants in Definition 4.1, and not on the size of the support. For general $\mathcal{K}$, the conclusion will then follow by a limiting argument, based on the following construction. We fix a $C_{0}^{\infty}$-function $\varphi$ on the real line, equal to 1 on a neighborhood of the origin, and set $\Phi=\varphi \otimes \cdots \otimes \varphi \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right), \Phi_{r}=\Phi \circ \delta_{r^{-1}}$. Then $\mathcal{K}_{r}=\Phi_{r} \mathcal{K}$ has compact support, satisfies the hypotheses of Theorem 6.13 uniformly in $r$, and $\lim _{r \rightarrow \infty} \mathcal{K}_{r}=\mathcal{K}$ in the sense of distributions.

Proof. For $i \in I$, define $R_{i}$ as

$$
\begin{equation*}
R_{i}=\max _{\substack{l \in I \\ l \geq i}} \rho_{\ell} \tag{6.22}
\end{equation*}
$$

Then $R_{1} \geq R_{2} \geq \cdots$, and so by hypothesis $\mathcal{K}_{\Psi, R}^{\#}$ satisfies the estimates in (6.21). Thus it suffices to prove that the difference $\mathcal{K}_{\Psi, \rho}^{\#}-\mathcal{K}_{\Psi, R}^{\#}$ does as well.

Denote by $I^{0}$ (respectively $I^{+}$) the set of $i \in I$ such that $R_{i}=\rho_{i}$ (respectively $\left.R_{i}>\rho_{i}\right)$. Setting

$$
\eta_{i}\left(\mathbf{x}_{i}\right)=\psi_{i}\left(\rho_{i} \cdot \mathbf{x}_{i}\right)-\psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)
$$

we have

$$
\begin{aligned}
\Psi_{\rho}(\mathbf{x})-\Psi_{R}(\mathbf{x}) & =\left(\prod_{i \in I^{0}} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right)\left(\prod_{i \in I^{+}} \psi_{i}\left(\rho_{i} \cdot \mathbf{x}_{i}\right)-\prod_{i \in I^{+}} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right) \\
& =\left(\prod_{i \in I^{0}} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right)\left(\prod_{i \in I^{+}}\left(\psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)+\eta_{i}\left(\mathbf{x}_{i}\right)\right)-\prod_{i \in I^{+}} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right) \\
& =\left(\prod_{i \in I^{0}} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right) \sum_{\emptyset \neq J \subseteq I^{+}}\left(\prod_{i \in J} \eta_{i}\left(\mathbf{x}_{i}\right)\right)\left(\prod_{i \in I^{+} \backslash J} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right) \\
& =\sum_{\emptyset \neq J \subseteq I^{+}}\left(\prod_{i \in J} \eta_{i}\left(\mathbf{x}_{i}\right)\right)\left(\prod_{i \in I \backslash J} \psi_{i}\left(R_{i} \cdot \mathbf{x}_{i}\right)\right) .
\end{aligned}
$$

Fix $J \subseteq I^{+}, J \neq \emptyset$. By definition of $I^{0}$ and $I^{+}$, for each $i \in J, R_{i}=\rho_{l}$ for some $l \in I^{0}, l>i$. Set $\bar{i}=\min \left\{l \in I^{0}: l>i\right.$ and $\left.R_{i}=\rho_{l}\right\}$ and $\bar{J}=\{\bar{i}: i \in J\}$. By the cancellation of $\mathcal{K}$ in the variables $\mathbf{x}_{i}$ for $i \in I \backslash(J \cup \bar{J})$,

$$
\mathcal{K}_{\Psi, \rho}^{\#}\left(\mathrm{x}_{I}^{\prime}\right)-\mathcal{K}_{\Psi, R}^{\#}\left(\mathrm{x}_{I}^{\prime}\right)=\sum_{\emptyset \neq J \subseteq I^{+}}\left\langle\mathcal{K}_{J}^{\#},\left(\prod_{i \in J} \eta_{i}\right)\left(\prod_{i \in \bar{J}}\left(\psi_{i} \circ \delta_{R_{i}}\right)\right)\right\rangle_{J \cup \bar{J}}
$$

where each $\mathcal{K}_{J}^{\#}$ is a distribution in the variables $\mathbf{x}_{i}$ with $i \in{ }^{c} I \cup J \cup \bar{J}$, satisfying condition (a) of Definition 2.3.

Notice that this pairing can be expressed as an integral because the right-hand side $f$ in the pairing above is supported where $\mathcal{K}_{J}^{\#}$ is smooth. To see this, denote by $i_{0}$ the smallest element of ${ }^{c} I \cup J \cup \bar{J}$. Then $\mathcal{K}_{J}^{\#}$ is smooth for $\mathbf{x}_{i_{0}} \neq 0$. On the other hand, if $\mathbf{x}=\left(\mathbf{x}_{i}\right)_{i \in^{c} I \cup J \cup \bar{J}} \in \operatorname{supp} f$, all coordinates $\mathbf{x}_{i}$ are bounded away from zero except for those in $\bar{J}$. But every element of $\bar{J}$ is strictly larger than some element of $J$, therefore $i_{0} \notin \bar{J}$.

We estimate the $\bar{\alpha}$-derivative of each $\mathcal{K}_{J}^{\#}$ by

$$
\begin{align*}
& \left|\partial_{\mathbf{x}_{I}^{\prime}}^{\bar{\alpha}} \mathcal{K}_{J}^{\#}\left(\mathbf{x}_{I}^{\prime}, \mathbf{x}_{J}, \mathbf{x}_{\bar{J}}\right)\right| \\
& \leq C_{\alpha}\left(\prod_{i \in J} N_{i}\left(\mathbf{x}_{i}\right)^{-Q_{i}}\right)\left(\prod_{l \in \bar{J}}\left(\sum_{i \in J_{l}} N_{i}\left(\mathbf{x}_{i}\right)\right)^{-Q_{l}}\right) \prod_{i \notin I}\left(\sum_{\substack{l \notin I \\
l \leq i}} N_{l}\left(\mathbf{x}_{l}\right)\right)^{-Q_{i}-\llbracket \bar{\alpha}_{i} \rrbracket}, \tag{6.23}
\end{align*}
$$

where $J_{l}=\{i \in J: \bar{i}=l\}=\left\{i \in J: R_{i}=R_{l}\right\}$. Since the $J_{l}$ form a partition of $J$, we have

$$
\left|\mathcal{K}_{\Psi, \rho}^{\#}\left(\mathbf{x}_{I}^{\prime}\right)-\mathcal{K}_{\Psi, R}^{\#}\left(\mathbf{x}_{I}^{\prime}\right)\right| \leq C\left(\prod_{i \notin I}\left(\sum_{\substack{l \notin I \\ l \leq i}} N_{l}\left(\mathbf{x}_{l}\right)\right)^{-Q_{i}-\llbracket \bar{\alpha}_{i} \rrbracket}\right) \sum_{\emptyset \neq J \subseteq I^{+}} \prod_{l \in \bar{J}} V_{l} .
$$

With $m_{l}$ denoting the cardinality of $J_{l}$,

$$
\begin{aligned}
V_{l} & =\int_{\left\{N_{i}\left(\mathbf{x}_{i}\right)>R_{l}^{-1}, \forall i \in J_{l}\right\}} \int_{N_{l}\left(\mathbf{x}_{l}\right)<R_{l}^{-1}}\left(\prod_{i \in J_{l}} N_{i}\left(\mathbf{x}_{i}\right)^{-Q_{i}}\right)\left(\sum_{i \in J_{l}} N_{i}\left(\mathbf{x}_{i}\right)\right)^{-Q_{l}} d \mathbf{x}_{l} \prod_{i \in J_{l}} d \mathbf{x}_{i} \\
& =R_{l}^{-Q_{l}} \int_{\left\{N_{i}\left(\mathbf{x}_{i}\right)>R_{l}^{-1}, \forall i \in J_{l}\right\}}\left(\prod_{i \in J_{l}} N_{i}\left(\mathbf{x}_{i}\right)^{-Q_{i}}\right)\left(\sum_{i \in J_{l}} N_{i}\left(\mathbf{x}_{i}\right)\right)^{-Q_{l}} \prod_{i \in J_{l}} d \mathbf{x}_{i} \\
& \leq C R_{l}^{-Q_{l}} \prod_{i \in J_{l}} \int_{N_{i}\left(\mathbf{x}_{i}\right)>R_{l}^{-1}} N_{i}\left(\mathbf{x}_{i}\right)^{-Q_{i}-Q_{l} / m_{l}} d \mathbf{x}_{i} \leq C .
\end{aligned}
$$

This concludes the proof.

### 6.5. Invariance of flag kernels under changes of variables

We study the effect of a change of variables on the class of flag distributions. If $\mathcal{K} \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$, then formally $\langle\mathcal{K}, \psi\rangle=\int_{\mathbb{R}^{N}} K(\mathbf{x}) \psi(\mathbf{x}) d \mathbf{x}$, where $K$ is the 'kernel' associated to $\mathcal{K}$. Let $F: \mathbb{R}^{N} \rightarrow \mathbb{R}^{N}$ be a diffeomorphism with inverse $G$. We want to define a new distribution $\mathcal{K} \#$ which is the composition of $\mathcal{K}$ with the change of variables $F$. Now formally

$$
\langle\mathcal{K} \circ F, \psi\rangle=\int_{\mathbb{R}^{N}} K(F(\mathbf{x})) \psi(\mathbf{x}) d \mathbf{x}=\int_{\mathbb{R}^{N}} K(\mathbf{y}) \psi(G(\mathbf{y})) \operatorname{det}(J G)(\mathbf{y}) d y
$$

where $J G$ is the Jacobian matrix of $G$. Thus if $\psi^{\#}(\mathbf{y})=\psi(G(\mathbf{y})) \operatorname{det}(J G)(\mathbf{y})$, and if the change of variables has the property that $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ implies $\psi^{\#} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, we can define $\mathcal{K}^{\#}=\mathcal{K} \circ F$ by setting $\langle\mathcal{K} \#, \psi\rangle=\left\langle\mathcal{K}, \psi^{\#}\right\rangle$ for all $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$.

We are primarily interested in changes of variables of the form

$$
F\left(x_{1}, \ldots, x_{N}\right)=\left(x_{1}+P_{1}(\mathbf{x}), \ldots, x_{N}+P_{N}(\mathbf{x})\right)
$$

where $P_{1}, \ldots, P_{N}$ are polynomials of the form $P_{k}\left(x_{1}, \ldots, x_{N}\right)=\sum c_{k}^{\alpha} x_{1}^{\alpha_{1}} \cdots x_{k-1}^{\alpha_{k-1}}$ with coefficients $c_{k}^{\alpha} \in \mathbb{R}$. Thus $P_{k}$ depends only on the variables $\left\{x_{1}, \ldots, x_{k-1}\right\}$, and this guarantees that $F$ is a diffeomorphism with inverse $G$ of the same form. In particular, $\operatorname{det}(J G)(\mathbf{x})$ is a polynomial. Thus if $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, then $\operatorname{det}(J G) \psi \circ G \in$ $\mathcal{S}\left(\mathbb{R}^{N}\right)$, so $\mathcal{K}^{\#}$ is well-defined. We want to show that if $\mathcal{K}$ is a flag distribution adapted to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, then $\mathcal{K}^{\#}$ has the same property. In order to show this, we need to make additional assumptions on the coefficients $\left\{c_{k}^{\alpha}\right\}$.

Definition 6.14. A change of variables $\mathbf{y}=F(\mathbf{x})$ of the form $y_{k}=x_{k}+P_{k}(\mathbf{x})$ where $P_{k}(\mathbf{x})=\sum_{\alpha \in \mathcal{B}_{k}} c_{k}^{\alpha} x_{1}^{\alpha_{1}} \cdots x_{k-1}^{\alpha_{k-1}}$ is allowable if

$$
\mathcal{B}_{k}=\left\{\left(\alpha_{1}, \ldots, \alpha_{k-1}\right) \in \mathbb{N}^{k-1} \mid \sum_{j=1}^{k-1} \alpha_{j} d_{j}=d_{k}\right\}
$$

Theorem 6.15. Let $\mathcal{K} \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$ be a flag kernel adapted to the standard flag $\mathcal{F}$ coming from the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$. If $\mathbf{y}=F(\mathbf{x})$ is an allowable change of variables, then $\mathcal{K}^{\#}=\mathcal{K} \circ F$ is a flag distribution for the same decomposition.

Proof. We can assume that $\mathcal{K}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$ where each $\varphi^{I}$ is a normalized bump function having strong cancellation. Let $I \in E_{N}$. We consider the dilate $\left[\varphi^{I}\right]_{I}$ composed with an allowable change of variables. We have

$$
\begin{aligned}
{\left[\varphi^{I}\right]_{I}(F(\mathbf{x})) } & =\left[\varphi^{I}\right]_{I}\left(\ldots, x_{l}+P_{l}\left(x_{1}, \ldots, x_{l-1}\right), \ldots\right) \\
& =2^{-\sum_{k=1}^{N} d_{k} i_{k}} \varphi^{I}\left(\ldots, 2^{-d_{l} i_{l}}\left[x_{l}+P_{l}\left(x_{1}, \ldots, x_{l-1}\right)\right], \ldots\right)
\end{aligned}
$$

Put

$$
\theta^{I}(\mathbf{x})=\varphi^{I}\left(\ldots, x_{l}+2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right), \ldots\right)
$$

so that $\left[\theta^{I}\right]_{I}(\mathbf{x})=\left[\varphi^{I}\right]_{I}(F(\mathbf{x}))$. Put

$$
P_{l}^{I}(\mathbf{x})=2^{-d_{l} i_{l}} P_{l}\left(2^{I} \cdot \mathbf{x}\right)=\sum_{\mathcal{B}_{l}} 2^{-d_{l} i_{l}+\sum_{k=1}^{l-1} d_{j} \alpha_{j} i_{j}} c_{k}^{\alpha} x_{1}^{\alpha_{1}} \cdots x_{k-1}^{\alpha_{k-1}}
$$

Then $\theta^{I}(\mathbf{x})=\varphi^{I}\left(x_{1}+P_{1}^{I}(\mathbf{x}), \ldots, x_{N}+P_{N}^{I}(\mathbf{x})\right)$. Since the change of variables is allowable and $I \in \mathcal{E}_{n}$, we have

$$
-d_{l} i_{l}+\sum_{k=1}^{l-1} d_{k} \alpha_{k} i_{k}=-\sum_{k=1}^{l-1} \alpha_{k} d_{k}\left(i_{l}-i_{k}\right) \leq 0
$$

It follows that each $P_{l}^{I}$ is normalized relative to $P_{l}$, and this shows that $\left[\varphi^{I}\right]_{I}(F(\mathbf{x}))$ $=\left[\theta^{I}\right]_{I}(\mathbf{x})$, where $\theta^{I} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ is normalized relative to $\varphi^{I}$.

Next we study the cancellation properties of $\theta^{I}$. If we can show that each $\theta^{I}$ has weak cancellation relative to the multi-index $I \in \mathcal{E}_{n}$, it follows from Theorem 6.8 that

$$
\mathcal{K} \circ F=\sum_{I}\left[\varphi^{I}\right]_{I} \circ F=\sum_{I}\left[\theta^{I}\right]_{I}
$$

is a flag kernel, which is what we want to show.
To do this we use Proposition 5.7. Let $\{1, \ldots, n\}=A \cup B$ with $A \cap B=\emptyset$. We study

$$
\begin{aligned}
\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} & \theta^{I}\left(\mathbf{x}_{A}, \mathbf{x}_{B}\right) d \mathbf{x}_{B} \\
& =\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} \varphi^{I}\left(\ldots, x_{l}+2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right), \ldots\right) d \mathbf{x}_{B}
\end{aligned}
$$

Since $\varphi^{I}$ has strong cancellation, we can write it as a sum of terms of the form $\partial_{j_{1}} \cdots \partial_{j_{n}} \widetilde{\varphi}^{I}$, where each index $j_{l} \in J_{l}$. It suffices to consider the integrals
$\int_{\bigoplus_{k \in B} \mathbb{R}^{a_{k}}} \partial_{j_{1}} \cdots \partial_{j_{n}} \widetilde{\varphi}^{I}\left(\ldots, x_{l}+2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 2^{d_{j_{r}} i_{j_{r}}} x_{j_{r}}, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right), \ldots\right) d \mathbf{x}_{B}$.

Let $r \in B$. In this last integral, replace the term

$$
2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 2^{d_{j_{r}} i_{j_{r}}} x_{j_{r}}, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right)
$$

for $l>j_{r}$ by the term $2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 0, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right)$; i.e., we set $x_{j_{r}}=0$ everywhere in the integrand except where it appears by itself in the $j_{r}^{\text {th }}$ entry of $\partial_{j_{1}} \cdots \partial_{j_{n}} \widetilde{\varphi}^{I}$. Now

$$
\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} \partial_{j_{1}} \cdots \partial_{j_{n}} \widetilde{\varphi}^{I}\left(\ldots, x_{l}+2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 0, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right), \ldots\right) d \mathbf{x}_{B}=0
$$

since one of the variables we integrate is $x_{j_{r}}$, and we are integrating the derivative of a Schwartz function. Thus it suffices to estimate the integral of the difference:
$\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}}\left[\partial_{j_{1}} \cdots \partial_{j_{n}} \widetilde{\varphi}^{I}\left(\ldots, x_{l}+2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 2^{d_{j_{r}} i_{j_{r}}} x_{j_{r}}, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right), \ldots\right)\right.$

$$
\left.-\partial_{j_{1}} \cdots \partial_{j_{n}} \widetilde{\varphi}^{I}\left(\ldots, x_{l}+2^{-d_{l} i_{l}} P_{l}\left(2^{d_{1} i_{1}} x_{1}, \ldots, 0, \ldots, 2^{d_{l-1} i_{l-1}} x_{l-1}\right), \ldots\right)\right] d \mathbf{x}_{B}
$$

A typical term in the polynomial $P_{l}$ has the form $c_{\alpha} x_{1}^{\alpha_{1}} \cdots x_{l-1}^{\alpha_{l-1}}$ where $\alpha_{1} d_{1}+$ $\cdots+\alpha_{l-1} d_{l-1}=d_{l}$. Thus we get a 'gain' whose size can be estimated by a sum of terms of the form

$$
\left|c_{\alpha}\right| 2^{-d_{l} i_{l}+\alpha_{1} d_{1} i_{1}+\cdots+\alpha_{l-1} d_{l-1} i_{l-1}}\left|x_{1}\right|^{\alpha_{1}} \cdots\left|x_{l-1}\right|^{\alpha_{l-1}}
$$

where $\alpha_{j_{r}}>0$. However,

$$
\begin{aligned}
-d_{l} i_{l}+\sum_{t=1}^{l-1} \alpha_{t} d_{t} i_{t} & =\left[-d_{1}+\sum_{t=1}^{l-1} \alpha_{t} d_{t}\right] i_{l}+\sum_{t=1}^{l-1} \alpha_{t} d_{t}\left(i_{t}-i_{l}\right) \\
& =\sum_{t=1}^{l-1} \alpha_{t} d_{t}\left(i_{t}-i_{l}\right) \leq-\alpha_{r} d_{r}\left(i_{l}-i_{r}\right) \leq-\epsilon\left(i_{r+1}-i_{r}\right)
\end{aligned}
$$

Thus for every $r \in B$ we have shown that

$$
\left|\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} \theta^{I}\left(\mathbf{x}_{A}, \mathbf{x}_{B}\right) d \mathbf{x}_{B}\right| \lesssim 2^{-\epsilon\left(i_{r+1}-i_{r}\right)} .
$$

Thus with a smaller $\epsilon$ we have

$$
\left|\int_{\oplus_{k \in B} \mathbb{R}^{a_{k}}} \theta^{I}\left(\mathbf{x}_{A}, \mathbf{x}_{B}\right) d \mathbf{x}_{B}\right| \lesssim \prod_{r \in B} 2^{-\epsilon\left(i_{r+1}-i_{r}\right)}
$$

and it follows from Proposition 5.7 that $\theta^{I}$ has weak cancellation. This completes the proof.

### 6.6. Homogeneous nilpotent Lie groups

We now begin the study of operators $f \rightarrow f * \mathcal{K}$ where $\mathcal{K}$ is a flag kernel, and the convolution is on a homogeneous nilpotent Lie group $G$ with Lie algebra $\mathfrak{g}$. To say that a Lie group $G$ is homogeneous means that there is a one-parameter group of automorphisms $\delta_{r}: G \rightarrow G$ for $r>0$, with $\delta_{1}=$ Id. As a manifold, $G$ is an $N$-dimension real vector space, and we assume that with an appropriate choice of coordinates, $G=\mathbb{R}^{N}$ and the automorphisms are given by $\delta_{r}[\mathbf{x}]=r \cdot \mathbf{x}=$ $\left(r^{d_{1}} x_{1}, \ldots, r^{d_{N}} x_{N}\right)$ with $1 \leq d_{1} \leq d_{2} \leq \cdots \leq d_{N}$. We begin by summarizing the facts about group multiplication, invariant vector fields, and group convolution that we need in this context. Additional background information, and in particular the proofs of formulas (6.24) and (6.25) below, can be found in the Chapter 1 of [3].

The product on $G=\mathbb{R}^{N}$ is given by a polynomial mapping; if $\mathbf{x}=\left(x_{1}, \ldots, x_{N}\right)$ and $\mathbf{y}=\left(y_{1}, \ldots, y_{N}\right)$, the $k^{\text {th }}$ component of the product $\mathbf{x y}$ is given by

$$
\begin{equation*}
(\mathbf{x y})_{k}=x_{k}+y_{k}+M_{k}(\mathbf{x}, \mathbf{y})=x_{k}+y_{k}+\sum_{\alpha, \beta \in \mathcal{M}_{k}} c_{k}^{\alpha, \beta} x_{1}^{\alpha_{1}} \cdots x_{k-1}^{\alpha_{k-1}} y_{1}^{\beta_{1}} \cdots y_{k-1}^{\beta_{k-1}} \tag{6.24}
\end{equation*}
$$

where $\left\{c_{k}^{\alpha, \beta}\right\}$ are real constants, and

$$
\mathcal{M}_{k}=\left\{(\alpha ; \beta)=\left(\alpha_{1}, \ldots, \alpha_{k-1} ; \beta_{1}, \ldots, \beta_{k-1}\right) \mid \sum_{l=1}^{k-1} d_{l}\left(\alpha_{l}+\beta_{l}\right)=d_{k}\right\}
$$

Note that

$$
M_{k}(r \cdot \mathbf{x}, r \cdot \mathbf{y})=r^{d_{k}} M_{k}(\mathbf{x}, \mathbf{y})
$$

Next, let $\left\{X_{1}, \ldots, X_{N}\right\}$ and $\left\{Y_{1}, \ldots, Y_{N}\right\}$ be the left- and right-invariant vector fields on $G$ such that, at the origin, $X_{k}=Y_{k}=\partial_{x_{k}}$. Then

$$
\begin{align*}
& X_{k}=\frac{\partial}{\partial x_{k}}+\sum_{\substack{l=k+1 \\
d_{l}>d_{k}}}^{N} P_{k_{l}}(\mathrm{x}) \frac{\partial}{\partial x_{l}}=\frac{\partial}{\partial x_{k}}+\sum_{\substack{l=k+1 \\
d_{l}>d_{k}}}^{N} \sum_{\alpha \in \mathfrak{H}_{d_{l}-d_{k}}} a_{k_{l}}^{\alpha} x_{1}^{\alpha_{1}} \cdots x_{l-1}^{\alpha_{l-1}} \frac{\partial}{\partial x_{l}}, \\
& Y_{k}=\frac{\partial}{\partial x_{k}}+\sum_{\substack{l=k+1 \\
d_{l}>d_{k}}}^{N} \widetilde{P}_{k_{l}}(\mathrm{x}) \frac{\partial}{\partial x_{l}}=\frac{\partial}{\partial x_{k}}+\sum_{\substack{l=k+1 \\
d_{l}>d_{k}}}^{N} \sum_{\alpha \in \mathfrak{H}_{d_{l}-d_{k}}} \widetilde{a}_{k_{l}}^{\alpha} x_{1}^{\alpha_{1}} \cdots x_{l-1}^{\alpha_{l-1}} \frac{\partial}{\partial x_{l}}, \tag{6.25}
\end{align*}
$$

where $\left\{a_{k_{l}}^{\alpha}\right\}$ and $\left\{\widetilde{a}_{k_{l}}^{\alpha}\right\}$ are real constants, and the index set $\mathfrak{H}_{d}$ is defined in Proposition 2.1. It follows that $P_{k_{l}}, \widetilde{P}_{k_{l}} \in \mathcal{H}_{d_{l}-d_{k}}$.

The bi-invariant Haar measure on $G$ is Lebesgue measure $d \mathbf{y}=d y_{1} \cdots d y_{N}$. The convolution of functions $f, g \in L^{1}(G)$ is given by

$$
f * g(\mathbf{x})=\int_{G} f\left(\mathbf{x y}^{-1}\right) g(\mathbf{y}) d \mathbf{y}=\int_{G} f(\mathbf{y}) g\left(\mathbf{y}^{-1} \mathbf{x}\right) d \mathbf{y}
$$

and the integral converges absolutely for almost all $x \in G$. The following result can be found on page 22 of [3].

Proposition 6.16. Let $f, g \in \mathcal{C}^{1}(G) \cap L^{1}(G)$.
(1) If $X$ is a left-invariant vector field and $Y$ is a right invariant vector field, then $X[f * g]=f * X[g]$ and $Y[f * g]=Y[f] * g$.
(2) If $X$ is a left-invariant vector field and $Y=\widetilde{X}$ is the unique right-invariant vector field agreeing with $X$ at the origin, then $X[f] * g=f * Y[g]$.
(3) If $\delta=\delta_{0}$ denotes the Dirac delta-function at the origin, then $\varphi(x)=\varphi * \delta(x)=$ $\delta * \varphi(x)$ for $\varphi \in \mathcal{C}_{0}^{\infty}(G)$. In particular, if $X$ is a left-invariant vector field and $Y$ is a right invariant vector field, $X[\varphi]=\varphi * X[\delta]$ and $Y[\varphi]=Y[\delta] * \varphi$.

Using the formulas in (6.24), we can write the convolution of integrable functions $f$ and $g$ as

$$
\begin{equation*}
f * g(\mathbf{x})=\int_{\mathbb{R}^{N}} f\left(\ldots, x_{m}-y_{m}-P_{m}(\mathbf{x}, \mathbf{y}), \ldots\right) g\left(\ldots, y_{m}, \ldots\right) d y_{1} \cdots d y_{N} \tag{6.26}
\end{equation*}
$$

where each $P_{m}$ is a polynomial in the $2 m-2$ variables $\left\{x_{1}, \ldots, x_{m-1}, y_{1}, \ldots, y_{m-1}\right\}$ satisfying $P_{m}\left(2^{K} \cdot \mathbf{x}, 2^{K} \cdot \mathbf{y}\right)=2^{k_{m} d_{m}} P_{m}(\mathbf{x}, \mathbf{y})$. In the formula (6.26), the variables in $\mathbf{x}$ appear in the argument of $f$. However by a change of variables we can move some or all of them to the argument of $g$. Thus if $S$ is any subset of $\{1, \ldots, N\}$, we can write

f * g(\mathbf{x})=\int_{\mathbb{R}^{N}} f\left(u_{1}(\mathbf{x}, \mathbf{y}), \ldots, u_{N}(\mathbf{x}, \mathbf{y})\right) g\left(v_{1}(\mathbf{x}, \mathbf{y}), \ldots, v_{N}(\mathbf{x}, \mathbf{y})\right) d y_{1} \cdots d y_{N} \tag{6.27}
\end{equation*}
$$ where

$$
\begin{align*}
& u_{m}(\mathbf{x}, \mathbf{y})= \begin{cases}x_{m}-y_{m}-Q_{m}(\mathbf{x}, \mathbf{y}) & \text { if } m \in S \\
y_{m} & \text { if } m \notin S\end{cases}  \tag{6.28}\\
& v_{m}(\mathbf{x}, \mathbf{y})= \begin{cases}y_{m} & \text { if } m \in S \\
x_{m}-y_{m}-Q_{m}(\mathbf{x}, \mathbf{y}) & \text { if } m \notin S\end{cases}
\end{align*}
$$

Here each $Q_{m}=Q_{m}^{S}$ is a polynomial in the variables $\left\{x_{1}, \ldots, x_{m-1}, y_{1}, \ldots, y_{m-1}\right\}$ with the same homogeneity as $P_{m}$; that is $Q_{m}\left(2^{K} \cdot \mathbf{x}, 2^{K} \cdot \mathbf{y}\right)=2^{k_{m} d_{m}} Q_{m}(\mathbf{x}, \mathbf{y})$.

### 6.7. Support properties of convolutions $[\varphi]_{I} *[\psi]_{J}$

In this section we study the support properties of the convolution of dilates of normalized bump functions with compact support. Given integers $i, j \in \mathbb{Z}$, we set $i \vee j=\max \{i, j\}$. Given $N$-tuples $I=\left(i_{1}, \ldots, i_{N}\right), J=\left(j_{1}, \ldots, j_{N}\right) \in \mathbb{Z}^{N}$, we set

$$
\begin{equation*}
I \vee J=\left(i_{1} \vee j_{1}, \ldots, i_{N} \vee j_{N}\right) \tag{6.29}
\end{equation*}
$$

We want to show that the convolution $[\varphi]_{I} *[\psi]_{J}$ is the $I \vee J$-dilate of a normalized function.

Lemma 6.17. Let $\varphi, \psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ have support in the ball $B(\rho)$. Then for any $I, J \in E_{N}$ there exists $\theta \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ supported in the ball $B(C \rho)$ such that $[\varphi]_{I}$ * $[\psi]_{J}=[\theta]_{I \vee J}$, and $\|\theta\|_{(m)} \leq C_{m}\|\varphi\|_{(m)}\|\psi\|_{(m)}$. The constants $C$ and $\left\{C_{M}\right\}$ can depend on the radius $\rho$, but are independent of the functions $\varphi$ and $\psi$.

Proof. Let $K=I \vee J$ and put

$$
\theta=\left[[\varphi]_{I} *[\psi]_{J}\right]_{-K} .
$$

It suffices to show that $\theta$ is supported in the set $\left\{\mathbf{x} \in \mathbb{R}^{N}:\left|x_{k}\right| \leq C \rho, 1 \leq k \leq N\right\}$ and that $\|\theta\|_{(m)} \leq C_{m}\|\varphi\|_{(m)}\|\psi\|_{(m)}$ for some absolute constants $C$ and $\left\{C_{m}\right\}$.

Making the change of variables $y_{m} \rightarrow 2^{k_{m} d_{m}} y_{m}$ and using the homogeneity of the functions $\left\{u_{m}\right\}$ and $\left\{v_{m}\right\}$, we have

$$
\begin{aligned}
& {\left[[\varphi]_{I} *\left[\psi_{J}\right]\right]_{-K}(\mathbf{x})} \\
& \quad=2^{\sum_{m} d_{m} k_{m}}\left([\varphi]_{I} *[\psi]_{J}\right)\left(2^{d_{1} k_{1}} x_{1}, \ldots, 2^{d_{N} k_{N}} x_{N}\right) \\
& =2^{\sum_{m} 2 d_{m} k_{m}} \int_{\mathbb{R}^{N}}[\varphi]_{I}\left(\ldots, u_{m}\left(2^{d_{1} k_{1}} x_{1}, \ldots, 2^{d_{N} k_{N}} x_{N}, \mathbf{y}\right), \ldots\right) \\
& \quad \cdot[\psi]_{J}\left(\ldots, v_{m}\left(2^{d_{1} k_{1}} x_{1}, \ldots, 2^{d_{N} k_{N}} x_{N}, \mathbf{y}\right), \ldots\right) d y_{1} \cdots d y_{N} \\
& =2^{\sum_{m} d_{m}\left(2 k_{m}-i_{m}-j_{m}\right)} \int_{\mathbb{R}^{N}} \varphi\left(\ldots, 2^{d_{m}\left(k_{m}-i_{m}\right)} u_{m}(\mathbf{x}, \mathbf{y}), \ldots\right) \\
&
\end{aligned} \quad \cdot \psi\left(\ldots, 2^{d_{m}\left(k_{m}-j_{m}\right)} v_{m}(\mathbf{x}, \mathbf{y}), \ldots\right) d y_{1} \cdots d y_{N} .
$$

Note that $2^{d_{m}\left(k_{m}-i_{m}\right)} \geq 1$ and $2^{d_{m}\left(k_{m}-j_{m}\right)} \geq 1$. It follows that if $\left[\varphi_{I} * \psi_{J}\right]_{-K}(\mathbf{x}) \neq 0$, there exists $\mathbf{y}=\left(y_{1}, \ldots, y_{N}\right) \in \mathbb{R}^{N}$ so that for $1 \leq m \leq N$,

$$
\begin{align*}
& \left|u_{m}(\mathbf{x}, \mathbf{y})\right| \leq 2^{d_{m}\left(k_{m}-i_{m}\right)}\left|u_{m}(\mathbf{x}, \mathbf{y})\right| \leq \rho \\
& \left|v_{m}(\mathbf{x}, \mathbf{y})\right| \leq 2^{d_{m}\left(k_{m}-j_{m}\right)}\left|v_{m}(\mathbf{x}, \mathbf{y})\right| \leq \rho \tag{6.30}
\end{align*}
$$

We show by induction on $m$ that these inequalities imply that $\left|x_{m}\right|+\left|y_{m}\right| \leq A_{m} \rho$ for an appropriate choice of constants $A_{1}<A_{2}<\cdots<A_{N}$. When $m=1$, we have $\left|x_{1}-y_{1}\right| \leq \rho$ and $\left|y_{1}\right| \leq \rho$, so $\left|x_{1}\right|+\left|y_{1}\right| \leq 3 \rho$, and we can take $A_{1}=3$. Next, assume by induction that $\left|x_{s}\right|+\left|y_{s}\right| \leq A_{s} \rho$ for $1 \leq s<m$. Since $Q_{m}(\mathbf{x}, \mathbf{y})$ depends only on the variables $\left\{x_{1}, \ldots, x_{m-1}, y_{1}, \ldots, y_{m-1}\right\}$, it follows that $\left|Q_{m}(\mathbf{x}, \mathbf{y})\right| \leq$ $B_{m} \rho$, where $B_{m}$ is a constant that depends on the coefficients of the polynomial $Q_{m}$, on the constants $\left\{A_{s}\right\}$ for $s<m$, and on $\rho$. We have $\left|y_{m}\right| \leq \rho$ and $\left|x_{m}-y_{m}-Q_{m}(\mathbf{x}, \mathbf{y})\right| \leq \rho$, so $\left|x_{m}\right|+\left|y_{m}\right| \leq\left(B_{m}+2\right) \rho$. This completes the proof of the statement about the support of $\theta$.

To establish the estimate $\|\theta\|_{(m)} \leq C_{m}\|\varphi\|_{(m)}\|\psi\|_{(m)}$, we again use (6.27), but this time with the set $S=\left\{m \in\{1, \ldots, N\} \mid j_{m} \leq i_{m}=k_{m}\right\}$. Of the two factors $\left\{2^{d_{m}\left(k_{m}-i_{m}\right)}, 2^{d_{m}\left(k_{m}-j_{m}\right)}\right\}$, the one which equals 1 multiplies the expression $x_{m}-$ $y_{m}-Q_{m}(\mathbf{x}, \mathbf{y})$, while the term $y_{m}$ is multiplied by the larger factor $2^{d_{m}\left(k_{m}-\left(i_{m} \wedge j_{m}\right)\right)}$. Thus with this representation of the convolution $\varphi_{I} * \psi_{J}$, the integration takes place
over the set $E=\left\{\mathbf{y} \in \mathbb{R}^{N}:\left|y_{m}\right| \leq 2^{-d_{m}\left(k_{m}-\left(i_{m} \wedge j_{m}\right)\right)}\right\}$. Thus we can estimate the size of $\left[[\varphi]_{I} *[\psi]_{J}\right]_{-K}(\mathbf{x})$ by

$$
\left|\left[\varphi_{I} * \psi_{J}\right]_{-K}(\mathbf{x})\right| \leq 2^{\sum_{m} d_{m}\left(2 k_{m}-i_{m}-j_{m}\right)}\|\varphi\|_{0}\|\psi\|_{0} \int_{E} d \mathbf{y} \leq C_{0}\|\varphi\|_{0}\|\psi\|_{0}
$$

since $2 k_{m}-i_{m}-j_{m}-k_{m}+\left(i_{m} \wedge j_{m}\right)=0$. When we take derivatives of $\left[[\varphi]_{I} *\right.$ $\left.[\psi]_{J}\right]_{-K}(\mathbf{x})$, the terms involving the variables $\mathbf{x}$ are multiplied by the factor 1 , and so we obtain in the same way the estimate

$$
\left\|\left[\varphi_{I} * \psi_{J}\right]_{-K}\right\|_{(m)} \leq C_{m}\|\varphi\|_{(m)}\|\psi\|_{(m)}
$$

This completes the proof.

### 6.8. Decay and cancellation properties of convolutions $[\varphi]_{I} *[\psi]_{J}$

We want to study the decay and cancellation properties of the convolution $[\varphi]_{I} *$ $[\psi]_{J}$ under the assumption that $\varphi$ has cancellation in the variables $\left\{x_{l_{1}}, \ldots, x_{l_{a}}\right\}$ and $\psi$ has cancellation in the variables $\left\{x_{m_{1}}, \ldots, x_{m_{b}}\right\}$. Here decay means that the size of $[\varphi]_{I} *[\psi]_{J}$ is small due to the difference between the $N$-tuples $I$ and $J$; cancellation means that the integral of $[\varphi]_{I} *[\psi]_{J}$ with respect to some variables is zero. (See Section 5.2 and Definition 5.3 for the precise definition of strong and weak cancellation). Before stating our results, let us see what we should expect by considering the much simpler case in which the convolution $[\varphi]_{I} *_{e}[\psi]_{J}$ is taken with respect to the Abelian (Euclidean) vector space structure of $\mathbb{R}^{N}$ rather than the general homogeneous nilpotent Lie group structure $G$.

Let $I=\left(i_{1}, \ldots, i_{N}\right)$ and $J=\left(j_{1}, \ldots, j_{N}\right)$, and put

$$
\begin{aligned}
A_{0} & =\left\{s \in\{1, \ldots, a\} \mid i_{l_{s}} \leq j_{l_{s}}\right\}, \\
A_{1} & =\left\{s \in\{1, \ldots, a\} \mid i_{l_{s}}>j_{l_{s}}\right\} \\
B_{0} & =\left\{t \in\{1, \ldots, b\} \mid j_{m_{t}} \leq i_{m_{t}}\right\}, \\
B_{1} & =\left\{t \in\{1, \ldots, b\} \mid j_{m_{t}}>i_{m_{t}}\right\}=\left\{m_{1}, \ldots, m_{b}\right\} \backslash B_{0} .
\end{aligned}
$$

Because of the hypothesis on cancellation, we can write

$$
\begin{aligned}
& \varphi=\partial_{l_{1}} \cdots \partial_{l_{a}} \widetilde{\varphi}, \\
& \psi=\partial_{m_{1}} \cdots \partial_{m_{b}} \widetilde{\psi} .
\end{aligned}
$$

For each $s \in A_{0}$ we can integrate by parts in the variable $x_{l_{s}}$ in the integral $[\varphi]_{I} *_{e}[\psi]_{J}$, moving the derivative $\partial_{l_{s}}$ from $\widetilde{\varphi}$ to $\widetilde{\psi}$. Since the width of the dilate $[\varphi]_{I}$ is narrower in this variable than the dilate $[\psi]_{J}$, this integration by parts gives a gain of $2^{-\epsilon\left(j_{l_{s}}-i_{l_{s}}\right)}$, and we get such a gain for each $s \in A_{0}$. A similar argument shows that we get a gain of $2^{-\epsilon\left(i_{m_{t}}-j_{m_{t}}\right)}$ for each $t \in B_{0}$. Thus the total gain from integration by parts is $\prod_{s \in A_{0}} 2^{-\epsilon\left(j_{l_{s}}-i_{l_{s}}\right)} \prod_{t \in B_{0}} 2^{-\epsilon\left(i_{m_{t}}-j_{m_{t}}\right)}$. In addition to this gain, we observe that in the convolution $[\varphi]_{I} *_{e}[\psi]_{J}$, the derivatives $\partial_{l_{s}}$ for $s \in A_{1}$
and $\partial_{m_{t}}$ for $t \in B_{1}$ can be pulled outside the integral. The final result is that there is a compactly supported function $\theta$, normalized relative to $\varphi$ and $\psi$, so that

$$
[\varphi]_{I} *_{e}[\psi]_{J}=\prod_{s \in A_{0}} 2^{-\epsilon\left(j_{l_{s}}-i_{l_{s}}\right)} \prod_{t \in B_{0}} 2^{-\epsilon\left(i_{m_{t}}-j_{m_{t}}\right)} \prod_{s^{\prime} \in A_{1}} \prod_{t^{\prime} \in B_{1}} \partial_{l_{s^{\prime}}} \partial_{m_{t^{\prime}}}[\theta]_{I \vee J}
$$

In other words, we get exponential gains from variables where there is cancellation for the function with 'narrower' dilation, and the resulting convolution still has cancellation in the remaining variables.

When dealing with convolution on a homogeneous nilpotent Lie group, we cannot move Euclidean derivatives from one factor to the other. However, we can write Euclidean derivatives in terms of left- or right-invariant vector fields which can be moved across the convolution. But this process introduces error terms involving derivatives with respect to 'higher' variables, and these come with a gain involving the differences between entries of $I$ or $J$. Thus in the case of nilpotent Lie groups, we might hope that convolution results in three kinds of terms: gains of the form $2^{-\epsilon\left|i_{\ell}-j_{\ell}\right|}$ coming from integration by parts in narrow variables with cancellation, residual cancellation of the convolution in some variables which are not used in the integration by parts, and finally gains of the type $2^{-\epsilon\left(i_{\ell+1}-i_{\ell}\right)}$ and $2^{-\epsilon\left(j_{\ell+1}-j_{\ell}\right)}$. This is in fact the case, and is made precise in the next lemma.

Suppose we are given two decompositions

(\mathcal{B}): & \mathbb{R}^{N}=\mathbb{R}^{b_{1}} \oplus \cdots \oplus \mathbb{R}^{b_{m}}
\end{array}
$$

Let $\left\{J_{1}^{\mathcal{A}}, \ldots, J_{n}^{\mathcal{A}}\right\}$ be the indices corresponding to $(\mathcal{A})$ and let $\left\{J_{1}^{\mathcal{B}}, \ldots, J_{m}^{\mathcal{B}}\right\}$ be the indices corresponding to $(\mathcal{B})$. Define

$$
\begin{gathered}
\sigma:\{1, \ldots, N\} \rightarrow\{1, \ldots, n\} \quad \text { such that } \quad \ell \in J_{\sigma(\ell)}^{\mathcal{A}}, \\
\tau:\{1, \ldots, N\} \rightarrow\{1, \ldots, m\} \quad \text { such that } \quad l \in J_{\tau(l)}^{\mathcal{B}} .
\end{gathered}
$$

In what follows, $\pi_{\mathcal{A}}$ and $\pi_{\mathcal{B}}$ denote mappings from the set $\{1, \ldots, N\}$ to itself with the properties that $\pi_{\mathcal{A}}(\ell) \in J_{\sigma(\ell)}^{\mathcal{A}}$, and $\pi_{\mathcal{B}}(l) \in J_{\tau(l)}^{\mathcal{B}}$. Also recall from equation (4.5) in Section 4.1 that we can introduce mappings $p_{\mathcal{A}}: \mathcal{E}_{n} \rightarrow E_{N}$ and $p_{\mathcal{B}}: \mathcal{E}_{m} \rightarrow E_{N}$ so that

\begin{aligned}
& p_{\mathcal{A}}\left(i_{1}, \ldots, i_{n}\right)=(\overbrace{i_{1}, \ldots, i_{1}}^{a_{1}}, \overbrace{i_{2}, \ldots, i_{2}}^{a_{2}}, \ldots, \overbrace{i_{n}, \ldots, i_{n}}^{a_{n}}), \\
& p_{\mathcal{B}}\left(j_{1}, \ldots, j_{m}\right)=(\overbrace{j_{1}, \ldots, j_{1}}^{b_{1}}, \overbrace{j_{2}, \ldots, j_{2}}^{b_{2}}, \ldots, \overbrace{j_{m}, \ldots, j_{m}}^{b_{m}}) .
\end{aligned}
$$

Lemma 6.18. Suppose that $\varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ has cancellation in the variables $x_{\ell}$ for $\ell \in A \subset\{1, \ldots, N\}$, and that $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ has cancellation in the variables $x_{l}$ for $l \in B \subset\{1, \ldots, N\}$. Let $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$ and $J=\left(j_{1}, \ldots, j_{m}\right) \in \mathcal{E}_{m}$. Set

where $\theta$ is normalized relative to $\varphi$ and $\psi, A=A_{1} \cup A_{2} \cup A_{3}$ and $B=B_{1} \cup B_{2} \cup B_{3}$ are disjoint unions, and we have $A_{2} \subset A_{0} \subset A_{1} \cup A_{2}$ and $B_{2} \subset B_{0} \subset B_{1} \cup B_{2}$. (We will have $\sigma(\ell) \neq n$ and $\tau(l) \neq n$.)

Proof. Using the cancellation hypotheses, it follows from Lemma 5.1 that we can write

Moreover, according to the Remarks 4.9 following Corollary 4.8, the operators $\left\{Z_{\pi_{\mathcal{A}}(\ell)}\right\}$ can be put in any desired order. Similarly $[\psi]_{J}$ is a finite sum of terms of the form

Let $\varphi, \psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ have strong cancellation relative to the same decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$. There exists $\epsilon>0$ so that if $I, J \in \mathcal{E}_{n}$, it follows that $[\varphi]_{I} *[\psi]_{J}$ is a finite sum of terms of the form

\prod_{\ell \in A} 2^{-\epsilon\left(i_{\ell+1}-i_{\ell}\right)} \prod_{\ell \in \widetilde{A}} 2^{-\epsilon\left|i_{\ell}-j_{\ell}\right|} \prod_{l \in B} 2^{-\epsilon\left(j_{l+1}-j_{l}\right)} \prod_{l \in \widetilde{B}} 2^{-\epsilon\left|i_{l}-j_{l}\right|}\left[\theta_{A, B}\right]_{I \vee J},

where,
(a) the set $\{1, \ldots, n\}$ is the disjoint union of the sets $A$ and $\widetilde{A}$, and of the sets $B$ and $\widetilde{B}$, with $n \notin A$ and $n \notin B$;
(b) each function $\theta_{A, B}$ is normalized relative to $\varphi$ and $\psi$.

Proof. Let $J_{\ell}$ denote the set of subscripts $\ell$ such that $x_{\ell} \in \mathbb{R}^{a_{\ell}}$, and let

\sigma:\{1, \ldots, N\} \rightarrow\{1, \ldots, n\}

be the mapping such that $\sigma(\ell) \in J_{\ell}$ for all $\ell$. Since $\varphi$ and $\psi$ both have strong cancellation relative to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, if $A_{0}$ and $B_{0}$ are the sets defined in Lemma 6.18, it follows that $\left\{\sigma(\ell) \mid \ell \in A_{0} \cup B_{0}\right\}=\{1, \ldots, n\}$. This means that the sets $A_{3}$ and $B_{3}$ of that Lemma must be empty, and the result follows.

### 6.9. Truncated flag kernels

Definition 6.20. A flag distribution $\mathcal{K}$ adapted to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus$ $\cdots \oplus \mathbb{R}^{a_{n}}$ is a truncated kernel of width $a>0$ if the differential inequalities given in part (a) of Definition 2.3 are replaced by

$\mathcal{K}$ is an improved truncated kernel if it is a truncated kernel, and in addition satisfies

Our objective is to establish the following:

Proposition 6.21. Let $\mathcal{K}$ be a flag distribution.
(1) If $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ has support in the unit ball, then $\mathcal{K} * \psi$ and $\psi * \mathcal{K}$ are truncated flag kernels of width 1 .
(2) If $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ has support in the unit ball, and if $\int_{\mathbb{R}^{N}} \psi(\mathbf{x}) d \mathbf{x}=0$, then $\mathcal{K} * \psi$ and $\psi * \mathcal{K}$ are improved truncated flag kernels of width 1 .

Proof. We can write $\mathcal{K}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}+\sum_{j=1}^{r} \mathcal{K}_{j}$, where $\left\{\varphi^{I}\right\}$ are normalized unit bump functions with strong cancellation, and $\left\{\mathcal{K}_{1}, \ldots, \mathcal{K}_{r}\right\}$ are flag distributions adapted to coarser flags. If $\mathcal{K}_{0}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$, it suffices to show that the proposition is true for $\mathcal{K}_{0}$. We consider $\psi * \mathcal{K}_{0}$. The case of $\mathcal{K}_{0} * \psi$ is handled similarly. We have

$$
\begin{aligned}
\psi * \mathcal{K}_{0} & =\sum_{I \in \mathcal{E}_{n}} \psi *\left[\varphi^{I}\right]_{I}=\sum_{I \in \mathcal{E}_{n}^{-}} \psi *\left[\varphi^{I}\right]_{I}+\sum_{k=1}^{n-1} \sum_{I \in \mathcal{E}_{n}^{k}} \psi *\left[\varphi^{I}\right]_{I}+\sum_{I \in \mathcal{E}_{n}^{+}} \psi *\left[\varphi^{I}\right]_{I} \\
& =\mathrm{I}+\sum_{k=1}^{n-1} \mathrm{II}_{k}+\mathrm{III}
\end{aligned}
$$

where

$$
\begin{aligned}
\mathcal{E}_{n}^{-} & =\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n} \mid i_{n} \leq 0\right\} \\
\mathcal{E}_{n}^{k} & =\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n} \mid i_{k} \leq 0<i_{k+1}\right\} \\
\mathcal{E}_{n}^{+} & =\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n} \mid 0<i_{1}\right\}
\end{aligned}
$$

Denote the element $(0, \ldots, 0) \in \mathcal{E}_{n}$ by $\mathbf{0}$. If $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}^{k}$, then $i_{1} \leq i_{2} \leq$ $\cdots \leq i_{k} \leq 0$, and we put $\widetilde{I}_{k}=\left(0, \ldots, 0, i_{k+1}, \ldots, i_{n}\right)$. Then

$$
I \vee \mathbf{0}= \begin{cases}\mathbf{0} & \text { if } I \in \mathcal{E}_{n}^{-} \\ \widetilde{I}_{k} & \text { if } I \in \mathcal{E}_{n}^{k} \\ I & \text { if } I \in \mathcal{E}_{n}^{+}\end{cases}
$$

Let

$$
\widetilde{\mathcal{E}}_{n}^{k}=\left\{I \in \mathcal{E}_{n} \mid i_{1}=\cdots=i_{k}=0\right\}
$$

Note that if $I \in \mathcal{E}_{n}^{k}$ then $\widetilde{I}_{k} \in \widetilde{\mathcal{E}}_{n}^{k}$. According to Lemmas 6.17 and 6.18, each term $\psi *\left[\varphi^{I}\right]_{I}$ has weak cancellation. Moreover, for each $I \in \mathcal{E}_{n}$ there exists $\theta^{I} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, normalized with respect to $\psi$ and $\varphi^{I}$, so that

I \in \mathcal{E}_{n}^{-} & \Longrightarrow \psi *\left[\varphi^{I}\right]_{I}=2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{n}\right|\right)}\left[\theta^{I}\right]_{\bar{o}}, \\
I \in \mathcal{E}_{n}^{k} & \Longrightarrow \psi *\left[\varphi^{I}\right]_{I}=2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{k}\right|\right)}\left[\theta^{I}\right]_{\widetilde{I}_{k}}  \tag{6.31}\\
I \in \mathcal{E}_{n}^{+} & \Longrightarrow \psi *\left[\varphi^{I}\right]_{I}=\left[\theta^{I}\right]_{I} .
\end{align*}
$$

We have

$$
\mathrm{I}(\mathbf{x})=\sum_{I \in \mathcal{E}_{n}^{-}} 2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{n}\right|\right)}\left[\theta^{I}\right]_{\mathbf{0}}(\mathbf{x})=\sum_{I \in \mathcal{E}_{n}^{-}} 2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{n}\right|\right)} \theta^{I}(\mathbf{x})=\widetilde{\theta}^{\mathbf{0}}(\mathbf{x})
$$

where the series converges to a normalized unit bump function $\widetilde{\theta}^{0}$. Next, we can write

$$
\begin{aligned}
\mathrm{I}_{k}(\mathbf{x}) & =\sum_{I \in \mathcal{E}_{n}^{k}} \psi *\left[\varphi^{I}\right]_{I}(\mathbf{x})=\sum_{J \in \widetilde{\mathcal{E}}_{n}^{k}}\left[\sum_{\substack{I \in \mathcal{E}_{n}^{k} \\
\widetilde{I}_{k}=J}} \psi *\left[\varphi^{I}\right]_{I}\right](\mathbf{x}) \\
& =\sum_{J \in \widetilde{\mathcal{E}}_{n}^{k}}\left[\sum_{\substack{I \in \mathcal{E}_{n}^{k} \\
\widetilde{I}_{k}=J}} 2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{k}\right|\right)}\left[\theta^{I}\right]_{\widetilde{I}_{k}}\right](\mathbf{x}) \\
& =\sum_{J \in \widetilde{\mathcal{E}}_{n}^{k}}\left[\sum_{\substack{I \in \mathcal{E}_{n}^{k} \\
\widetilde{I}_{k}=J}} 2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{k}\right|\right)} \theta^{I}\right]_{J}(\mathbf{x})=\sum_{J \in \widetilde{\mathcal{E}}_{n}^{k}}\left[\widetilde{\theta}^{J}\right]_{J}(\mathbf{x}),
\end{aligned}
$$

where

$$
\sum_{\substack{I \in \mathcal{E}_{n}^{k} \\ \tilde{I}_{k}=J}} 2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{k}\right|\right)} \theta^{I}=\widetilde{\theta}^{J}
$$

converges to a normalized unit bump function. Thus each $\mathrm{II}_{k}$ is a flag kernel with a decomposition into dilates of normalized bump functions where all of the dilation parameters are non-negative. This is also true of the term III.

Thus we have shown that

$$
\psi * \mathcal{K}_{0}=\sum_{I \in \mathcal{E}_{n}^{+}}\left[\widetilde{\theta}^{I}\right]_{I}
$$

where

$$
\mathcal{E}_{n}^{+}=\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{Z}^{n} \mid 0 \leq i_{1} \leq i_{2} \leq \cdots \leq i_{n}\right\}
$$

But then it follows from the second inequality in Proposition 10.1, as in the proof of Proposition 6.9 that $\psi * \mathcal{K}_{0}$ satisfies the differential inequalities of a truncated kernel of width one.

If we assume in addition that $\int_{\mathbb{R}^{N}} \psi(\mathbf{x}) d \mathbf{x}=0$, then we can write $\psi=\sum_{l=1}^{N} \psi_{l}$, with

$$
\int_{\mathbb{R}} \psi_{l}\left(x_{1}, \ldots, x_{l-1}, t, x_{l+1}, \ldots, x_{N}\right) d t=0
$$

We can repeat the argument given above with $\psi$ replaced by $\psi_{l}$. It then follows from Lemma 6.18 that instead of the formulas given in equation (6.31), we get

I \in \mathcal{E}_{n}^{-} & \Longrightarrow \psi_{l} *\left[\varphi^{I}\right]_{I}=2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{n}\right|\right)}\left[\theta^{I}\right]_{\overline{0}}, & \\
I \in \mathcal{E}_{n}^{k} \quad \Longrightarrow & \psi_{l} *\left[\varphi^{I}\right]_{I}=2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{k}\right|\right)}\left[\theta^{I}\right]_{\widetilde{I}_{k}} & \text { if } k<l,  \tag{6.32}\\
I \in \mathcal{E}_{n}^{k} & \Longrightarrow \psi_{l} *\left[\varphi^{I}\right]_{I}=2^{-d_{l} i_{l}} 2^{-\epsilon\left(\left|i_{1}\right|+\cdots+\left|i_{k}\right|\right)}\left[\theta^{I}\right]_{\widetilde{I}_{k}} & \text { if } k \geq l, \\
I \in \mathcal{E}_{n}^{+} & \Longrightarrow \psi_{l} *\left[\varphi^{I}\right]_{I}=2^{-d_{l} i_{l}}\left[\theta^{I}\right]_{I} . &
\end{array}
$$

Again using the second inequality in Proposition 10.1, and observing that the case $l=1$ gives the worst estimate, we see that $\psi_{l} * \mathcal{K}_{0}$ satisfies the differential inequalities of an improved truncated kernel of width one.

Remark 6.22. We point out that we can relax the $\mathcal{C}^{\infty}$ requirement on the function $\psi$ in Proposition 6.21 in the following way. An examination of the arguments in Sections 6.6 and 6.8 and the proof just given shows that for any integer $m$ there exists an integer $M$, so that $\mathcal{K} * \psi$ and $\psi * \mathcal{K}$ satisfy the required differential inequalities and cancellation properties for orders of differentiation not exceeding $m$, if $\psi$ is supposed to be of class $\mathcal{C}^{M}$.

## 7. Convolution of flag kernels

Let $\mathcal{K} \in \mathcal{S}^{\prime}\left(\mathbb{R}^{N}\right)$ be a flag distribution on the homogeneous nilpotent Lie group $G=\mathbb{R}^{N}$, adapted to the standard flag associated with the decomposition $\mathbb{R}^{N}=$ $\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$. Define a left-invariant operator $T_{\mathcal{K}}: \mathcal{S}\left(\mathbb{R}^{N}\right) \rightarrow \mathcal{C}^{\infty}\left(\mathbb{R}^{N}\right)$ by setting

$$
T_{\mathcal{K}}[\phi](\mathbf{x})=\phi * \mathcal{K}(\mathbf{x})=\left\langle\mathcal{K}, \phi_{\mathbf{x}}^{\#}\right\rangle
$$

where, if $\phi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, we set $\phi_{\mathbf{x}}^{\#}(\mathbf{y})=\phi\left(\mathbf{x y}^{-1}\right)$. If $\mathcal{K}_{1}$ and $\mathcal{K}_{2}$ are two flag kernels on $G$, we want to make sense of the composition $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}$, and show that the resulting operator is of the form $T_{\mathcal{K}_{3}}$ where $\mathcal{K}_{3}$ is a third flag kernel on $G$. Now formally

$$
T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}[\phi]=\left(T_{\mathcal{K}_{1}}[\phi]\right) * \mathcal{K}_{2}=\left(\phi * \mathcal{K}_{1}\right) * \mathcal{K}_{2}=\phi *\left(\mathcal{K}_{1} * \mathcal{K}_{2}\right)
$$

so the operator $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}$ should be given by convolution with the distribution $\mathcal{K}_{1} * \mathcal{K}_{2}$. However we cannot directly define the composition $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}[\phi]=$ $T_{\mathcal{K}_{2}}\left(T_{\mathcal{K}_{1}}[\phi]\right)$, even if $\phi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, since $T_{\mathcal{K}_{1}}[\phi]$ need not belong to $\mathcal{S}\left(\mathbb{R}^{N}\right)$. Also, in general one cannot convolve an arbitrary pair of distributions unless one of them has compact support.

We will define the convolution $\mathcal{K}_{1} * \mathcal{K}_{2}$ somewhat indirectly. In Section 7.1 we show that if $\phi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, then $T_{\mathcal{K}}[\phi] \in L^{2}\left(\mathbb{R}^{N}\right)$ and the mapping $T_{\mathcal{K}}: \mathcal{S}\left(\mathbb{R}^{N}\right) \rightarrow$ $L^{2}\left(\mathbb{R}^{N}\right)$ has a (unique) continuous extension to a mapping of $L^{2}\left(\mathbb{R}^{N}\right)$ to itself. This allows us to define $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}$ as the composition of two mappings from $L^{2}\left(\mathbb{R}^{N}\right)$ to itself. Then in Section 7.2, we show that this composition is given by convolution with a distribution which is given as a sum of convolutions of dilates of bump functions. The key is then to recognize this sum as a flag kernel. The combinatorics are rather complicated, so in Section 7.3 we work out an explicit example. In Section 7.4 we prove the main result, Theorem 7.4 , which shows that the convolution of two flag kernels is a sum of flag kernels. Finally in Section 7.5 we work out some additional examples.

### 7.1. Boundedness on $L^{2}$

In this section we show that convolution with a flag kernel extends to a bounded operator on $L^{2}\left(\mathbb{R}^{N}\right)$. Later in Section 8 we will see more: such operators are bounded on $L^{p}\left(\mathbb{R}^{N}\right)$ for $1<p<\infty$.

Lemma 7.1. Let $\mathcal{K}$ be a flag kernel on $\mathbb{R}^{N}$. Then there is a constant $C$ so that if $T_{\mathcal{K}}[\phi]=\phi * \mathcal{K}$ for $\phi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$ then $\left\|T_{\mathcal{K}}[\phi]\right\|_{L^{2}\left(\mathbb{R}^{N}\right)} \leq C\|\phi\|_{L^{2}\left(\mathbb{R}^{N}\right)}$. As a consequence, there is a unique extension of $T_{\mathcal{K}}$ to a bounded operator from $L^{2}\left(\mathbb{R}^{N}\right)$ to itself.

Proof. Using Corollary 6.2, we can assume that $\mathcal{K}$ is a flag kernel adapted to a standard flag $\mathcal{F}$ of length $n$ as given in equation (2.4), and that there is a uniformly bounded family of functions $\left\{\varphi^{I}\right\} \subset \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, each having strong cancellation relative to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$ such that $\mathcal{K}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$ with convergence in the sense of distributions.

For any $I \in \mathcal{E}_{n}$, let $T_{I}[f]=T_{\varphi^{I}}[f]=f *\left[\varphi^{I}\right]_{I}$. Then $\left\|T_{I}[f]\right\|_{L^{2}} \leq\left\|\varphi^{I}\right\|_{L^{1}}\|f\|_{L^{2}}$. If $(f, g)=\int_{\mathbb{R}^{N}} f(\mathbf{x}) \overline{g(\mathbf{x})} d \mathbf{x}$ is the standard inner product in $L^{2}\left(\mathbb{R}^{N}\right)$, it follows from Fubini's theorem that $\left(T_{I}[f], g\right)=\left(f, \widetilde{T}_{I}[g]\right)$ where $T_{\widetilde{I}}[g]=g *\left[\widetilde{\varphi}^{I}\right]_{I}$ and $\widetilde{\varphi}^{I}(\mathbf{x})=\overline{\varphi^{I}\left(\mathbf{x}^{-1}\right)}$. Thus the Hilbert space adjoint of the operator $T_{\varphi^{I}}$ is the operator $T_{\varphi}^{*}=T_{\widetilde{\varphi}^{I}}$. Fubini's theorem also shows that $T_{I} \circ T_{J}^{*}=T_{\widetilde{\varphi}^{I} * \varphi^{J}}$ and $T_{J}^{*} \circ T_{I}=T_{\varphi^{I} * \widetilde{\varphi}^{J}}$. Thus if $I, J \in \mathcal{E}_{n}$, the $L^{2}$-norm of the operators $T_{I} \circ T_{J}^{*}$ and $T_{J}^{*} \circ T_{I}$ are bounded by the $L^{1}$ norms of $\left[\widetilde{\varphi}^{J}\right]_{J} *\left[\varphi^{I}\right]_{I}$ and $\left[\varphi^{I}\right]_{I} *\left[\widetilde{\varphi}^{J}\right]_{J}$. It follows from Corollary 6.19 that

$$
\begin{align*}
& \left\|[\tilde{\varphi}]_{J} *[\varphi]_{I}\right\|_{L^{1}\left(\mathbb{R}^{N}\right)}+\left\|[\varphi]_{I} *[\widetilde{\varphi}]_{J}\right\|_{L^{1}\left(\mathbb{R}^{N}\right)} \\
& \quad \leq C 2^{-\epsilon\left|i_{n}-j_{n}\right|} \prod_{\ell=1}^{n-1}\left[2^{-\epsilon\left|i_{\ell}-j_{\ell}\right|}+\min \left\{2^{-\epsilon\left(i_{\ell+1}-i_{\ell}\right)}, 2^{-\epsilon\left(j_{\ell+1}-j_{\ell}\right)}\right\}\right] \tag{7.1}
\end{align*}
$$

For any finite subset $F \subset \mathcal{E}_{n}$, set $\mathcal{K}_{F}(\mathbf{x})=\sum_{I \in F}\left[\varphi^{I}\right]_{I}(\mathbf{x})$. Then for any $\phi \in \mathcal{S}\left(\mathbb{R}^{N}\right),\langle\mathcal{K}, \phi\rangle=\lim _{F} \not \mathcal{E}_{n}\left\langle\mathcal{K}_{F}, \phi\right\rangle$, and in particular, if $\phi_{\mathbf{x}}^{\#}(\mathbf{y})=\phi\left(\mathbf{x y}^{-1}\right)$,
$T_{\mathcal{K}}[\phi](\mathbf{x})=\left\langle\mathcal{K}, \phi_{\mathbf{x}}^{\#}\right\rangle=\lim _{F \nearrow \mathcal{E}_{n}}\left\langle\mathcal{K}_{F}, \phi_{\mathbf{x}}^{\#}\right\rangle=\lim _{F \nearrow \mathcal{E}_{n}} \sum_{I \in F} \phi *\left[\varphi^{I}\right]_{I}(\mathbf{x})=\lim _{F \nearrow \mathcal{E}_{n}} \sum_{I \in F} T_{I}[\phi](\mathbf{x})$.
It follows from the almost orthogonality estimate in (7.1) and the Cotlar-Stein Theorem (see for example [11], page 280) that there is a constant $C$ independent of the finite set $F$ such that

$$
\left\|\sum_{I \in F} T_{\left[\varphi^{I}\right]_{I}}[\phi]\right\|_{L^{2}} \leq C\|\phi\|_{L^{2}}
$$

But then Fatou's lemma implies that $\left\|T_{\mathcal{K}}[\phi]\right\|_{L^{2}} \leq C\|\phi\|_{L^{2}}$ for all $\phi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. This completes the proof.

Corollary 7.2. Supposet that $\mathcal{K}$ is a flag kernel, and that $\mathcal{K}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$. Then for all $f \in L^{2}\left(\mathbb{R}^{N}\right)$,

$$
\lim _{F \nearrow \mathcal{E}_{n}}\left\|\sum_{I \in F} T_{[\varphi]_{I}}[f]-T_{\mathcal{K}}[f]\right\|_{L^{2}}=0
$$

Proof. Since $\mathcal{S}\left(\mathbb{R}^{N}\right)$ is dense in $L^{2}\left(\mathbb{R}^{N}\right)$, and since $T_{\mathcal{K}}$ is bounded on $L^{2}\left(\mathbb{R}^{N}\right)$, it suffices to show that $\lim _{K} \mathcal{E}_{n}\left\|\sum_{I \in F} T_{\left[\varphi^{I}\right]_{I}}[\psi]-T_{\mathcal{K}}[\psi]\right\|_{L^{2}}=0$ for $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. (Both $T_{\mathcal{K}}$ and $\sum_{I \in F} T_{\left[\varphi^{I}\right]_{I}}$ are bounded on $L^{2}\left(\mathbb{R}^{N}\right)$ with norm independent of $\left.F\right)$. But for $\psi \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, the result follows from Theorem 6.8 and the discussion following it on page 663 . This completes the proof.

### 7.2. Composition of convolution operators

Let $\mathcal{K}_{j}, j=1,2$, be two flag kernels on $\mathbb{R}^{N}$, and let $T_{\mathcal{K}_{j}}[\phi]=\phi * \mathcal{K}_{j}$ be the corresponding convolution operators. According to Lemma 7.1, each of these operators is bounded on $L^{2}\left(\mathbb{R}^{N}\right)$, and hence the composition $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}$ is well-defined as a bounded operator on $L^{2}\left(\mathbb{R}^{N}\right)$. Our main result is the following.

Theorem 7.3. Let $\mathcal{F}_{1}, \mathcal{F}_{2}$ be two standard flags on $\mathbb{R}^{N}$, and let $\mathcal{F}_{0}$ be the coarsest flag on $\mathbb{R}^{N}$ which is finer than both $\mathcal{F}_{1}$ and $\mathcal{F}_{2}$. For $j=1,2$, let $\mathcal{K}_{j}$ be a flag kernel adapted to the flag $\mathcal{F}_{j}$. Then $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}$ is a flag kernel adapted to the flag $\mathcal{F}_{0}$.

In order to study the composition $T_{\mathcal{K}_{2}} \circ T_{\mathcal{K}_{1}}$, we want to relate it to the decompositions of $\mathcal{K}_{1}$ and $\mathcal{K}_{2}$ as sums of dilates of normalized bump functions. According to Corollary 6.2, we can assume that the flags $\mathcal{F}_{1}$ and $\mathcal{F}_{2}$ are given by

$$
\begin{array}{ll}
\mathcal{F}_{1}: & (0) \subseteq \mathbb{R}^{a_{n}} \subseteq \mathbb{R}^{a_{n-1}} \oplus \mathbb{R}^{a_{n}} \subseteq \cdots \subseteq \mathbb{R}^{a_{2}} \oplus \cdots \oplus \mathbb{R}^{a_{n}} \subseteq \mathbb{R}^{N} \\
\mathcal{F}_{2}: & (0) \subseteq \mathbb{R}^{b_{m}} \subseteq \mathbb{R}^{b_{m-1}} \oplus \mathbb{R}^{b_{m}} \subseteq \cdots \subseteq \mathbb{R}^{b_{2}} \oplus \cdots \oplus \mathbb{R}^{b_{m}} \subseteq \mathbb{R}^{N}
\end{array}
$$

and the flag kernels are given by $\mathcal{K}_{1}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}$ and $\mathcal{K}_{2}=\sum_{J \in \mathcal{E}_{m}}\left[\psi^{J}\right]_{J}$, where $\left\{\varphi^{I} \mid I \in \mathcal{E}_{n}\right\}$ is a uniformly bounded family of compactly supported functions with with common support and strong cancellation relative to the flag $\mathcal{F}_{1}$, and $\left\{\psi^{J} \mid J \in \mathcal{E}_{m}\right\}$ is a uniformly bounded family of compactly supported functions with with common support and strong cancellation relative to the flag $\mathcal{F}_{2}$.

If $\phi, \theta \in \mathcal{S}\left(\mathbb{R}^{N}\right)$, then

$$
T_{\mathcal{K}_{1}}[\phi]=\lim _{F \nearrow \mathcal{E}_{n}} \sum_{I \in F} \phi *\left[\varphi^{I}\right]_{I} \quad \text { and } \quad T_{\mathcal{K}_{2}}[\theta]=\lim _{G \nearrow \mathcal{E}_{m}} \sum_{J \in G} \theta *\left[\psi^{J}\right]_{J},
$$

where the limits are in $L^{2}\left(\mathbb{R}^{N}\right)$ and are taken over finite subsets $F \subset \mathcal{E}_{n}$ and $G \subset \mathcal{E}_{m}$. For every fixed finite set $F \subset \mathcal{E}_{n}$, the function $\sum_{I \in F} \phi *\left[\varphi^{I}\right]_{I} \in \mathcal{S}\left(\mathbb{R}^{N}\right)$. Since $T_{\mathcal{K}_{2}}$ is a continuous mapping from $L^{2}\left(\mathbb{R}^{N}\right)$ to itself, it follows that

T_{\mathcal{K}_{2}}\left(T_{\mathcal{K}_{1}}[\phi]\right) & =\lim _{F \nearrow \mathcal{E}_{n}} T_{\mathcal{K}_{2}}\left(\sum_{I \in F} \phi *\left[\varphi^{I}\right]_{I}\right)=\lim _{F \nearrow \mathcal{E}_{n}} \lim _{G \nearrow \mathcal{E}_{m}} \sum_{I \in F} \sum_{J \in G} \phi *\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \\
& =\lim _{F \nearrow \mathcal{E}_{n}} \lim _{G \nearrow \mathcal{E}_{m}} \phi *\left[\sum_{I \in F} \sum_{J \in G}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}\right] .
\end{aligned}
$$

So in order to prove Theorem 7.3, we must study the finite sums $\sum_{I \in F} \sum_{J \in G}\left[\varphi^{I}\right]_{I}$ $*\left[\psi^{J}\right]_{J}$, and show that these converge in the sense of distributions to a finite sum of flag kernels, each adapted to a flag which is equal to or coarser than $\mathcal{F}_{0}$.

Since the general situation is rather complicated, we first present an example which may help understand the difficulties.

### 7.3. An example

Suppose that we are working in $\mathbb{R}^{5}$ with the family of dilations given by

\delta \cdot \mathbf{x}=\delta \cdot\left(x_{1}, x_{2}, x_{3}, x_{4}, x_{5}\right)=\left(\delta^{d_{1}} x_{1}, \delta^{d_{2}} x_{2}, \delta^{d_{3}} x_{3}, \delta^{d_{4}} x_{4}, \delta^{d_{5}} x_{5}\right) \tag{7.2}
\end{equation*}
$$

with $d_{1} \leq \cdots \leq d_{5}$. The standard flags on $\mathbb{R}^{5}$ correspond to partitions of $N=5$.

Consider two flags $\mathcal{F}_{1}$ and $\mathcal{F}_{2}$ corresponding to the partitions $\mathfrak{A}=(2,3)$, where we write $\mathbb{R}^{5}=\mathbb{R}^{2} \oplus \mathbb{R}^{3}$, and $\mathfrak{B}=(1,2,2)$, where we write $\mathbb{R}^{5}=\mathbb{R} \oplus \mathbb{R}^{2} \oplus \mathbb{R}^{2}$. Thus
$\mathcal{F}_{1}$ is the flag $(0) \subset\left\{x_{1}=x_{2}=0\right\} \cong \mathbb{R}^{3} \subset \mathbb{R}^{5}$,
$\mathcal{F}_{2}$ is the flag $(0) \subset\left\{x_{1}=x_{2}=x_{3}=0\right\} \cong \mathbb{R}^{2} \subset\left\{x_{1}=0\right\} \cong \mathbb{R}^{2} \oplus \mathbb{R}^{2} \subset \mathbb{R}^{5}$.
We are given flag kernels

$$
\mathcal{K}_{1}=\sum_{I \in \mathcal{E}_{2}}\left[\varphi^{I}\right]_{I} \quad \text { and } \quad \mathcal{K}_{2}=\sum_{J \in \mathcal{E}_{3}}\left[\psi^{J}\right]_{J}
$$

adapted to these two flags. We then want to study the infinite sum

$$
\begin{equation*}
\sum_{I \in \mathcal{E}_{2}} \sum_{J \in \mathcal{E}_{3}}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \tag{7.3}
\end{equation*}
$$

arising from the composition of the operators $T_{\mathcal{K}_{1}} \circ T_{\mathcal{K}_{2}}$.
Suppose $I=\left(i_{1}, i_{2}\right) \in \mathcal{E}_{2}$ and $J=\left(j_{1}, j_{2}, j_{3}\right) \in \mathcal{E}_{3}$, so that $i_{1} \leq i_{2}$, and $j_{1} \leq j_{2} \leq j_{3}$. If $\varphi^{I}, \psi^{J} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, we have

\begin{aligned}
& {\left[\varphi^{I}\right]_{I}(\mathbf{x})=2^{-i_{1}\left(d_{1}+d_{2}\right)-i_{2}\left(d_{3}+d_{4}+d_{5}\right)}} \\
& \quad \cdot \varphi^{I}\left(2^{-d_{1} i_{1}} x_{1}, 2^{-d_{2} i_{1}} x_{2}, 2^{-d_{3} i_{2}} x_{3}, 2^{-d_{4} i_{2}} x_{4}, 2^{-d_{5} i_{2}} x_{5}\right) \\
& {\left[\psi^{J}\right]_{J}(\mathbf{x})=2^{-j_{1} d_{1}-j_{2}\left(d_{2}+d_{3}\right)-j_{3}\left(d_{4}+d_{5}\right)}} \\
& \quad \cdot \psi^{J}\left(2^{-d_{1} j_{1}} x_{1}, 2^{-d_{2} j_{2}} x_{2}, 2^{-d_{3} j_{2}} x_{3}, 2^{-d_{4} j_{3}} x_{4}, 2^{-d_{5} j_{3}} x_{5}\right)
\end{aligned}
$$

Note that dilation by $I=\left(i_{1}, i_{2}\right)$ on $\mathbb{R}^{2} \oplus \mathbb{R}^{3}$ is the same as dilation by the 5 -tuple $\tilde{I}=\left(i_{1}, i_{1}, i_{2}, i_{2}, i_{2}\right)$ on $\mathbb{R}^{5}$, and dilation by $J=\left(j_{1}, j_{2}, j_{3}\right)$ on $\mathbb{R} \oplus \mathbb{R}^{2} \oplus \mathbb{R}^{2}$ is the same as dilation by the 5 -tuple $\tilde{J}=\left(j_{1}, j_{2}, j_{2}, j_{3}, j_{3}\right)$ on $\mathbb{R}^{5}$. Also note that we can reconstruct $I$ and $J$ from $\tilde{I}$ and $\tilde{J}$ by consolidating repeated indices. By Lemma 6.17, the convolution $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$ is equal to $\left[\theta^{I, J}\right]_{K}$ where $\theta^{I, J} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{5}\right)$, and where

$$
\begin{align*}
K & =\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right)=\tilde{I} \vee \tilde{J}=\left(i_{1}, i_{1}, i_{2}, i_{2}, i_{2}\right) \vee\left(j_{1}, j_{2}, j_{2}, j_{3}, j_{3}\right)  \tag{7.4}\\
& =\left(\max \left\{i_{1}, j_{1}\right\}, \max \left\{i_{1}, j_{2}\right\}, \max \left\{i_{2}, j_{2}\right\}, \max \left\{i_{2}, j_{3}\right\}, \max \left\{i_{2}, j_{3}\right\}\right) .
\end{align*}
$$

We must consider the sum in (7.3) of the convolutions $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$, taken over all $I \in \mathcal{E}_{2}$ and $J \in \mathcal{E}_{3}$. Each pair $(I, J) \in \mathcal{E}_{2} \times \mathcal{E}_{3}$ gives rise to a 5 -tuple $K \in \mathcal{E}_{5}$. However, not all elements of $\mathcal{E}_{5}$ actually arise in this sum. (For example, it is clear from (7.4) that we must have $k_{4}=k_{5}$, so the 5 -tuple ( $1,2,3,4,5$ ) does not arise). Let $\mathcal{E}(\mathfrak{A}, \mathfrak{B})$ denote the set of all 5 -tuples $K=\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{5}\right)$ that do arise as in (7.4). (The notation reflects the fact that this set of 5 -tuples is determined by the partitions $\mathfrak{A}=(2,3)$ and $\mathfrak{B}=(1,2,2)$ of $N=5)$. Then for each $K \in \mathcal{E}(\mathfrak{A}, \mathfrak{B})$, let $\mathcal{E}(K)$ denote the set of pairs $(I, J) \in \mathcal{E}_{2} \times \mathcal{E}_{3}$ which give rise to the 5 -tuple $K$. Once $K \in \mathcal{E}(\mathfrak{A}, \mathfrak{B})$ is fixed, each of the terms in the inner infinite sum on the right-hand side of (7.3) is the $K$ dilate of a normalized bump function $\theta^{I, J}$. Then we can write the sum in (7.3) as

\begin{equation*}
\sum_{I \in \mathcal{E}_{2}} \sum_{J \in \mathcal{E}_{3}}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}=\sum_{K \in \mathcal{E}(\mathfrak{A}, \mathfrak{B})} \sum_{I, J \in \mathcal{E}(K)}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}=\sum_{K \in \mathcal{E}(\mathfrak{A}, \mathfrak{B})} \sum_{I, J \in \mathcal{E}(K)}\left[\theta^{I, J}\right]_{K} . \tag{7.5}
\end{equation*}
$$

We will need to show that the infinite inner sum $\sum_{I, J \in \mathcal{E}(K)}\left[\theta^{I, J}\right]_{K}$ actually converges and is the $K$ dilate of a normalized bump function. However, this is not enough to give the right description of the sum in (7.3) as a flag kernel. In the outer sum on the right-hand side of (7.5), the 5 -tuple $K$ runs over $\mathcal{E}(\mathfrak{A}, \mathfrak{B})$ and not over all of $\mathcal{E}_{5}$. We still need to partition $\mathcal{E}(\mathfrak{A}, \mathfrak{B})$ into a finite number of subsets based on which indices in $K$ are repeated. To make this clear, we further analyze $\mathcal{E}(\mathfrak{A}, \mathfrak{B})$.

As one sees from (7.4), the 5-tuple $K=\tilde{I} \vee \tilde{J}$ depends not only on the tuples $I=\left\{i_{1}, i_{2}\right\}$ and $J=\left\{j_{1}, j_{2}, j_{3}\right\}$, but also on the ordering of the larger set consisting of $\left\{i_{1}, i_{2}, j_{1}, j_{2}, j_{3}\right\}$. We know that $i_{1} \leq i_{2}$ and $j_{1} \leq j_{2} \leq j_{3}$, but this does not determine the ordering of the larger set. Such orderings are in one-to-one correspondence with decompositions of the set $\{1,2,3,4,5\}$ into two disjoint subsets of sizes 2 and 3 , where elements of the first set are indices from $I$, and elements of the second set are indices from $J$. Thus there are $\binom{5}{2}=\binom{5}{3}=10$ such orderings. A description of these is given in the following Table 1:

Table 1. Decomposition of $\mathcal{E}(\mathfrak{A}, \mathfrak{B})$.

In the first column, we have given the decomposition of $\{1,2,3,4,5\}$ into two subsets, the first with two elements and the second with three. This then gives an ordering of the elements in the set $\left\{i_{1}, i_{2}, i_{3}, i_{4}, i_{5}\right\}$ which is given in the second column. The third column gives the value of the 5 -tuple $K=\tilde{I} \vee \tilde{J}$. In this tuple, certain entries can be repeated, and this corresponds to a new decomposition of $\mathbb{R}^{5}$. The fourth column gives this new decomposition of $\mathbb{R}^{5}$ dictated by the repeated indices of $K$. Finally, in each of the decompositions, certain of the indices from $I$ or $J$ appear in the 5 -tuple $K$. In the sixth column of Table 1, we list the 'free'variables which do not appear in $K$ are listed. It is precisely these free variables which appear in the inner sum on the right-hand side of equation (7.5).

Table 1 shows that if $K \in \mathcal{E}(\mathfrak{A}, \mathfrak{B})$, then $K$ takes one of five forms:

\left(k_{1}, k_{2}, k_{3}, k_{3}, k_{3}\right) & \text { (decomp. } 4 \text { and } 7 \text { ) } & \text { leading to the flag } \mathbb{R} \oplus \mathbb{R} \oplus \mathbb{R}^{3},  \tag{7.6}\\
\left(k_{1}, k_{1}, k_{2}, k_{3}, k_{3}\right) & \text { (decomp. 8) } & \text { leading to the flag } \mathbb{R}^{2} \oplus \mathbb{R} \oplus \mathbb{R}^{2}, \\
\left(k_{1}, k_{2}, k_{3}, k_{4}, k_{4}\right) & \text { (decomp. } 3 \text { and } 6) & \text { leading to the flag } \mathbb{R} \oplus \mathbb{R} \oplus \mathbb{R} \oplus \mathbb{R}^{2} .
\end{array}
$$

The outer sum on the right-hand side of (7.5) thus splits into five separate sums:

\sum_{I \in \mathcal{E}_{2}} & \sum_{J \in \mathcal{E}_{3}}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \\
= & \sum_{K \in \mathcal{E}_{9} \cup \mathcal{E}_{10}} \sum_{I, J \in \widetilde{\mathcal{E}}(K)}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}+\sum_{K \in \mathcal{E}_{1} \cup \mathcal{E}_{2} \cup \mathcal{E}_{5}} \sum_{I, J \in \widetilde{\mathcal{E}}(K)}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \\
& +\sum_{K \in \mathcal{E}_{4} \cup \mathcal{E}_{7}} \sum_{I, J \in \widetilde{\mathcal{E}}(K)}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}+\sum_{K \in E_{8}} \sum_{I, J \in \widetilde{\mathcal{E}}(K)}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \\
& \quad+\sum_{K \in E_{3} \cup E_{6}} \sum_{I, J \in \widetilde{\mathcal{E}}(K)}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}
\end{aligned}
$$

Our object is to show that these five sums are flag kernels, each adapted to one of the five flags listed on the right-hand side of (7.6). To see this, we must show that in each case, the inner infinite sum converges, and has weak cancellation. Let us see why this happens in one case.

Case 1: $K \in E_{9} \cup E_{10}$.
In this case, $K=\left\{i_{1}, i_{1}, i_{2}, i_{2}, i_{2}\right\}$ is fixed, and the inner sum $\sum_{I, J \in \widetilde{\mathcal{E}}(K)}\left[\varphi^{I}\right]_{I} *$ $\left[\psi^{J}\right]_{J}$ is over the free variables $\left\{j_{1}, j_{2}, j_{3}\right\}$ which satisfy the inequalities

j_{1} \leq j_{2}<i_{1} \leq j_{3}<i_{2} \quad \text { or } \quad j_{1} \leq j_{2} \leq j_{3}<i_{1} \leq i_{2}
$$

In order to apply Theorem 6.8, we need to check that the sum converges to the $K$-dilate of a normalized bump function $\theta^{I, J}$, and moreover that $\theta^{I, J}$ has weak cancellation relative to the decomposition $\mathbb{R}^{2} \oplus \mathbb{R}^{3}$.

To show that the sum over the free variables $\left\{j_{1}, j_{2}, j_{3}\right\}$ converges, we want to show that each term in the sum can be bounded by $2^{-\epsilon\left[\left(l_{1}-j_{1}\right)+\left(l_{2}-j_{2}\right)+\left(l_{3}-j_{3}\right)\right]}$ where $l_{1}, l_{2}, l_{3} \in\left\{i_{2}, i_{2}\right\}$, and $j_{1} \leq l_{1}, j_{2} \leq l_{2}$, and $j_{3} \leq l_{3}$. This will follow because, by hypothesis, $\psi^{J}$ has strong cancellation relative to the decomposition $\mathbb{R} \oplus \mathbb{R}^{2} \oplus \mathbb{R}^{2}$. Thus $\psi^{J}$ has cancellation in $x_{1}$, in either $x_{2}$ or $x_{3}$, and in either $x_{4}$ or $x_{5}$. In the variable $x_{1}, j_{1}<i_{1}$, and so by Lemma 6.18, we get a gain of $2^{-\epsilon\left|i_{1}-j_{1}\right|} \leq 2^{-\epsilon\left|i_{1}-j_{2}\right|}$. If there is cancellation in $x_{2}$, we have $j_{2}<i_{1}$, so we get a gain of $2^{-\epsilon\left|i_{1}-j_{2}\right|}$, while if there is cancellation in $x_{3}$, we have $j_{3} \leq i_{2}$ and so we get a gain of $2^{-\epsilon\left|i_{2}-j_{3}\right|}$. Finally, if there is cancellation in $x_{4}$ or $x_{5}$, we have $j_{3}<i_{2}$, and so we get a gain of $2^{-\epsilon\left|i_{2}-j_{3}\right|}$. Taking the best of these estimates, we see that the size of $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$ is dominated by a constant times $2^{-\epsilon\left[\left|i_{1}-j_{1}\right|+\left|i_{1}-j_{2}\right|+\left|i_{2}-j_{3}\right|\right]}$. Thus in this case we can take $l_{1}=i_{1}, l_{2}=i_{1}$, and $l_{3}=i_{2}$.

The key points in this convergence argument are the following:
(a) If $f_{s}$ is a free variable, it does not appear in $K$. Since the entries $k_{s} \in K$ are the maxima of the corresponding entries of $i_{s} \in \tilde{I}$ and $j_{s} \in \tilde{J}$, the free variable must satisfy $f_{s} \leq k_{s}$.
(b) Since we will sum over the free variable $f_{s}$, but the variable $k_{s} \in K$ is fixed, it suffices to show that there is a gain $2^{-\epsilon\left(k_{s}-f_{s}\right)}$.
(c) The function $\varphi^{I}$ or $\psi^{J}$ with the free variable $f_{s}$ may not necessarily have cancellation in the variable $x_{s}$. (For example, the free variable $j_{2}$ comes from the function $\psi^{\left(j_{1}, j_{2}, j_{2}, j_{3}, j_{3}\right)}$, and we only know that this function has cancellation in the variable $x_{2}$ or the variable $x_{3}$ ). However, if there is no cancellation in the free variable, there is a smaller free variable where there is cancellation, and where the corresponding element of $K$ is the same. (In our example, $\psi^{\left(j_{2}, j_{2}, j_{3}\right)}$ has cancellation in $x_{1}$, and $k_{1}=k_{2}$ ).
To see that the sum of the terms $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$ has weak cancellation relative to the decomposition $\mathbb{R}^{2} \oplus \mathbb{R}^{3}$, we again use Lemma 6.18 . We only need to observe that either $\varphi^{I}$ or $\psi^{J}$ has cancellation in one of the variables $\left\{x_{1}, x_{2}\right\}$, and also that either $\varphi^{I}$ or $\psi^{J}$ has cancellation in one of the variables $\left\{x_{3}, x_{4}, x_{5}\right\}$. But this is clear: for example, $\psi^{J}$ has strong cancellation relative to the decomposition $\mathbb{R} \oplus$ $\mathbb{R}^{2} \oplus \mathbb{R}^{2}$, and so has cancellation in $x_{1}$, and $\varphi^{I}$ has strong cancellation relative to the decomposition $\mathbb{R}^{2} \oplus \mathbb{R}^{3}$, and so has cancellation in one of the variables $\left\{x_{3}, x_{4}, x_{5}\right\}$.

### 7.4. The general decomposition

Now let us return to the general situation. Suppose $\mathcal{F}_{1}$ and $\mathcal{F}_{2}$ are standard flags arising from two (in general different) decompositions we label as ( $\mathfrak{A}$ ) and ( $\mathfrak{B}$ ):

\begin{array}{ll}
(\mathfrak{A}): & \mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}} \\
(\mathfrak{B}): & \mathbb{R}^{N}=\mathbb{R}^{b_{1}} \oplus \cdots \oplus \mathbb{R}^{b_{m}}
\end{array}
$$

Let $\mathcal{K}_{1}$ and $\mathcal{K}_{2}$ be flag kernels adapted to the flags $\mathcal{F}_{1}$ and $\mathcal{F}_{2}$. We only need to consider the parts of these kernels given by sums of dilates of normalized bump functions with strong cancellation. (That is, for each kernel we focus on the part called $\mathcal{K}_{0}$ in Theorem 6.1 and disregard the other terms since they correspond to coarser flags). Thus we can write

$$
\begin{equation*}
\mathcal{K}_{1}=\sum_{I \in \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}, \quad \mathcal{K}_{2}=\sum_{J \in \mathcal{E}_{m}}\left[\psi^{J}\right]_{J}, \tag{7.7}
\end{equation*}
$$

where each $\varphi^{I}$ has strong cancellation relative to the decomposition $\mathfrak{A}$ and each $\psi^{J}$ has strong cancellation relative to the decomposition $\mathfrak{B}$. Let

$$
\mathcal{K}_{1}^{F}=\sum_{I \in F \subset \mathcal{E}_{n}}\left[\varphi^{I}\right]_{I}, \quad \mathcal{K}_{2}^{G}=\sum_{J \in G \subset \mathcal{E}_{m}}\left[\psi^{J}\right]_{J},
$$

where $F \subset \mathcal{E}_{n}$ and $G \subset \mathcal{E}_{m}$ are finite subsets. We study the double sum

$$
\begin{equation*}
\mathcal{K}_{1}^{F} * \mathcal{K}_{2}^{G}=\sum_{I \in F \subset \mathcal{E}_{n}} \sum_{J \in G \subset \in \mathcal{E}_{m}}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J} \tag{7.8}
\end{equation*}
$$

Let $\mathcal{F}_{0}$ be the coarsest flag which is finer than both $\mathcal{F}_{1}$ and $F_{2}$.
Theorem 7.4. Let $\mathcal{K}_{1}$ and $\mathcal{K}_{2}$ be the flag kernels given in (7.7). Then

$$
\lim _{\substack{F \\ G \mathcal{C} \mathcal{E}_{m}}} \mathcal{K}_{1}^{F} * \mathcal{K}_{2}^{G}=\mathcal{K}_{1} * \mathcal{K}_{2}
$$

converges in the sense of distributions to a finite sum of flag kernels $\sum \mathcal{K}_{\mu}$, each of which is adapted to a flag $\mathcal{F}_{\mu}$ which is equal to or coarser than the flag $\mathcal{F}_{0}$.

Before outlining the proof, we review our notation. If $\mathbf{x} \in \mathbb{R}^{N}$, we can write $\mathbf{x}=\left(\mathbf{x}_{1}^{\prime}, \ldots, \mathbf{x}_{n}^{\prime}\right)$ with $\mathbf{x}_{j}^{\prime}=\left(x_{p_{j}^{\prime}}, \ldots, x_{q_{j}^{\prime}}\right) \in \mathbb{R}^{a_{j}}$, or $\mathbf{x}=\left(\mathbf{x}_{1}^{\prime \prime}, \ldots, \mathbf{x}_{m}^{\prime \prime}\right)$ with $\mathbf{x}_{k}^{\prime \prime}=$ $\left(x_{p_{k}^{\prime \prime}}, \ldots, x_{q_{k}^{\prime \prime}}\right) \in \mathbb{R}^{b_{k}}$. We let $J_{j}^{\prime}=\left\{p_{j}^{\prime}, \ldots, q_{j}^{\prime}\right\}$ and $J_{k}^{\prime \prime}=\left\{p_{k}^{\prime \prime}, \ldots, q_{k}^{\prime \prime}\right\}$ so that $\{1, \ldots, N\}=\bigcup_{j=1}^{n} J_{j}^{\prime}=\bigcup_{k=1}^{m} J_{k}^{\prime \prime}$. Define

$$
\begin{array}{lll}
\sigma_{\mathfrak{A}}:\{1, \ldots, N\} \rightarrow\{1, \ldots, n\} & \text { so that } & l \in J_{\sigma_{\mathfrak{H}}(l)}^{\prime} \text { for } 1 \leq l \leq N ; \\
\tau_{\mathfrak{B}}:\{1, \ldots, N\} \rightarrow\{1, \ldots, m\} & \text { so that } & l \in J_{\sigma_{\mathfrak{B}}(l)}^{\prime \prime} \text { for } 1 \leq l \leq N .
\end{array}
$$

If $Q_{j}^{\prime}$ is the homogeneous dimension of $\mathbb{R}^{a_{j}}$ and $Q_{k}^{\prime \prime}$ is the homogeneous dimension of $\mathbb{R}^{b_{k}}$, then

$$
Q_{j}^{\prime}=d_{p_{j}^{\prime}}+\cdots+d_{q_{j}^{\prime}}=\sum_{l \in J_{j}^{\prime}} d_{l}, \quad Q_{k}^{\prime \prime}=d_{p_{k}^{\prime \prime}}+\cdots+d_{q_{k}^{\prime \prime}}=\sum_{l \in J_{k}^{\prime \prime}} d_{l} .
$$

If $I \in \mathcal{E}_{n}$ and $J \in \mathcal{E}_{m}$, the notation $\left[\varphi^{I}\right]_{I}$ and $\left[\psi^{J}\right]_{J}$ refers to the families of dilations

$$
\begin{aligned}
& {\left[\varphi^{I}\right](\mathbf{x})=2^{-\left[Q_{1}^{\prime} i_{1}+\cdots+Q_{n}^{\prime} i_{n}\right]} \varphi\left(2^{-i_{1}} \cdot \mathbf{x}_{1}^{\prime}, \ldots, 2^{-i_{n}} \cdot \mathbf{x}_{n}^{\prime}\right),} \\
& {\left[\psi^{J}\right](\mathbf{x})=2^{-\left[Q_{1}^{\prime \prime} j_{1}+\cdots+Q_{m}^{\prime \prime} j_{m}\right]} \varphi\left(2^{-j_{1}} \cdot \mathbf{x}_{1}^{\prime \prime}, \ldots, 2^{-j_{m}} \cdot \mathbf{x}_{m}^{\prime \prime}\right) .}
\end{aligned}
$$

In order to compare multi-indices $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n}$ and $J=\left(j_{1}, \ldots, j_{m}\right) \in$ $\mathcal{E}_{m}$ which parameterize different families of dilations, we identify them with multiindices of length $N$ with repeated entries. Thus we define $p_{\mathfrak{A}}: \mathcal{E}_{n} \rightarrow E_{N}$ and $p_{\mathfrak{B}}: \mathcal{E}_{m} \rightarrow E_{N}$ so that $p_{\mathfrak{A}}(I)$ is the $N$-tuple with $i_{1}$ repeated $a_{1}$ times, $i_{2}$ repeated $a_{2}$ times, etc. We define $p_{\mathfrak{B}}$ analogously. Thus
$p_{\mathfrak{A}}(I)=I=\left(I_{1}, \ldots, I_{N}\right)=(\overbrace{i_{1}, \ldots \ldots \ldots, i_{1}}^{a_{1}}, \ldots, \overbrace{i_{r}, \ldots, i_{r}}^{a_{r}}, \ldots \ldots \ldots, \overbrace{i_{n}, \ldots, i_{n}}^{a_{n}})$,
$p_{\mathfrak{B}}(J)=J=\left(J_{1}, \ldots, J_{N}\right)=(\overbrace{j_{1}, \ldots, j_{1}}^{b_{1}}, \ldots \ldots, \overbrace{j_{s}, \ldots \ldots, j_{s}}^{b_{s}}, \ldots, \overbrace{j_{m}, \ldots \ldots, j_{m}}^{b_{m}})$.
Explicitly, $p_{\mathfrak{A}}(I)=\left(I_{1}, \ldots, I_{N}\right)$ and $p_{\mathfrak{B}}(J)=\left(J_{1}, \ldots, J_{N}\right)$ where $I_{l}=i_{\sigma(l)}$ and $J_{l}=j_{\tau(l)}$. Next set $K=\left(K_{1}, \ldots, K_{N}\right)=p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J)=\left(k_{1}, \ldots, k_{N}\right)$. This means that for $1 \leq l \leq N$

K_{l}=i_{\sigma(l)} \vee j_{\tau(l)}=\max \left\{i_{\sigma(l)}, j_{\tau(l)}\right\}= \begin{cases}j_{\tau(l)} & \text { if } i_{\sigma(l)} \leq j_{\tau(l)}  \tag{7.9}\\ i_{\sigma(l)} & \text { if } j_{\tau(l)}<i_{\sigma(l)}\end{cases}
$$

Note that we can then define a map $\pi_{I, J}:\{1, \ldots, N\} \rightarrow\{1, \ldots, n, n+1, \ldots, n+m\}$ so that

\pi_{I, J}(l)= \begin{cases}\ell \in\{1, \ldots n\} & \text { if } K_{l}=i_{\sigma(\ell)}  \tag{7.10}\\ n+\ell \in\{n+1, \ldots, n+m\} & \text { if } K_{l}=j_{\tau(\ell)}\end{cases}
$$

Now let us outline the proof of Theorem 7.4. For each $I \in \mathcal{E}_{n}$ and $J \in \mathcal{E}_{m}$ it follows from Lemma 6.17 that there is a function $\theta^{I, J} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, normalized relative to $\varphi^{I}$ and $\psi^{J}$, so that

\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}=\left[\theta^{I, J}\right]_{p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J)} \tag{7.11}
\end{equation*}

and hence equation (7.8) can be written

$$
\begin{equation*}
\mathcal{K}_{1}^{F} * \mathcal{K}_{2}^{G}=\sum_{(I, J) \in F \times G \subset \mathcal{E}_{n} \times \mathcal{E}_{m}}\left[\theta^{I, J}\right]_{p_{\mathfrak{H}}(I) \vee p_{\mathfrak{B}}(J)} \tag{7.12}
\end{equation*}
$$

We analyze this sum by decomposing the set $\mathcal{E}_{n} \times \mathcal{E}_{m}$ into disjoint subsets. Let $\mathfrak{P}(n, m)$ denote the set of permutations $\mu:\{1, \ldots, n, n+1, \ldots, n+m\} \rightarrow\{1, \ldots, n$, $n+1, \ldots, n+m\}$ which preserve the order of the first $n$ elements $\{1, \ldots, n\}$ and of the last $m$ elements $\{n+1, \ldots, n+m\}$. (Explicitly, this means that if $\mu \in \mathfrak{P}(n, m)$, then $1 \leq s<t \leq n$ implies $\mu(s)<\mu(t)$ and $n+1 \leq s<t \leq n+m$ implies $\mu(s)<$ $\mu(t))$. This corresponds to the ten cases in the example studied in Section 7.3. The cardinality of $\mathfrak{P}(n, m)$ is $\binom{n+m}{n}$. Let $I \in \mathcal{E}_{n}$ and $J \in \mathcal{E}_{m}$, and let us write

$$
\begin{array}{r}
I=\left(\alpha_{1}, \ldots, \alpha_{n}\right) \quad \text { and } \quad J=\left(\alpha_{n+1}, \ldots, \alpha_{n+m}\right), \quad \text { so that } \\
\alpha_{1} \leq \alpha_{2} \leq \cdots \leq \alpha_{n} \quad \text { and } \quad \alpha_{n+1} \leq \alpha_{n+2} \leq \cdots \leq \alpha_{n+m} .
\end{array}
$$

Then let $L(I, J)$ be the (weakly) increasing rearrangement of the set $I \cup J=$ $\left\{\alpha_{1}, \ldots, \alpha_{n+m}\right\}$ so that
if $1 \leq r<s \leq n \quad$ then $\alpha_{r}$ comes to the left of $\alpha_{s}$,
if $n+1 \leq r<s \leq n+m \quad$ then $\alpha_{r}$ comes to the left of $\alpha_{s}$, if $1 \leq r \leq n, n+1 \leq s \leq n+m$ and $\alpha_{r}<\alpha_{s}$ then $\alpha_{r}$ comes to the left of $\alpha_{s}$, if $1 \leq r \leq n, n+1 \leq s \leq n+m$ and $\alpha_{s} \leq \alpha_{r}$ then $\alpha_{s}$ comes to the left of $\alpha_{r}$.

This rearrangement of $\left\{\alpha_{1}, \ldots, \alpha_{n+m}\right\}$ is given by $L(I, J)=\left\{\alpha_{\mu(1)}, \ldots, \alpha_{\mu(n+m)}\right\}$ where $\mu$ is a permutation of the set of subscripts $\{1, \ldots, n, n+1, \ldots, n+m\}$, and it follows from (7.13) that $\mu \in \mathfrak{P}(n, m)$. In this way we associate to each pair $(I, J) \in \mathcal{E}_{n} \times \mathcal{E}_{m}$ a unique $\mu=\mu(I, J) \in \mathfrak{P}(n, m)$. Conversely, for each $\mu \in \mathfrak{P}(n, m)$, let

$$
\begin{equation*}
\mathcal{E}_{n, m}(\mu)=\left\{(I, J) \in \mathcal{E}_{n} \times \mathcal{E}_{m} \mid L(I, J)=\left\{\alpha_{\mu(1)}, \ldots, \alpha_{\mu(n+m)}\right\}\right\} \tag{7.14}
\end{equation*}
$$

It follows that we have a disjoint decomposition $\mathcal{E}_{n} \times \mathcal{E}_{m}=\bigcup_{\mu \in \mathfrak{P}(m, n)} \mathcal{E}_{n, m}(\mu)$, and we can write equation (7.8) as

$$
\begin{equation*}
\mathcal{K}_{1}^{F} * \mathcal{K}_{2}^{G}=\sum_{\mu \in \mathfrak{P}(m, n)}\left(\sum_{(I, J) \in \mathcal{E}_{n, m}(\mu) \cap(F \times G)}\left[\theta^{I, J}\right]_{p_{\mathfrak{H}}(I) \vee p_{\mathfrak{B}}(J)}\right) . \tag{7.15}
\end{equation*}
$$

Now let

$$
\begin{equation*}
E_{N}(\mu)=\left\{K \in E_{N} \mid K=p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J) \text { where }(I, J) \in \mathcal{E}_{n, m}(\mu)\right\} . \tag{7.16}
\end{equation*}
$$

Note that in general $E_{N}(\mu)$ is a proper subset of $E_{N}$, and an element $K \in E_{N}(\mu)$ can be represented in many ways as $p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J)$ with $(I, J) \in \mathcal{E}_{n, m}(\mu)$. We can then rewrite (7.15) as

\begin{align*}
\mathcal{K}_{1}^{F} * \mathcal{K}_{2}^{G} & =\sum_{\mu \in \mathfrak{P}(m, n)}\left(\sum_{K \in E_{N}(\mu)}\left(\sum_{\substack{(I, J) \in \mathcal{E}_{n, m}(\mu) \cap(F \times G) \\
p_{\mathfrak{H}}(I) \vee p_{\mathfrak{B}}(J)=K}}\left[\theta^{I, J}\right]_{K}\right)\right) \\
& =\sum_{\mu \in \mathfrak{P}(m, n)}\left(\sum_{K \in E_{N}(\mu)}\left[\sum_{\substack{(I, J) \in \mathcal{E}_{n, m}(\mu) \cap(F \times G) \\
p_{\mathfrak{H}}(I) \vee p_{\mathfrak{B}}(J)=K}} \theta^{I, J}\right]_{K}\right) \tag{7.17}
\end{align*}
$$

We will prove in Lemma 7.8 below that because the functions $\left\{\varphi^{I}\right\}$ and $\left\{\psi^{J}\right\}$ have strong cancellation, the innermost sum

$$
\begin{equation*}
\sum_{\substack{(I, J) \in \mathcal{E}_{n, m}(\mu) \\ p_{\mathfrak{H}}(I) \vee p_{\mathfrak{B}}(J)=K}} \theta^{I, J}=\lim _{\substack{F \nearrow \mathcal{E}_{n} \\ G \nearrow \mathcal{E}_{m}}} \sum_{\substack{(I, J) \in \mathcal{E}_{n, m}(\mu) \cap(F \times G) \\ p_{\mathfrak{H}}(I) \vee p_{\mathfrak{B}}(J)=K}} \theta^{I, J} \tag{7.18}
\end{equation*}
$$

converges to a function $\Theta^{K} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ which is normalized relative to the families $\left\{\varphi^{I}\right\}$ and $\left\{\psi^{j}\right\}$. From this it follows from (7.17) that

$$
\begin{equation*}
\mathcal{K}_{1} * \mathcal{K}_{2}=\lim _{\substack{F \\ G \nearrow \mathcal{E}_{n} \\ G}} \mathcal{K}_{1}^{F} * \mathcal{K}_{2}^{G}=\sum_{\mu \in \mathfrak{P}(n, m)}\left(\sum_{K \in E_{N}(\mu)}\left[\Theta^{K}\right]_{K}\right) \tag{7.19}
\end{equation*}
$$

We will also see in Lemma 7.8 below that for each fixed $\mu$, the functions $\left\{\Theta^{K}\right\}$ for $K \in E_{N}(\mu)$ have weak cancellation relative to a decomposition of $\mathbb{R}^{N}$ depending on $\mu, \mathbb{R}^{N}=\mathbb{R}^{c_{1}} \oplus \cdots \oplus \mathbb{R}^{c_{r}}$, and hence the inner sum on the right hand side of (7.19) is a flag kernel relative to the corresponding standard flag $\mathcal{F}_{\mu}$. Once this is done, we will have established Theorem 7.4.

We now turn to the details of the proof. We begin by studying the $N$-tuple $K=\left(K_{1}, \ldots, K_{N}\right)=p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J)$ if $(I, J) \in \mathcal{E}_{n, m}(\mu)$. Partition $K$ into disjoint subsets of consecutive entries where two successive elements $K_{l}$ and $K_{l+1}$ belong to the same subset if and only if either
(i) $K_{l}=i_{\sigma(l)} \geq j_{\tau(l)}, K_{l+1}=i_{\sigma(l+1)} \geq j_{\tau(l+1)}$, and $\sigma(l)=\sigma(l+1) ; \quad$ or
(ii) $K_{l}=j_{\tau(l)} \geq i_{\sigma(l)}, K_{l+1}=j_{\tau(l+1)} \geq i_{\sigma(l+1)}$, and $\tau(l)=\tau(l+1)$.

In particular, if two successive elements $K_{l}$ and $K_{l+1}$ belong to the same subset, they must be equal. Thus we write

$$
K=\left(K_{1}, \ldots, K_{N}\right)=\left(\left\{K_{\alpha_{1}}, \ldots, K_{\beta_{1}}\right\},\left\{K_{\alpha_{2}}, \ldots, K_{\beta_{2}}\right\}, \ldots,\left\{K_{\alpha_{r}}, \ldots, K_{\beta_{r}}\right\}\right)
$$

where

$$
\begin{aligned}
& K_{\alpha_{1}}=K_{\alpha_{1}+1}=\cdots=K_{\beta_{1}} \\
& K_{\alpha_{2}}=K_{\alpha_{2}+1}=\cdots=K_{\beta_{2}} \\
& \quad \vdots \\
& \\
& K_{\alpha_{r}}=K_{\alpha_{r}+1}=\cdots=K_{\beta_{r}}
\end{aligned}
$$

We can also write

$$
\begin{equation*}
K=\left(K_{1}, \ldots, K_{N}\right)=(\overbrace{k_{1}, \ldots, k_{1}}^{c_{1}} ; \overbrace{k_{2}, \ldots, k_{2}}^{c_{2}} ; \ldots ; \overbrace{k_{r}, \ldots, k_{r}}^{c_{r}}), \tag{7.20}
\end{equation*}
$$

so that $c_{1}+c_{2}+\cdots+c_{r}=N$. Note that $1 \leq r<m+n$ since either $i_{1}$ or $j_{1}$ does not appear in $K$. We have the following properties of this decomposition:

Proposition 7.5. The integers $\left\{\alpha_{1}, \beta_{1}, \ldots, \alpha_{r}, \beta_{r}\right\}$ depend only on the permutation $\mu$ and are independent of the choice of $(I, J) \in \mathcal{E}_{n, m}(\mu)$. In fact, let $\widetilde{K}_{l}=$ $\left\{K_{\alpha_{l}}, \ldots, K_{\beta_{l}}\right\}$ be one of the subsets of consecutive indices in $K=p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J) \in$ $\mathcal{E}_{n, m}(\mu)$. Then:
(1) The starting position $\alpha_{l}$ coincides either with the starting position of one of the subsets of $p_{\mathfrak{A}}(I)$ or with the position of one of the subsets of $p_{\mathfrak{B}}(J)$. More precisely, for $l \geq 2$,
(1a) If $K_{\alpha_{l}}=i_{\sigma\left(\alpha_{l}\right)}$, then $\sigma\left(\alpha_{l}\right)>\sigma\left(\alpha_{l}-1\right)$, so the start of $\widetilde{K}_{l}$ coincides with the start of the index $i_{\sigma\left(\alpha_{l}\right)}$ in $p_{\mathfrak{A}}(I)$.
(1b) If $K_{\alpha_{l}}=j_{\tau\left(\alpha_{l}\right)}$, then $\tau\left(\alpha_{l}\right)>\tau\left(\alpha_{l}-1\right)$, so the start of $\widetilde{K}_{l}$ coincides with the start of the index $j_{\tau\left(\alpha_{l}\right)}$ in $p_{\mathfrak{B}}(J)$.
(2) If the ending position of $\widetilde{K}_{l}$ does not coincide with the end of the corresponding segment of $p_{\mathfrak{A}}(I)$ or $p_{\mathfrak{B}}(J)$, the entries of the segment which do not appear in $\widetilde{K}_{l}$ are bounded above by the corresponding entries of $K$. More precisely, for $\gamma \leq N$,
(2a) Suppose that $K_{\alpha_{l}}=i_{\sigma\left(\alpha_{l}\right)}$, so that $K_{t}=i_{\sigma\left(\alpha_{l}\right)}$ for $\alpha_{l} \leq t \leq \beta_{l}$. Suppose that $I_{t}=I_{\alpha_{l}}$ for $\alpha_{l} \leq t \leq \gamma$ and that $\gamma>\beta_{l}$. Then $I_{t} \leq J_{t}=K_{t}$ for $\beta_{l}+1 \leq t \leq \gamma$.
(2b) Suppose that $K_{\alpha_{l}}=j_{\tau\left(\alpha_{l}\right)}$, so that $K_{t}=j_{\tau\left(\alpha_{l}\right)}$ for $\alpha_{l} \leq t \leq \beta_{l}$. Suppose that $J_{t}=J_{\alpha_{l}}$ for $\alpha_{l} \leq t \leq \gamma$ and that $\gamma>\beta_{l}$. Then $J_{t} \leq I_{t}=K_{t}$ for $\beta_{l}+1 \leq t \leq \gamma$.

Proof. We begin by establishing part (1a). If it were not true, then since $j_{\tau\left(\alpha_{l}-1\right)} \leq$ $j_{\tau\left(\alpha_{l}\right)}$, we would have

$$
j_{\tau\left(\alpha_{l}-1\right)} \leq j_{\tau\left(\alpha_{l}\right)} \leq i_{\sigma\left(\alpha_{l}\right)}=i_{\sigma\left(\alpha_{l}-1\right)}
$$

and by condition (i) in the definition of $\widetilde{K}_{l}$ it would follow that $K_{\alpha_{l}}$ and $K_{\alpha_{l}-1}$ belong to the same subset. Part (1b) follows in the same way. To establish part (2a), observe that since $J_{\beta_{l}+1} \leq J_{t}$, it suffices to show this for $t=\beta_{l}+1$. However, if $J_{\beta_{l}+1}<I_{\beta_{l}+1}$, it would follow from (i) that $K_{\beta_{l}+1}$ belongs to the same subset as $K_{\alpha_{l}}$. Part (2b) follows in the same way.

Now parts (1) and (2) show that the positions where we decompose $K$ depend on the ordering of the entries of $p_{\mathfrak{A}}(I)$ and $p_{\mathfrak{B}}(J)$, and not on the entries themselves. This shows that the decomposition depends only on $\mu$, completing the proof.

Definition 7.6. Let $\mu \in \mathfrak{P}(n, m)$.
(1) It follows from Proposition 7.5 that the permutation $\mu$ determines $r$ and the integers $\left\{c_{1}, \ldots, c_{r}\right\}$. Thus $\mu$ determines the decomposition $\mathbb{R}^{N}=\mathbb{R}^{c_{1}} \oplus \cdots \oplus$ $\mathbb{R}^{c_{r}}$. We let $\mathcal{F}_{\mu}$ denote the corresponding standard flag ( 0 ) $\subseteq \mathbb{R}^{c_{r}} \subseteq \mathbb{R}^{c_{r-1}} \oplus$ $\mathbb{R}^{c_{r}} \subseteq \cdots \subseteq \mathbb{R}^{c_{2}} \oplus \cdots \oplus \mathbb{R}^{c_{n}} \subseteq \mathbb{R}^{c_{1}} \oplus \cdots \oplus \mathbb{R}^{c_{r}}=\mathbb{R}^{N}$. For $\mathbf{x} \in \mathbb{R}^{N}$, we write $\mathbf{x}=\left(\widetilde{\mathbf{x}}_{1}, \ldots, \widetilde{\mathbf{x}}_{r}\right)$, and we let $\left\{\widetilde{J}_{1}, \ldots, \widetilde{J}_{r}\right\}$ denote the corresponding sets of subscripts so that $x_{l}$ is a coordinate in $\mathbb{R}^{c_{k}}$ if and only if $l \in \widetilde{J}_{k}$.
(2) Let $I=\left(i_{1}, \ldots, i_{n}\right), J=\left(j_{1}, \ldots, j_{m}\right) \in \mathcal{E}_{n, m}(\mu)$. An index $i_{l}$ is free if $I_{t} \leq J_{t}$ for all $t$ such that $\sigma(t)=l$. An index $j_{l}$ is free if $J_{t}<I_{t}$ for all $t$ such that $\sigma(t)=l$. In particular, a free index does not appear in the set $K=$ $p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J) \in E_{N}(\mu)$.
Note that whether or not an index is free depends only on the choice of $\mu$, and not on the choice of $(I, J) \in \mathcal{E}_{n, m}(\mu)$. The number of free elements is equal to $m+n-r$, and $1 \leq m+n-r<m+r$.

Proposition 7.7. Fix $\mu \in \mathfrak{P}(n, m)$, and let $(I, J) \in \mathcal{E}_{n, m}(\mu)$ with $I=\left(i_{1}, \ldots, i_{n}\right)$ and $J=\left(j_{1}, \ldots, j_{m}\right)$. Let $\varphi^{I}, \psi^{J} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, and suppose that $\varphi^{I}$ has strong cancellation relative to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{a_{1}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, and that $\psi^{J}$ has strong cancellation relative to the decomposition $\mathbb{R}^{N}=\mathbb{R}^{b_{1}} \oplus \cdots \oplus \mathbb{R}^{b_{m}}$.
(1) Suppose that an index $i_{l}$ is free, and that $i_{l}=I_{r}=I_{r+1}=\cdots=I_{s}$ is the corresponding group of indices in $p_{\mathfrak{A}}(I)$, so that $I_{r-1}=i_{l-1}$ and $I_{s+1}=i_{l+1}$. Then the function $\varphi^{I}$ has cancellation in the variables $\left\{x_{I_{r}}, \ldots, x_{I_{s}}\right\}$, and $I_{t} \leq$ $J_{t}$ for $r \leq t \leq s{ }^{8}$
(2) Suppose that an index $j_{l}$ is free, and that $\left\{j_{l}=J_{r}=J_{r+1}=\cdots=J_{s}\right\}$ is the corresponding group of indices in $p_{\mathfrak{B}}(J)$, so that $J_{r-1}=j_{l-1}$ and $J_{s+1}=j_{l+1}$. Then the function $\psi^{J}$ has cancellation with respect to one of the variables $\left\{x_{J_{r}}, \ldots, x_{J_{s}}\right\}$, and $J_{t} \leq I_{t}$ for $r \leq t \leq s .{ }^{9}$
(3) Let $\mathbb{R}^{N}=\mathbb{R}^{c_{1}} \oplus \cdots \oplus \mathbb{R}^{c_{r}}$ be the decomposition corresponding to $\mu$, and let $\left\{\widetilde{J}_{1}, \ldots, \widetilde{J}_{r}\right\}$ be the corresponding sets of subscripts. Let $1 \leq l \leq r$.
(a) Suppose that $K_{\alpha_{l}}=\cdots=K_{\beta_{l}}=i_{\ell}$ so that $\sigma\left(\alpha_{l}\right)=\cdots=\sigma\left(\beta_{l}\right)=\ell$. Then either $\varphi^{I}$ has cancellation in a variable $x_{t}$ with $t \in \widetilde{J}_{l}$, or $\varphi^{I}$ has cancellation in a coordinate $x_{t}$ with $t>\beta_{l}$, in which case $K_{t}=J_{t} \geq I_{t}=i_{\ell}$.
(b) Suppose that $K_{\alpha_{l}}=\cdots=K_{\beta_{l}}=j_{\ell}$ so that $\tau\left(\alpha_{l}\right)=\cdots=\tau\left(\beta_{l}\right)=\ell$. Then either $\psi^{J}$ has cancellation in a variable $x_{t}$ with $t \in \widetilde{J}_{l}$, or $\psi^{J}$ has cancellation in a coordinate $x_{t}$ with $t>\beta_{l}$, in which case $K_{t}=I_{t} \geq J_{t}=j_{\ell}$.

[^6]Proof. To prove assertion (1), note that since $i_{l}$ is free, it does not appear in $K$. Hence for any $r \leq t \leq s, i_{l} \neq \max \left\{I_{t}, J_{t}\right\}=\max \left\{i_{l}, J_{t}\right\}$, and so $J_{\ell} \geq i_{\ell}=I_{t}$. Since $\varphi^{I}$ is assumed to have strong cancellation and $\left\{x_{I_{r}}, \ldots, x_{I_{s}}\right\}$ are precisely the variables corresponding to the index $i_{r}$, this establishes (1). The proof of assertion (2) proceeds in the same way.

To prove assertion (3a), note that by Proposition 7.5, part (1a), the only way in which it is possible for $\varphi^{I}$ not to have cancellation in a variable $x_{t}$ with $t \in \widetilde{J}_{l}$ is if $I_{t}=I_{\alpha_{l}}$ for $\alpha_{l} \leq t \leq \gamma$ and that $\gamma>\beta_{l}$. But then the conclusion follows from Proposition 7.5, part (2a). The proof of assertion (3b) follows in the same way.

Lemma 7.8. Fix $\mu \in \mathfrak{P}(n, m)$.
(1) Let $K \in E_{N}(\mu)$. Then there exists $\Theta^{K} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$, normalized relative to the families $\left\{\varphi^{I}\right\}$ and $\left\{\psi^{J}\right\}$ so that the sum

$$
\sum_{\substack{(I, J) \in \mathcal{E}_{n, m}(\mu) \\ p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J)=K}}\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}
$$

converges (uniformly) to $\left[\Theta^{K}\right]_{K}$.
(2) The function $\Theta^{K}$ has weak cancellation relative to the decomposition of $\mathbb{R}^{N}$ corresponding to $\mu$.
Proof. Let $(I, J) \in \mathcal{E}_{n, m}(\mu)$. Suppose that $\varphi^{I}$ has cancellation in the variables $\left\{x_{r_{1}}, \ldots, x_{r_{n}}\right\}$, with $r_{l} \in J_{l}^{\prime}$, and that $\psi^{J}$ has cancellation in the variables $\left\{x_{s_{1}}, \ldots\right.$, $\left.x_{s_{m}}\right\}$ with $s_{l} \in J_{l}^{\prime \prime}$. Let

$$
A_{0}=\left\{l \in\{1, \ldots, n\} \mid i_{r_{l}}<j_{r_{l}}\right\}, \quad B_{0}=\left\{l \in\{1, \ldots, m\} \mid j_{s_{l}}<i_{s_{l}}\right\} .
$$

Then it follows from Proposition 7.7 that if $i_{l}$ is a free index, $l \in A_{0}$ and if $j_{l}$ is a free index, then $l \in B_{0}$. On the other hand, according to Lemma 6.18, we can write each $\left[\varphi^{I}\right]_{I} *\left[\psi^{J}\right]_{J}$ as a finite sum of terms of the form

$$
\prod_{s \in A^{\prime}} 2^{-\epsilon\left|j_{l_{s}}-i_{l_{s}}\right|} \prod_{t \in B^{\prime}} 2^{-\epsilon\left|i_{m_{t}}-j_{m_{t}}\right|} \prod_{s \in A^{\prime \prime}} 2^{-\epsilon\left|i_{l_{s}+1}-i_{l_{s}}\right|}
$$

$$
\begin{equation*}
\prod_{t \in B^{\prime \prime}} 2^{-\epsilon\left|j_{m_{t}+1}-j_{m_{t}}\right|} \prod_{s \in A^{\prime \prime \prime}} \partial_{l_{s}} \prod_{t \in B^{\prime \prime \prime}} \partial_{m_{t}}[\tilde{\theta}] \tag{7.21}
\end{equation*}
$$

where

1. $A^{\prime}, A^{\prime \prime}, A^{\prime \prime \prime}$ are disjoint subsets of $\{1, \ldots, n\}$ with $A^{\prime} \cup A^{\prime \prime} \cup A^{\prime \prime \prime}=\{1, \ldots, n\}$;
2. $B^{\prime}, B^{\prime \prime}, B^{\prime \prime \prime}$ are disjoint subsets of $\{1, \ldots, m\}$ with $B^{\prime} \cup B^{\prime \prime} \cup B^{\prime \prime \prime}=\{1, \ldots, m\}$;
3. $A^{\prime} \subset A_{0} \subset A^{\prime} \cup A^{\prime \prime}$ and $B^{\prime} \subset B_{0} \subset B^{\prime} \cup B^{\prime \prime}$, and $n \notin A^{\prime \prime}$ and $n \notin B^{\prime \prime}$;
4. each function $\widetilde{\theta}$ depends on $\left\{A^{\prime}, A^{\prime \prime}, A^{\prime \prime \prime}, B^{\prime}, B^{\prime \prime}, B^{\prime \prime \prime}\right\}$ and is normalized relative to $\varphi$ and $\psi$.
Since $K$ is fixed, the sum for $p_{\mathfrak{A}}(I) \vee p_{\mathfrak{B}}(J)=K$ is precisely the sum over the set of free indices in $\left\{i_{1}, \ldots, i_{n}, j_{1}, \ldots, j_{m}\right\}$, and these are contained in the indices in $A^{\prime} \cup A^{\prime \prime} \cup B^{\prime} \cup B^{\prime \prime}$. The exponential decay in the powers of 2 in equation (7.21) show that the sum over all the free indices converges, and what remains satisfies the requirements for weak cancellation in Definition 5.5. This completes the proof.

### 7.5. Further examples

It may help to consider two additional examples.
Example 2: Suppose that $N=5$, and that the two partitions of $\{1,2,3,4,5\}$ are $A=\{2,3\}$ and $B=\{2,3\}$. Thus $A$ and $B$ come from the same decomposition $\mathbb{R}^{5}=\mathbb{R}^{2} \oplus \mathbb{R}^{3}$. There are $\binom{4}{2}=6$ different decompositions of $\{1,2,3,4\}$ into two disjoint subsets of cardinalities 2 and 2 . The six decompositions, the 5 -tuples $\tilde{I}, \tilde{J}$, and $\tilde{I} \vee \tilde{J}$, and the resulting new decomposition $C$ of $\{1,2,3,4,5\}$ are listed in Table 2 below. This example is typical of the convolution of two kernels coming from the same flag (in this case coming from the decomposition $\{2,3\}$ ). Note that all decompositions lead to the same decomposition $\{2,3\}$. Thus the convolution will be a flag of the same type.

Example 3: Suppose that $N=5$, and that the two partitions of $\{1,2,3,4,5\}$ are $A=\{5\}$ and $B=\{1,2,3,4,5\}$. Thus $m=1$ and $n=5$. There are then $\binom{6}{5}=6$ different decompositions of $\{1,2,3,4,5,6\}$ into two disjoint subsets of cardinalities 1 and 5 . The six decompositions, the 5 -tuples $\mathcal{I}$, $\mathcal{J}$, and $\mathcal{I} \vee \mathcal{J}$, and the resulting new decomposition $C$ of $\{1,2,3,4,5\}$ are listed in Table 3 below.

This example is typical of the convolution of a Calderón-Zygmund kernel with a kernel that is as fine as possible. In this case, the flag $A$ is coarser than flag $B$.

## 8. $L^{p}$-estimates for flag convolutions

In this section we establish the boundedness in $L^{p}(G)$ for $1<p<\infty$ of the operator $f \rightarrow \mathcal{K} * f$ given by convolution on $G$ with a flag kernel. To simplify the notation, we limit ourselves to the special situation where the exponents of the dilations $d_{1}, d_{2}, \ldots, d_{n}$ in equation (2.1) are positive integers. The results proved below will go over to the more general context with essentially no change in the proofs. We will also find it convenient to consider a continuous parameter $s_{k}$ for the dilation of the $x_{k}$ variable, in place of the dyadic version $2^{i_{k}}$ appearing in the previous sections. Again, the various results above stated for the dyadic dilations have simple modifications valid for their continuous analogues.

### 8.1. Maximal functions

As usual, $G$ is a homogeneous nilpotent Lie group that we identify with $\mathbb{R}^{N}$ as in Section 6.6. We also let

$$
\begin{aligned}
G_{k} & =\left\{\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \in \mathbb{R}^{N} \mid \mathbf{x}_{1}=\cdots=\mathbf{x}_{k-1}=0\right\} \\
& =\left\{\left(\mathbf{0}, \ldots, \mathbf{0}, \mathbf{x}_{k}, \ldots, \mathbf{x}_{n}\right) \in \mathbb{R}^{N} \mid \mathbf{x}_{j} \in \mathbb{R}^{a_{j}}, k \leq j \leq n\right\}
\end{aligned}
$$

We can identify $G_{k}$ with $\mathbb{R}^{a_{k}} \oplus \cdots \oplus \mathbb{R}^{a_{n}}$, and it follows from the formula (6.24) for group multiplication that $G_{k}$ is a subgroup of $G$. We let $m(E)$ denote the Lebesgue measure of a set $E \subseteq G=G_{1}$, and $m_{k}(E)$ denote the Lebesgue measure on $G_{k}$ of a subset $E \subseteq G_{k}$. For $\mathbf{s}=\left(s_{k}, \ldots, s_{n}\right)$, let

$$
R_{\mathrm{s}}=R_{\mathrm{s}}^{(k)}=\left\{\left(\mathbf{x}_{k}, \ldots, \mathbf{x}_{n}\right) \in G_{k}:\left|\mathbf{x}_{k}\right| \leq s_{k}^{k}, \ldots,\left|\mathbf{x}_{n}\right| \leq s_{n}^{n}\right\}
$$

We say that the size of the rectangle $R_{\mathbf{s}}$ is acceptable if $s_{k} \leq s_{k+1} \leq \cdots \leq s_{n}$.

Definition 8.1. The maximal function $M$, defined on $G=G_{1}$, is given by

$$
M(f)(\mathbf{x})=\sup \frac{1}{m\left(R_{\mathbf{s}}\right)} \int_{R_{\mathbf{s}}}\left|f\left(\mathbf{x} \cdot \mathbf{y}^{-1}\right)\right| d \mathbf{y}
$$

where the supremum is taken over all acceptable rectangles $R_{\mathbf{s}}=R_{\mathbf{s}}^{(1)} \subseteq G=G_{1}$.

## Theorem 8.2.

(a) $M$ is a bounded map of $L^{p}(G)$ to itself, for $1<p<\infty$.
(b) For $1<p<\infty$ there are constants $A_{p}$ so that if $\left\{f_{j}\right\}$ are scalar-valued functions on $G$ then

$$
\left\|\left(\sum_{j} M\left(f_{j}\right)^{2}\right)^{1 / 2}\right\|_{L^{p}(G)} \leq A_{p}\left\|\left(\sum_{j}\left|f_{j}\right|^{2}\right)^{1 / 2}\right\|_{L^{p}(G)}
$$

To prove this theorem, we consider the standard maximal function $M_{k}$ on the subgroup $G_{k}$ defined by

$$
M_{k}(f)(\mathbf{x})=\sup _{\rho>0} \frac{1}{m\left(B_{\rho}\right)} \int_{B_{\rho}}\left|f\left(\mathbf{x y}^{-1}\right)\right| d \mathbf{y}
$$

where $B_{\rho}=B_{\rho}^{(k)}$ is the automorphic one-parameter ball given by

$$
B_{\rho}^{(k)}=\left\{\left(\mathbf{x}_{k}, \ldots, \mathbf{x}_{n}\right) \in G_{k}:\left|\mathbf{x}_{k}\right| \leq \rho^{k},\left|\mathbf{x}_{k+1}\right| \leq \rho^{k+1}, \ldots,\left|\mathbf{x}_{n}\right| \leq \rho^{n}\right\}
$$

Let $\widetilde{M}_{k}$ be the maximal function in $G$ obtained by lifting $M_{k}$ in $G_{k}$ to $G$. (Facts about lifting are reviewed in the Appendix, Section 9). The key lemma is

Lemma 8.3. There is a constant $C$ so that

$$
M \leq C \widetilde{M}_{n} \circ \widetilde{M}_{n-1} \circ \cdots \circ \widetilde{M}_{1}
$$

Proof. Let $\mathbf{s}=\left(s_{k}, s_{k+1}, \ldots, s_{n}\right)$ and $\overline{\mathbf{s}}=\left(s_{k+1}, \ldots, s_{n}\right)$. Let
$\chi_{R_{\mathrm{s}}^{(k)}}=$ the characteristic function of the rectangle $R_{\mathrm{s}}^{(k)}$ in the subgroup $G_{k}$,
$\chi_{R_{\mathbf{s}}^{(k+1)}}=$ the characteristic function of $R_{\overline{\mathbf{s}}}^{(k+1)}$ in the subgroup $G_{k+1}$,
$\chi_{B_{s_{k}}^{(k)}}=$ the characteristic function of the ball $B_{s_{k}}^{(k)}$ in $G_{k}$.
Let $\eta_{R_{\mathrm{s}}^{(k)}}, \eta_{R_{\mathbf{s}}^{(k+1)}}, \eta_{B_{s_{k}^{(k)}}^{(k)}}$ be the normalized versions of these functions, so that, for example, $\eta_{R_{\mathrm{s}}^{(k)}}=m_{k}\left(R_{\mathrm{s}}^{(k)}\right)^{-1} \chi_{R_{\mathrm{s}}^{(k)}}$, with a similar definition for $\eta_{B_{\mathbf{s}_{k}}^{(k)}}$. The first observation to make is that if $s_{k} \leq s_{k+1} \leq \cdots \leq s_{n}$, there is an estimate $\eta_{R_{\mathrm{s}}^{(k)}} \lesssim \eta_{B_{s_{k}}^{(k)}} * \eta_{R_{\mathrm{s}}^{(k+1)}}$, in the sense there are constants $c, C$, so that

$$
\begin{equation*}
\eta_{R_{c \mathrm{~s}}^{(k)}}^{(k)} \leq C \eta_{B_{s_{k}}^{(k)}} *\left(\delta_{\mathbf{x}_{k}} \otimes \eta_{R_{\mathbf{s}}^{(k+1)}}\right) \tag{8.1}
\end{equation*}
$$

where the convolution is now on the group $G_{k}$, and $\delta_{\mathbf{x}_{k}}$ denotes the delta function of the $\mathbf{x}_{k}$ variables. ${ }^{10}$

[^7]In fact,

$$
\chi_{B_{s_{k}}^{(k)}} *\left(\delta_{\mathbf{x}_{k}} \otimes \chi_{R_{\mathbf{s}}^{(k+1)}}\right)=\int_{G_{k}} \chi_{B_{s_{k}}^{(k)}}\left(\mathbf{x} \cdot \mathbf{y}^{-1}\right) \chi_{R_{\mathbf{s}}^{(k+1)}}(\mathbf{y}) d \mathbf{y}
$$

We introduce a new coordinate system in $G_{k}$, so that if $\mathbf{x} \in G_{k}$, then

$$
\mathbf{x}=\left(\mathbf{x}_{k}, \mathbf{x}_{k+1}, \ldots, \mathbf{x}_{n}\right)=\left(\mathbf{x}_{k}, 0, \ldots, 0\right) \cdot\left(0, \mathrm{x}_{k+1}^{\prime}, \ldots, \mathbf{x}_{n}^{\prime}\right)=\left(\mathbf{x}_{k}\right) \cdot \mathbf{x}^{\prime}
$$

with $\mathbf{x}^{\prime} \in G_{k+1}$. In this new coordinate system the integral can be written as

$$
\begin{equation*}
\int_{G_{k+1}} \chi_{B_{s_{k}}^{(k)}}\left(\mathbf{x}_{k} \cdot \mathbf{y}^{\prime}\right) \chi_{R_{\mathbf{s}}^{(k+1)}}\left(\mathbf{y}^{\prime-1} \cdot \mathbf{x}^{\prime}\right) d \mathbf{y}^{\prime} \tag{8.2}
\end{equation*}
$$

Now if $\mathbf{x} \in R_{c \mathrm{~s}}^{(k)}$, and $c>0$ is small, then $\left|\mathbf{x}_{k}\right| \leq c^{k} s_{k}^{k}$ and $\mathbf{x}^{\prime} \in R_{c^{\prime} \mathbf{s}}^{(k+1)}$, with $c^{\prime}$ small with $c$. (This is because $\mathbf{x}_{j}^{\prime}=q_{j}(\mathbf{x})$, with $q_{j}$ homogeneous polynomials of degree $j$, $k+1 \leq j \leq n$.) So if $\mathbf{y}^{\prime} \in B_{c s_{k+1}}^{(k+1)}$ then $\mathbf{y}^{\prime-1} \cdot \mathbf{x}^{\prime} \in R_{\overline{\mathbf{s}}}^{(k+1)}$. Thus for $\mathbf{x} \in R_{c \mathrm{~s}}^{(k)}$, the integrand above is 1 , whenever $\mathbf{y}^{\prime} \in B_{c s_{k+1}}^{(k+1)}$. The result is that the last integral exceeds $m_{k+1}\left(B_{c s_{k+1}}^{(k+1)}\right)$ for $\mathbf{x} \in R_{c \mathrm{~s}}^{(k)}$. Dividing through by the normalizing factors and observing that

$$
\frac{1}{m_{k}\left(B_{s_{k}}^{(k)}\right)} \cdot \frac{1}{m_{k+1}\left(R_{\overline{\mathbf{s}}}^{(k+1)}\right)} \cdot m_{k+1}\left(B_{c s_{k+1}}^{(k+1)}\right)=c^{\prime \prime} \frac{1}{m_{k}\left(R_{\mathbf{s}}^{(k)}\right)}
$$

proves the claim (8.1). Proceeding this way by downward induction, starting with the trivial case $k=n$, gives

$$
\begin{equation*}
\eta_{R_{c \mathrm{~s}}^{(1)}} \leq C \eta_{B_{s_{1}}^{(1)}} *\left(\delta_{\mathbf{x}_{1}} \otimes \eta_{B_{s_{2}}^{(2)}}\right) * \cdots *\left(\delta_{\mathbf{x}_{1} \cdots \mathbf{x}_{n-1}} \otimes \eta_{\left.B_{s_{n}}^{(n)}\right)}\right) \tag{8.3}
\end{equation*}
$$

whenever $s_{1} \leq s_{2} \leq \cdots \leq s_{n}$. The inequality (8.3) then implies Lemma 8.3.
We now turn to the proof of Theorem 8.2. For each $k$, the maximal functions $M_{k}$ satisfy the usual weak-type and $L^{p}$ estimates on $L^{p}\left(G_{k}\right)$ (because the balls $B_{s_{k}}^{(k)}$ satisfy the required properties for the Vitali covering argument). Moreover, the vector-valued version

$$
\begin{equation*}
\left\|\left(\sum_{j}\left(M_{k}\left(f_{j}\right)\right)^{2}\right)^{1 / 2}\right\|_{L^{p}\left(G_{k}\right)} \leq \mathcal{A}_{p}\left\|\left(\sum\left|f_{j}\right|^{2}\right)^{1 / 2}\right\|_{L^{p}\left(G_{k}\right)} \tag{8.4}
\end{equation*}
$$

also holds. This can be shown by following the main steps in the case of $\mathbb{R}^{n}$ (see, e.g., Chapter 2 of [11]). In fact, one proves first a weak-type inequality for the vector-valued case, using a Calderón-Zygmund decomposition, which establishes (8.4) for $1<p \leq 2$. An additional argument is needed for $p>2$, and is based on the fact that

$$
\int_{G_{k}} M_{k}(f)^{2}(\mathbf{x}) \omega(\mathbf{x}) d \mathbf{x} \leq A \int_{G_{k}}|f(\mathbf{x})|^{2}\left(M_{k} \omega\right)(\mathbf{x}) d \mathbf{x}
$$

for all positive functions $\omega$. Next a lifting argument (see the Appendix) allows one to lift (8.4) on $G_{k}$ to $G$ to get

$$
\left\|\left(\sum_{j}\left|\tilde{M}_{k}\left(f_{j}\right)\right|^{2}\right)^{1 / 2}\right\|_{L^{p}(G)} \leq A_{p}\left\|\left(\sum_{j}\left|f_{j}\right|^{2}\right)^{1 / 2}\right\|_{L^{p}(G)}
$$

As a result we obtain a similar inequality for $\tilde{M}_{n} \circ \tilde{M}_{n-1} \circ \cdots \circ \tilde{M}_{1}$, and an application of Lemma 8.3 then proves Theorem 8.2.

Our actual application of the estimate in equation (8.4') is contained in the following:

Corollary 8.4. Suppose $F_{\mathbf{t}}(\mathbf{x})$ is a measurable function of $(\mathbf{t}, \mathbf{x}) \in\left(\mathbb{R}^{+}\right)^{n} \times \mathbb{R}^{N}$. Then

$$
\left.\|\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left(M\left(F_{\mathbf{t}}\right)\right)(\mathbf{x})\right)^{2} d \mathbf{t}\right)^{1 / 2}\left\|_{L^{p}\left(\mathbb{R}^{M}\right)} \leq A_{p}\right\|\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left|F_{\mathbf{t}}(\mathbf{x})\right|^{2} d \mathbf{t}\right)^{1 / 2} \|_{L^{p}\left(\mathbb{R}^{N}\right)}
$$

Proof. Assume first that $F_{\mathbf{t}}(\mathbf{x})$ is jointly continuous and has compact support. For each $\epsilon>0$, apply the conclusion (8.4') to the case where $\left\{f_{j}(\mathbf{x})\right\}$ are an enumeration of the $\epsilon^{n / 2} F_{\epsilon i_{1}, \epsilon i_{2}, \ldots, \epsilon i_{n}}(\mathbf{x})$, for $\left(i_{1}, i_{2}, \ldots, i_{n}\right)$ ranging over $\left(\mathbb{Z}^{+}\right)^{n}$, and then let $\epsilon \rightarrow 0$, obtaining the desired result in this case. For the general $F_{\mathbf{t}}$, assuming that $\left\|\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left|F_{\mathbf{t}}(\mathbf{x})\right|^{2} d \mathbf{t}\right)^{1 / 2}\right\|_{L^{p}(G)}$ is finite, find a sequence $F_{\mathbf{t}}^{(n)}(\mathbf{x})$ of continuous functions of compact support, with $F_{\mathbf{t}}^{(n)}(\mathbf{x}) \rightarrow F_{\mathbf{t}}(\mathbf{x})$ almost everywhere, so that

$$
\left\|\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left|F_{\mathbf{t}}^{(n)}\right|^{2} d \mathbf{t}\right)^{1 / 2}\right\|_{L^{p}} \rightarrow\left\|\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left|F_{\mathbf{t}}\right|^{2} d \mathbf{t}\right)^{1 / 2}\right\|_{L^{p}}
$$

and apply the previous case, via Fatou's lemma.
It will also be useful to observe that effectively the estimate (8.3) can be reversed in the following way.
Lemma 8.5. We have

$$
\begin{equation*}
\eta_{B_{s_{1}}^{(1)}} *\left(\delta_{\mathbf{x}_{1}} \otimes \eta_{B_{s_{2}}^{(2)}}\right) * \cdots *\left(\delta_{\mathbf{x}_{1}, \ldots, \mathbf{x}_{n-1}} \otimes \eta_{B_{s_{n}}^{(n)}}\right) \leq C \eta_{R_{c \mathbf{s}^{*}}^{(1)}} \tag{8.5}
\end{equation*}
$$

for an appropriate $C>0$. Here $\mathbf{s}^{*}=\left(s_{1}^{*}, \ldots, s_{n}^{*}\right)$, with $s_{k}^{*}=\max \left\{s_{j}, 1 \leq j \leq k\right\}$. Note that we do not require that $s_{1} \leq s_{2} \leq \cdots \leq s_{n}$.

The proof is based on the observation that $\eta_{B_{s_{k}}^{(k)}} *\left(\delta_{\mathbf{x}_{k}} \otimes \eta_{R_{\mathbf{s}}^{(k+1)}}\right) \leq c \eta_{R_{c \mathbf{s}}^{(k)}}$, where $\widetilde{\mathbf{s}}=\left(\widetilde{s}_{k}, \ldots, \widetilde{s}_{n}\right)$ and

$$
\tilde{s}_{j}= \begin{cases}\max \left\{s_{k}, s_{j}\right\} & \text { if } j>k \\ s_{k} & \text { if } j=k\end{cases}
$$

In fact if $\mathbf{x} \notin R_{C \tilde{\mathbf{s}}}^{(k)}$ (for some large $C$ ) then either $\left|\mathbf{x}_{k}\right| \geq C^{\prime} s_{k}^{k}$ or $\mathbf{x}^{\prime} \notin R_{\tilde{\bar{s}}}^{(k+1)}$. Looking back at the integral in equation (8.2) we see that the integral vanishes, because $\chi_{B_{s_{k}}^{(k)}}\left(\mathbf{x}_{k} \cdot \mathbf{y}^{\prime}\right)=0$ in the first case, or $\chi_{R_{\overline{\mathbf{s}}}^{(k+1)}}\left(\mathbf{y}^{\prime-1} \cdot \mathbf{x}^{\prime}\right)=0$ in the second case. Moreover as above, this integral is majorized by $C m\left(B_{c_{s}+1}^{(k+1)}\right)$. Altogether then, we have $\eta_{B_{s_{k}}^{(k)}} *\left(\delta_{\mathbf{x}_{k}} \otimes \eta_{R_{\overline{\mathrm{s}}}^{(k+1)}}\right) \leq c \eta_{R_{\mathrm{s}}^{(k)}}$, and an induction proves Lemma 8.5.

Now let $A_{\mathbf{s}}$ denote the function appearing on the left-side of (8.5). Then as a consequence we have

$$
\begin{equation*}
\left|\left(f * A_{\mathbf{s}}\right)(\mathbf{x})\right| \leq C M(f)(\mathbf{x}) \tag{8.6}
\end{equation*}
$$

for all $\mathbf{s}=\left(s_{1}, \ldots, s_{n}\right)$, not necessarily in increasing order. Similarly if $A_{\mathbf{s}}^{*}=$ $\left(\delta_{\mathbf{x}_{1}, \ldots, \mathbf{x}_{n-1}} \otimes \eta_{B_{s_{n}}^{(n)}}\right) * \cdots *\left(\eta_{B_{s_{1}}^{(1)}}\right)$ we also have $A_{\mathbf{s}}^{*}(\mathbf{x}) \leq c \eta_{R_{\mathbf{s}^{*}}^{(1)}}$. This follows from (8.5) if we observe that $A_{\mathbf{s}}^{*}(\mathbf{x})=A_{\mathbf{s}}\left(\mathbf{x}^{-1}\right)$. As a result, in analogy to (8.6), we have for all s

$$
\left|\left(f * A_{\mathbf{s}}^{*}\right)(\mathbf{x})\right| \leq c M(f)(\mathbf{x}) .
$$

Indeed, one has $R_{\mathbf{s}^{*}}^{-1}=R_{\mathbf{s}^{*}}$ if, in defining $R_{\mathbf{s}}$, a coordinate system is used where the inverse of $\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)$ is given by $\mathbf{x}^{-1}=\left(-\mathbf{x}_{1}, \ldots,-\mathbf{x}_{n}\right)$. Alternatively, if we use canonical coordinates of the second kind, as above, then one has $R_{c_{1} \mathbf{s}^{*}} \subset$ $R_{\mathbf{s}^{*}}^{-1} \subset R_{c_{2} \mathbf{s}^{*}}$, for two appropriate constants $c_{1}$ and $c_{2}$; this also leads to (8.6').

### 8.2. Comparisons

The basic comparison function is

$$
\Gamma_{\mathbf{t}}(\mathbf{x})=t_{1} \cdot t_{2} \cdots t_{n} \cdot \prod_{k=1}^{n}\left(t_{1}+t_{2}+\cdots+t_{k}+N_{1}(\mathbf{x})+\cdots+N_{k}(\mathbf{x})\right)^{-Q_{k}-1}
$$

for $\mathbf{t}=\left(t_{1}, \ldots, t_{n}\right), t_{j}>0$. Recall that $N_{k}(\mathbf{x})=\left|\mathbf{x}_{k}\right|^{1 / k}$ and $Q_{k}=k a_{k}$ with $a_{k}$ the dimension of the $x_{k}$ space.

## Theorem 8.6.

$$
\begin{equation*}
\sup _{\mathbf{t}}\left|\left(f * \Gamma_{\mathbf{t}}\right)(\mathbf{x})\right| \leq C M(f)(\mathbf{x}) \tag{8.7}
\end{equation*}
$$

where the supreme is taken over all $\mathbf{t}$, with $t_{j}>0$.
Proof. Note that it suffices to restrict attention to t's that are of acceptable size. Indeed, let $s_{j}=t_{1}+t_{2} \cdots+t_{j}, 1 \leq j \leq k$. Then $s_{j} \leq s_{j+1}$ but $k\left(t_{1}+\cdots+t_{k}\right) \geq$ $s_{1}+s_{2}+\cdots+s_{k}$. Hence,
$\left(t_{1}+\cdots+t_{k}+N_{1}+\cdots+N_{k}\right)^{-Q_{k}-1} \leq c_{k}\left(s_{1}+s_{2} \cdots+s_{k}+N_{1}+\cdots+N_{k}\right)^{-Q_{k}-1}$,
with $c_{k}=k^{Q_{k}+1}$. Therefore $\Gamma_{\mathbf{t}}(\mathbf{x}) \leq c \Gamma_{\mathbf{s}}(\mathbf{x})$, which shows that it suffices to consider t's that are increasing.

We next fix $\mathbf{t}=\left(t_{1}, \ldots, t_{n}\right)$ and decompose the space $G=\mathbb{R}^{N}$ into a preliminary dyadic partition as follows. For each $J=\left(j_{1}, \ldots, j_{n}\right) \in \mathbb{Z}_{+}^{n}$ we let

$$
R_{J}=\left\{\mathbf{x} \in \mathbb{R}^{N} \left\lvert\, 2^{j_{k}-1}<\frac{N_{1}(\mathbf{x})+\cdots+N_{k}(\mathbf{x})}{t_{1}+t_{2}+\cdots+t_{k}} \leq 2^{j_{k}}\right., \text { for } k=1,2, \ldots, n\right\}
$$

with the understanding that if $j_{k}=0$ the inequality should be taken to be

$$
\frac{N_{1}(\mathbf{x})+\cdots+N_{k}(\mathbf{x})}{t_{1}+t_{2}+\cdots+t_{k}} \leq 1
$$

Notice that $\bigcup_{J \in \mathbb{Z}_{+}^{n}} R_{J}=G$ gives a partition of the space $G$. However, in general each $R_{J}$ is not comparable to an acceptable rectangle. We remedy this as follows. For a suitable constant $c$, define $s^{J}=\left(s_{1}^{J}, \ldots, s_{n}^{J}\right)$ by

$$
\begin{equation*}
s_{1}^{J}=c t_{1} 2^{j_{1}}, \quad s_{2}^{J}=c^{2} t_{2} 2^{j_{2}}, \ldots, s_{n}^{J}=c^{n} t_{n} 2^{j_{n}} . \tag{8.8}
\end{equation*}
$$

Now if $R_{J}$ is non-empty, then since $t_{1} \leq t_{2} \leq \cdots \leq t_{n}$, we have
$N_{1}(\mathbf{x}) \approx t_{1} 2^{J_{1}}, \quad N_{1}(\mathbf{x})+N_{2}(\mathbf{x}) \approx t_{2} 2^{j_{2}}, \ldots, N_{1}(\mathbf{x})+N_{2}(\mathbf{x})+\cdots+N_{n}(\mathbf{x}) \approx t_{n} 2^{j_{n}}$. As a result, for sufficiently large $c$, it follows that $s_{1}^{J} \leq s_{2}^{J} \leq \cdots \leq s_{n}^{J}$.

Now define $R_{J}^{*}=\left\{\mathbf{x}: N_{k}(\mathbf{x}) \leq s_{k}^{J}, k=1, \ldots, n\right\}$ for those $J$ where $R_{J}$ is not empty. Then clearly $R_{J} \subset R_{J}^{*}$ and each $R_{J}^{*}$ is a rectangle of acceptable size (in fact, essentially the smallest rectangle of acceptable size containing $R_{J}$ ). However, for $f \geq 0$,

$$
\int_{G} f\left(\mathbf{x} \cdot \mathbf{y}^{-1}\right) \Gamma_{\mathbf{t}}(\mathbf{y}) d \mathbf{y}=\sum_{J \in \mathbb{Z}_{+}^{n}} \int_{R_{J}} f\left(\mathbf{x y}^{-1}\right) \Gamma_{\mathbf{t}}(\mathbf{y}) d \mathbf{y}
$$

Recall that by (8.8), $t_{k} \approx s_{k}^{J} 2^{-j_{k}}$, and on $R_{J}$ we have $N_{1}+\cdots+N_{k} \approx\left(t_{1}+t_{2}+\right.$ $\left.\cdots+t_{k}\right) 2^{j_{k}} \approx s_{k}^{J}$. Thus, on $R_{J}$ we have $\Gamma_{\mathbf{t}}(\mathbf{y}) \lesssim \prod_{k=1}^{n}\left(s_{k}^{J}\right)^{-Q_{k}} \cdot\left(2^{-Q_{k} j_{k}}\right)$. So

$$
\int_{G} f\left(\mathbf{x y}^{-1}\right) \Gamma_{\mathbf{t}}(\mathbf{y}) d \mathbf{y} \lesssim \sum_{J} \prod_{k=1}^{n} 2^{-Q_{k} j_{k}}\left(s_{k}^{J}\right)^{-Q_{k}} \cdot \int_{R_{J}^{*}} f\left(\mathbf{x y}^{-1}\right) d \mathbf{y}
$$

However, each $R_{J}^{*}$ is a rectangle of acceptable size and $\prod_{k=1}^{n}\left(s_{k}^{J}\right)^{Q_{k}}=c m\left(R_{J}^{*}\right)$. Thus by the definition of $M$, the last sum is majorized by

$$
c \sum_{J} \prod_{k=1}^{n} 2^{-Q_{k} j_{k}} M(f)=c^{\prime} M(f)
$$

and (8.7) is proved.

### 8.3. Truncated kernels

Recall that we defined truncated kernels and improved truncated kernels in Definition 6.20 (Section 6.9). Suppose that $\psi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ with support in the unit ball. For $b>0$ write

$$
\psi_{b}(\mathbf{x})=b^{-Q_{1}-Q_{2}-\cdots-Q_{n}} \psi\left(b^{-1} \mathbf{x}_{1}, b^{-2} \mathbf{x}_{2}, \ldots, b^{-n} \mathbf{x}_{n}\right)
$$

the automorphically dilated $\psi$. We also say that $\psi_{b}$ has width $b$.
Theorem 8.7. Suppose $\mathcal{K}$ is a truncated flag kernel of width $a$, and $\psi_{b}$ is as above of width $b$. Then
(1) $\mathcal{K} * \psi_{b}$ and $\psi_{b} * \mathcal{K}$ are truncated kernels of width $a+b$.
(2) If in addition $\int_{G} \psi(\mathbf{x}) d \mathbf{x}=0$, then $K * \psi_{b}$ and $\psi_{b} * K$ are improved truncated kernels of width $a+b$. Moreover, then $K * \psi_{b}$ and $\psi_{b} * K$ are actually improved truncated kernels of width $a+b$, multiplied by the further factor $\frac{b}{a+b}$.

Note that the statements of the hypotheses and conclusions have an automor-phic-dilation invariance, so in proving Theorem 8.7, it suffices to consider two cases: $b=1, a \leq 1$; and $a=1, b \leq 1$. In the first case we use Proposition 6.21, since any truncated kernel is actually an un-truncated kernel. Thus we get that $K * \psi_{1}$ and $\psi_{1} * K$ have width 1 , which is essentially the same as having width $1+a$, since $a \leq 1$.

The second case would be easy if every truncated kernel of width 1 were of the form $K * \psi_{1}$. Its proof is a little more involved and requires the following lemma.

Lemma 8.8. Given any $M$, there exist $\eta_{0}$ and $\eta_{1}$ both of class $C^{(M)}$, supported in the unit ball, and a (non-communicative) polynomial $P\left(X_{1}, \ldots, X_{N}\right)=P(X)$ in the right-invariant vector fields of $G$, so that

$$
\begin{equation*}
P(X) \eta_{0}=\delta_{0}+\eta_{1} \tag{8.9}
\end{equation*}
$$

with $\delta_{0}$ the Dirac delta at the origin.
Proof. Consider the elliptic operator of order $2 r, P(X)=\left(\sum_{j=1}^{N} X_{j}^{2}\right)^{r}$, with $r$ a positive integer. Then by the standard theory of pseudo-differential operators there is a locally integrable function $F$ which is $C^{\infty}$ away from the origin, so that $P(X) F=\delta_{0}+\eta^{\prime}$, with $\eta^{\prime}$ a $C^{\infty}$ function. Moreover, $F$ satisfies the estimate $\left|\left(\frac{\partial}{\partial x}\right)^{\alpha} F(\mathbf{x})\right| \leq A_{\alpha}$, whenever $|\mathbf{x}| \leq 1$ and $2 r>N+|\alpha|$ (these estimates also follow from Theorem 1 in [8]). Thus we only need to take $2 r>M+N$ and set $\eta_{0}=\mu \cdot F$, where $\mu$ is a $C^{\infty}$ function supported in the unit ball, and $\mu(x)=1$ in the ball of radius $1 / 2$. Then since $\eta_{0}$ is supported in the unit ball, so is $\eta_{1}=P(X) \eta_{0}-\delta_{0}$; and since $F$ is $C^{\infty}$ away from the origin it follows that $\eta_{1}$ is in fact $C^{\infty}$ everywhere. This completes the proof of Lemma 8.8.

We now return to the proof of Theorem 8.7. We consider $K * \psi_{b}$ when $K$ has width 1 , and $b \leq 1$. Now by the lemma $K * \psi_{b}=K * \delta_{0} * \psi_{b}=K * P(X) * \eta_{0} *$ $\psi_{b}+K * \eta_{1} * \psi_{b}$, since $P(X)$ is a right-invariant differential operator. Now since $K$ has width $1, K * P(X)$ is also a truncated kernel of width one, and in particular an un-truncated kernel. However, $\eta_{0} * \psi_{b}$ has width $1+b$, which is essentially one. Also, it is of class $C^{(M)}$ (uniformly in $b$ ), since $\eta_{0}$ is of class $C^{(M)}$. Thus $K * P(X) * \eta_{0} * \psi_{b}$ satisfies the differential inequalities for a truncated kernel of width one for all orders $\leq m$. However, the term $K * \eta_{1} * \psi_{b}$ clearly does the same, for all orders. Notice we can make $m$ as large as we wish by making $M$ sufficiently large. (See Remark 6.22 on page 690.) A similar argument works for $\psi_{b} * K$ and thus part (1) of Theorem 8.7 is proved.

Part (2) is proved in the same way, using conclusion (2) of Proposition 6.21. The further improvement given by the factor $b(a+b)^{-1}$ comes about as follows. As before, we may take $a=1$, and $b \leq 1$. Since $\int \psi(\mathbf{x}) d \mathbf{x}=0$, both $\eta_{0} * \psi_{b}$ and $\eta_{1} * \psi_{b}$ give an improvement of $b$. In fact, since $\int \psi(\mathbf{x}) d \mathbf{x}=0$, it follows from Lemma 5.1 and Proposition 4.5 that we can write

$$
\begin{equation*}
\psi_{b}=\sum b^{k} X_{k}\left(\psi_{b}^{(k)}\right) \tag{8.10}
\end{equation*}
$$

for suitable $C^{\infty}$ functions $\psi^{(k)}$ supported in the unit ball, with $\left\{X_{k}\right\}$ ranging over right-invariant vector fields of degree $k, k \geq 1$. Thus $\eta_{0} * \psi_{b}=\sum b^{k}\left(\eta_{0} * X_{k}\right) * \psi_{b}^{(k)}$ and this gives a gain $b, b \leq 1$. Similarly for the term $\eta_{1} * \psi_{b}$.

### 8.4. Key estimates: kernels

Suppose $\varphi^{(k)} \in \mathcal{C}_{0}^{\infty}$ is supported on the unit ball of the group $G_{k}$, with

$$
\int_{G_{k}} \varphi^{(k)}(\mathbf{x}) d \mathbf{x}=0
$$

We set $\varphi_{t}^{(k)}(\mathbf{x})=t^{-Q_{k}-\cdots-Q_{n}} \varphi\left(\delta_{t^{-1}}(\mathbf{x})\right)$, with $Q_{k}=k a_{k}$ and let $\tilde{\varphi}^{(k)}$ to be the corresponding distributions lifted to the full group $G$; i.e., $\tilde{\varphi}_{t}^{(k)}=\delta_{\mathbf{x}_{1}, \mathbf{x}_{2} \cdots \mathbf{x}_{k-1}} \otimes$ $\varphi_{t}^{(k)}$. We let $\Phi_{\mathbf{t}}=\tilde{\varphi}_{t_{1}}^{(1)} * \tilde{\varphi}_{t_{2}}^{(2)} * \cdots * \tilde{\varphi}_{t_{n}}^{(n)}$ for $\mathbf{t}=\left(t_{1}, \ldots, t_{n}\right)$, and write

$$
\Phi_{\mathbf{t}}^{*}=\tilde{\varphi}_{t_{n}}^{(n)} * \tilde{\varphi}_{t_{n-1}}^{(n-1)} * \cdots * \tilde{\varphi}_{t_{1}}^{(1)}
$$

Recall the comparison function $\Gamma_{\mathbf{t}}$ discussed in Section 8.2. Note that here we will allow the functions $\varphi$ and $\Phi$ to take their values in finite-dimensional vector spaces.

Theorem 8.9. Suppose $\mathcal{K}$ is a flag kernel. Then
(1) $\left|K * \Phi_{\mathbf{t}}(\mathbf{x})\right|$ and $\left|\Phi_{\mathbf{t}}^{*} * K(\mathbf{x})\right|$ are both majorized by $c \Gamma_{\mathbf{t}}(\mathbf{x})$ for all $\mathbf{t}$.
(2) If $X_{k}^{R}$ is any right-invariant vector field of degree $k$, then

$$
\left|X_{k}^{R}\left(K * \Phi_{\mathbf{t}}\right)\right| \leq c\left(t_{1}+\cdots+t_{k}\right)^{-k} \Gamma_{\mathbf{t}}(\mathbf{x})
$$

(3) If $X_{k}^{L}$ is any left-invariant vector field of degree $k$, then

$$
\left|X_{k}^{L}\left(K * \Phi_{\mathbf{t}}\right)\right| \leq c\left(t_{1}+\cdots+t_{k}\right)^{-k} \Gamma_{\mathbf{t}}(\mathbf{x})
$$

For the proof we need to do our calculations in a particular coordinate system, already used in the proof Lemma 8.3. Here we represent a point $\mathbf{x}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right) \in$ $G$ via adapted canonical coordinates of the second kind; i.e., we take $\mathbf{x}=\exp \left(\mathbf{x}_{1}^{\prime}\right.$. $\left.X_{1}\right) \exp \left(\mathbf{x}_{2}^{\prime} \cdot X_{2}\right) \cdots \exp \left(\mathbf{x}_{n}^{\prime} \cdot X_{n}\right)$, where $\mathbf{x}^{\prime}=\left(x_{k, 1}^{\prime}, \ldots, x_{k, a_{k}}^{\prime}\right),\left\{X_{k, 1}, \ldots, X_{k, a_{k}}\right\}$ is a basis of the subspace of vector fields of degree $k$, and $\mathbf{x}_{k}^{\prime} \cdot X_{k}=\sum_{j} x_{k, j}^{\prime} X_{k, j}$. The passage from the initial $\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)$ coordinates to the $\left(\mathrm{x}_{1}^{\prime}, \ldots, \mathbf{x}_{n}^{\prime}\right)$ coordinates is of the form treated in Section 6.5, so that the basic comparison function $\Gamma_{\mathbf{t}}$ is essentially unchanged when passing from $\mathbf{x}$ to $\mathbf{x}^{\prime}$. We therefore freely use instead the new coordinate system $\mathbf{x}^{\prime}$, and now relabel $\mathbf{x}^{\prime}$ by $\mathbf{x}$. The advantage of this coordinate system is that, firstly $\mathbf{y}=\left(\mathbf{y}_{1}, \ldots, \mathbf{y}_{k}, \mathbf{y}_{k+1}, \ldots, \mathbf{y}_{n}\right) \in G_{k}$ if and only if $\mathbf{y}_{1}=0, \ldots, \mathbf{y}_{k-1}=0$, but more importantly, if $\mathbf{x} \in G$, and $\mathbf{y} \in G_{k}$, then $\mathbf{x} \cdot \mathbf{y}=\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{k-1}, \overline{\mathbf{x}}_{k}, \ldots, \overline{\mathbf{x}}_{n}\right)$, with $\overline{\mathbf{x}}_{\ell}($ for $\ell \geq k)$, depending only on $\mathbf{x}_{k}, \ldots, \mathbf{x}_{n}$, and $\mathbf{y}_{k}, \ldots, \mathbf{y}_{n}$, and not on $\mathbf{x}_{1}, \ldots, \mathbf{x}_{k-1}$.

Now set $K^{(k)}=K * \tilde{\varphi}_{t_{1}}^{(1)} * \cdots * \tilde{\varphi}_{t_{k}}^{(k)}$. Consider first $K^{(1)}=K * \varphi_{t_{1}}^{(1)}$. According to Proposition 6.21, part (2), since $\int_{G} \varphi^{(1)}(\mathbf{x}) d \mathbf{x}=0$, then for each $\mathbf{x}_{1}$, the kernel
$K^{(1)}\left(\mathbf{x}_{1}, \mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)$, as a function of $\left(\mathbf{x}_{2}, \ldots, \mathbf{x}_{n}\right)$ on $G_{2}$, is a truncated kernel of width $t_{1}+N_{1}\left(\mathbf{x}_{1}\right)$, multiplied by the "constant" factor $t_{1}\left[t_{1}+N_{1}\left(\mathbf{x}_{1}\right)\right]^{-Q_{1}-1}$. Also we have a similar conclusion for $\partial_{x_{1}}^{\beta_{1}} K^{(1)}(\mathbf{x})$, except now the improving factor is $t_{1}\left[t_{1}+N_{1}\left(\mathbf{x}_{1}\right)\right]^{-Q_{1}-1-\beta_{1}}$.

Consider next the inductive hypothesis: for a given $k$,
(a) for each $\mathbf{x}_{1}, \ldots, \mathbf{x}_{k}, K^{(k)}\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{n}\right)$, thought of as a function of $\left(\mathbf{x}_{k+1}, \ldots, \mathbf{x}_{n}\right)$ on $G_{k+1}$, is a truncated kernel of width $t_{1}+\cdots+t_{k}+N_{1}\left(\mathbf{x}_{1}\right)+\cdots+N_{k}\left(\mathbf{x}_{k}\right)$, multiplied by the improving factor $\prod_{j=1}^{k} t_{j}\left[t_{1}+\cdots+t_{j}+N_{1}+\cdots+N_{j}\right]^{-Q_{j}-1}$;
(b) for each $r \leq k$, a similar statement holds for $\partial_{x_{r}}^{\beta_{r}} K^{(k)}(\mathbf{x})$, except that now the $r^{\text {th }}$ part of the improving factor is $t_{r}\left[t_{1}+\cdots+t_{r}+N_{1}+\cdots+N_{r}\right]^{-Q_{r}-1-r \beta_{r}}$.
Notice that if the inductive hypothesis holds for $k$, that is for $K^{(k)}$, then since $K^{(k+1)}\left(\mathbf{x}_{1} \cdots \mathbf{x}_{n}\right)=K^{(k)} * \varphi_{t_{k+1}}^{(k+1)}$, where since the convolution is taken on the group $G_{k+1}$, it therefore does not involve the variables $\mathbf{x}_{1}, \ldots, \mathbf{x}_{k}$ because of the nature of our coordinate system. As a result, we get the conclusion for $k+1$, that is for $K^{(k+1)}$. To see this, we merely apply Proposition 6.21 , part (2), for the case of the group $G_{k+1}$.

More precisely, we are convolving a truncated kernel of width $a=t_{1}+\cdots+t_{k}+$ $N_{1}+\cdots+N_{k}$ (on $G_{k+1}$ ) with a function $\varphi$ (which equals $\varphi_{t_{k+1}}^{(k+1)}$ ) of width $b=t_{k+1}$. The result is a truncated kernel of width $a+b=t_{1}+\cdots+t_{k+1}+N_{1}+\cdots+N_{k}$ on $G_{k+1}$, together with a further factor $\frac{b}{a+b}$. That is, for $K^{(k+1)}$ as a function of $\mathbf{x}_{k+2}, \ldots, \mathbf{x}_{n}$, we have a truncated kernel of width $t_{1}+\cdots+t_{k+1}+N_{1}+\cdots+N_{k+1}$, times a factor of the form $b(a+b)^{-1}$. So the full improvement is

$$
\frac{b}{a+b} \cdot \frac{a+b}{\left(a+b+N_{k+1}\right)^{Q_{k+1}+1}}=\frac{t_{k+1}}{\left(t_{1}+\cdots+t_{k+1}+N_{1}+\cdots+N_{k+1}\right)^{Q_{k+1}+1}},
$$

as was needed. The same kind of improvement holds for the estimates of $\partial_{x_{l}}^{\beta_{\ell}} K^{(k+1)}(\mathbf{x})$, for $\ell \leq k+1$.

Thus, the inductive hypothesis (now the conclusion of the induction) holds for $k=n$. As a result, it is clear that $\left|K * \Phi_{\mathbf{t}}(\mathbf{x})\right| \leq c \Gamma_{\mathbf{t}}(\mathbf{x})$ and

$$
\left|\partial_{\mathbf{x}_{k}}\left(K * \Phi_{\mathbf{t}}(\mathbf{x})\right)\right| \leq c\left[t_{1}+\cdots+t_{k}+N_{1}+\cdots+N_{k}\right]^{-k} \Gamma_{\mathbf{t}}(\mathbf{x})
$$

for every $k, 1 \leq k \leq n$. Since $X_{k}^{R}=\partial_{\mathbf{x}_{k}}+\sum_{\ell>k} h_{\ell}^{k} \partial_{\mathbf{x}_{\ell}}$ where $h_{\ell}^{k}$ is a homogeneous polynomial of degree $\ell-k$, it follows, in particular, that

$$
X_{k}^{R}\left(K * \Phi_{\mathbf{t}}\right)(\mathbf{x}) \leq c\left[t_{1}+\cdots+t_{k}\right]^{-k} \Gamma_{\mathbf{t}}(\mathbf{x})
$$

The results for $\Phi_{\mathbf{t}}^{*} * K$ and $X_{k}^{L}\left(\Phi_{\mathbf{t}}^{*} * K\right)$ follow in the same way, but require a canonical coordinate system in the reverse order. Alternatively we can deduce them from the previous case by using the inversion $\mathbf{x} \rightarrow \mathrm{x}^{-1}$.

### 8.5. Key estimates: operators

We define $P_{\mathbf{t}}(f)=f * \Phi_{\mathbf{t}}$, and $P_{\mathbf{t}}^{*}=f * \Phi_{t}^{*}$, with $\mathbf{t}=\left(t_{1}, t_{2}, \ldots, t_{n}\right)$ and $t_{j}>0$, $1 \leq j \leq n$, with $\Phi_{\mathrm{t}}$ and $\Phi_{\mathrm{t}}^{*}$ defined at the beginning of the previous section. We suppose $\mathcal{K}$ is a flag kernel and $T f=f * K$ when $f$ is a Schwartz function. We recall the maximal operator $M$ and let $\mathcal{M}=M \circ M$, i.e., $\mathcal{M}(f)=M(M(f))$.

## Theorem 8.10.

(a) $\left|P_{\mathbf{t}} T(f)(\mathbf{x})\right| \leq c M(f)(\mathbf{x})$, all $\mathbf{t}$.
( $\mathrm{a}^{\prime}$ ) Similarly, $\left|\left(T P_{\mathbf{t}}^{*}\right)(f)(\mathbf{x})\right| \leq c M(f)(\mathbf{x})$, all $\mathbf{t}$.
(b) $\left|P_{\mathbf{t}} T P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq \gamma(\mathbf{s}, \mathbf{t}) \mathcal{M}(f)(\mathbf{x})$, where, for some $\delta>0$,

$$
\gamma(\mathbf{s}, \mathbf{t}) \leq c\left(\prod_{k=1}^{n} \min \left(\frac{s_{k}}{t_{k}}, \frac{t_{k}}{s_{k}}\right)\right)^{\delta}
$$

Note: the conclusion will be seen to hold for $\delta=1 / n^{2}$.
Proof. The function $P_{\mathbf{t}} T(f)$ is given by $(f * K) * \Phi_{\mathbf{t}}=f *\left(K * \Phi_{\mathbf{t}}\right)$. Hence conclusion (a) is a direct consequence of Theorem 8.6 and Theorem 8.9, part (1). The same is true for conclusion ( $\mathrm{a}^{\prime}$ ).

Turning to (b), we first fix $k$, and consider the situation when $t_{k} / s_{k}=\rho \geq 1$. With this $\rho$ given, we next divide our consideration in two cases.
Case I: With $\sigma$ a positive constant, to be specified below, $s_{j-1} / s_{j}>\rho^{\sigma}$ for at least one $j$, with $2 \leq j \leq k$.
Case II: $s_{j-1} / s_{j} \leq \rho^{\sigma}$ for all $j$, with $2 \leq j \leq k$.
To handle Case I we need the following observation, that will give us the needed gain. Recall the notation $\eta_{B_{\rho}^{(k)}}=m_{k}\left(B_{\rho}^{(k)}\right)^{-1} \chi_{B_{\rho}^{(k)}}$ used above in Section 8.1.

Lemma 8.11. If $s_{j-1} / s_{j} \geq \rho^{\sigma}, \rho \geq 1$, then

$$
\left|\tilde{\varphi}_{s_{j}}^{(j)} * \varphi_{s_{j-1}}^{(j-1)}\right| \leq c \rho^{-\sigma j}\left(\tilde{\eta}_{B_{s_{j}}^{(j)}}^{(j)}\right) *\left(\eta_{B_{s_{j-1}}^{(j-1)}}^{(j-1)}\right) .
$$

Proof. In analogy with equation (8.10) in Section 8.3, we have that on $G_{j}$

$$
\begin{equation*}
\varphi_{s_{j}}^{(j)}=\sum_{r \geq j}\left(s_{j}\right)^{r} X_{r}^{L}\left(\psi_{s_{j}}^{(r)}\right) \tag{8.11}
\end{equation*}
$$

where $X_{r}^{L}$ are left-invariant vector fields on $G_{j}$, with $\psi^{(r)} C^{\infty}$ functions supported in the unit ball. Now

$$
\left(\delta_{\mathbf{x}_{j-1}} \otimes X_{r}^{L}\left(\psi_{s_{j}}^{(r)}\right)\right) * \varphi_{s_{j-1}}^{(j-1)}=\left(\delta_{\mathbf{x}_{j-1}} \otimes \psi_{s_{j}}^{(r)}\right) * X_{r}^{R}\left(\varphi_{s_{j-1}}^{(j-1)}\right)
$$

and $X_{r}^{R}\left(\varphi_{s_{j-1}}^{(j-1)}\right)$ is of the form $s_{j-1}^{-r} \psi_{s_{j-1}}^{\prime(r)}$. Combining these gives a sum

$$
\sum_{r \geq j}\left(s_{j} / s_{j-1}\right)^{r} \tilde{\psi}_{s_{j}}^{(r)} * \psi_{s_{j-1}}^{\prime(r)}
$$

and since $s_{j} / s_{j-1} \leq \rho^{-\sigma}$, the lemma is proved.

Consider the operator $P_{\mathbf{s}}^{*}$ given by $P_{\mathbf{s}}^{*}(f)=f * \Phi_{\mathbf{s}}^{*}$, with $\Phi_{\mathbf{s}}^{*}=\tilde{\varphi}_{s_{n}}^{(n)} * \tilde{\varphi}_{s_{n-1}}^{(n-1)} * \cdots *$ $\tilde{\varphi}_{s_{1}}^{(1)}$. Because of Lemma 8.11 and since $j \geq 2$, we have $\left|\Phi_{\mathbf{s}}^{*}\right| \leq c \rho^{-2 \sigma} \tilde{\eta}_{B_{s_{n}}}^{(k)} * \cdots *$ $\tilde{\eta}_{B_{s_{1}}^{(1)}}=c \rho^{-\sigma j}=c \rho^{-2 \sigma} A_{\mathbf{s}}^{*}$, in the notation of Section 8.1. So by equation (8.6') there, it follows that $\left|P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq c \rho^{-2 \sigma} M(f)(\mathbf{x})$. Combining this with the first conclusion already proved that $\left|P_{\mathbf{t}} T(F)(\mathbf{x})\right| \leq c M(F)(\mathbf{x})$, with $F=P_{\mathbf{t}}^{*}(f)$, yields

$$
\begin{equation*}
\left|P_{\mathbf{t}} T P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq c \rho^{-2 \sigma} \mathcal{M}(f)(\mathbf{x}) \tag{8.12}
\end{equation*}
$$

since $\mathcal{M}=M \cdot M$.
We now turn to Case II. Here $s_{j-1} / s_{j} \leq \rho^{\sigma}$, for all $j, 2 \leq j \leq k$. Thus $s_{j} \leq s_{k} \rho^{\sigma(k-j)}$ for $1 \leq j \leq k$. If we set $s_{*}=\sup _{1 \leq j \leq k} s_{j}$, then $s_{*} \leq s_{k} \rho^{\sigma(k-1)}$. Next we recall the following fact:

If $X_{\ell}^{R}$ is a right-invariant vector field of degree $\ell \geq j$ on $G_{j}$, then one can write

$$
X_{\ell}^{R}\left(\psi_{a}\right)=\sum_{r \geq \ell} a^{r-\ell} X_{r}^{L}\left(\psi_{a}\right)
$$

where $X_{r}^{L}$ are left-invariant vector fields of degree $r$. This follows by writing $X_{\ell}^{R}=\sum h_{\ell, r}(\mathbf{x}) X_{r}^{L}$, with $h_{\ell, r}(\mathbf{x})$ a homogeneous polynomial of degree $r-\ell$, and arguing as in Proposition 3.2.

With this in hand, consider $\tilde{\varphi}_{s_{k}}^{(k)} * \tilde{\varphi}_{s_{k-1}}^{(k-1)} * \cdots * \tilde{\varphi}_{s_{1}}^{(1)}$. First use that $\int_{G_{k}} \varphi^{(k)}(\mathbf{x}) d \mathbf{x}$ $=0$, which by the analogue of assertion (8.10) (for left-invariant vector fields on the group $G_{k}$ ) gives an expression involving the action of left-invariant vector fields (of degrees $\geq k$ ). Next pass from the left-invariant vector-fields acting on $\psi_{s_{j}}^{(r)}$ to the corresponding right-invariant vector fields acting on $\tilde{\varphi}_{s_{k-1}}^{k-1}$, via the rule

$$
\begin{equation*}
\left(X_{r}^{L} \psi\right) * \varphi=\psi * X_{r}^{R} \varphi \tag{8.13}
\end{equation*}
$$

At this point utilize the remark on page 714 to pass to left-invariant vector fields, and then use the rule (8.13) above to pass to $\tilde{\varphi}_{s_{k-2}}^{k-2}$, etc.

Putting this all together leads quickly to the following conclusion: the convolution

$$
\tilde{\varphi}_{s_{k}}^{(k)} * \tilde{\varphi}_{s_{k-1}}^{(k-1)} * \cdots * \tilde{\varphi}_{s_{1}}^{(1)}
$$

is a finite sum of expression of the form

$$
\begin{equation*}
\left(s_{*}\right)^{r} \tilde{\psi}_{s_{k}}^{(k)} * \tilde{\psi}_{s_{k-1}}^{(k-1)} * \cdots * X_{r}^{L}\left(\tilde{\psi}_{s_{1}}^{(1)}\right) \tag{8.14}
\end{equation*}
$$

for $r \geq k$. Here we use the fact that $s_{*} \geq s_{j}, j \leq k$. Now consider

$$
\begin{equation*}
\tilde{\varphi}_{s_{k}}^{(k)} * \tilde{\varphi}_{s_{k-1}}^{(k-1)} * \cdots * \tilde{\varphi}_{s_{1}}^{(1)} * K * \Phi_{t} \tag{8.15}
\end{equation*}
$$

By applying the rule (8.3) we can pass the left-invariant vector field $X_{r}^{L}$ as a rightinvariant vector field acting on $K * \Phi_{\mathbf{t}}$. We keep in mind that $r \geq k$, and use Theorem 8.9, part (2). Therefore $\Phi_{\mathrm{s}}^{*} * K * \Phi_{\mathrm{t}}=\tilde{\varphi}_{s_{n}}^{(n)} * \tilde{\varphi}_{s_{k-1}}^{(k-1)} * \cdots * \tilde{\varphi}_{s_{1}}^{(1)} * K * \Phi_{\mathrm{t}}$ is majorized by a constant multiple of $s_{*}^{r} \cdot t_{k}^{-r} A_{\mathbf{s}}^{*} * \Gamma_{\mathbf{t}}$, where $A_{\mathbf{s}}^{*}=\tilde{\eta}_{B_{s_{n}}^{(n)}} * \tilde{\eta}_{B_{s_{n-1}}^{(n-1)}} * \cdots * \tilde{\eta}_{B_{s_{1}}^{(1)}}$.

In view of Theorem 8.6 and inequality (8.6 ) in Section 8.1, we get that

$$
\begin{equation*}
\left|P_{\mathbf{t}} T P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq c \sup _{r \geq k}\left(s_{*}^{r} t_{k}^{-r}\right) M(M(f))(\mathbf{x}) \tag{8.16}
\end{equation*}
$$

We now pick $\sigma=1 / 2 k$. Since $s_{*} \leq s_{k} \rho^{\sigma(k-1)}$, and $s_{k} / t_{k}=\rho^{-1}, \rho \geq 1$, we get

$$
\left|P_{\mathbf{t}} T P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq c \rho^{-1 / 2} M(M(f))(\mathbf{x}) .
$$

Combining this with the previous case given by (8.12) yields

$$
\left|P_{\mathbf{t}} T P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq c\left(\frac{s_{k}}{t_{k}}\right)^{1 / n} \mathcal{M}(f)(\mathbf{x}), \quad \text { if } t_{k} / s_{k} \geq 1
$$

By a parallel argument the analogous result holds for $s_{k} / t_{k} \geq 1$. Hence

$$
\left|P_{\mathbf{t}} T P_{\mathbf{s}}^{*}(f)(\mathbf{x})\right| \leq c \min \left(\frac{s_{k}}{t_{k}}, \frac{t_{k}}{s_{k}}\right)^{\frac{1}{n}} \mathcal{M}(f)(\mathbf{x})
$$

Since this holds for all $k, 1 \leq k \leq n$, we can take the geometric mean of these inequalities. The result is conclusion (b) of Theorem 8.10 , with $\delta=1 / n^{2}$.

### 8.6. Square functions and $L^{p}$-boundedness

We will construct the square functions for $G$ as products of the (one-parameter) square functions of the subgroups $G_{k}, 1 \leq k \leq n$. Each $G_{k}$ is a homogeneous group with family of dilations $\delta_{r}$, and so there exists a finite-dimensional inner product space $V_{k}$ and a pair $\varphi^{(k)}, \psi^{(k)}$ of $V_{k}$-valued functions, with $\varphi^{(k)} \in$ $\mathcal{C}_{0}^{\infty}\left(G_{k}\right)$ supported in the unit ball, and $\psi^{(k)} \in \mathcal{S}\left(G_{k}\right)$ a Schwartz function, so that $\int_{G_{k}} \varphi^{(k)}(\mathbf{x}) d \mathbf{x}=\int_{G_{k}} \psi^{(k)}(\mathbf{x}) d \mathbf{x}=0$, and

$$
\begin{equation*}
\int_{0}^{\infty} \psi_{a}^{(k)}\left(\mathbf{x y}^{-1}\right) \cdot \varphi_{a}^{(k)}(\mathbf{y}) \frac{d a}{a}=\delta_{0} \tag{8.17}
\end{equation*}
$$

Here $\varphi_{a}^{(k)}(\mathbf{x})=a^{-Q_{k}-Q_{k+1}-\cdots-Q_{n}} \varphi^{(k)}\left(\delta_{a^{-1}}(\mathbf{x})\right)$, with a similar definition for $\psi_{a}^{(k)}(\mathbf{x})$. Also • denotes the inner product in $V_{k}$. See Theorem 1.61 in [3].

We define operators $P_{a}^{(k)}$ and $Q_{a}^{(k)}$, acting on functions on $G_{k}$, by setting $P_{a}^{(k)}(f)=f * \varphi_{a}^{(k)}$ and $Q_{a}^{(k)}(f)=f * \psi_{a}^{(k)}$. Note that (8.17) shows that

$$
\begin{equation*}
\int_{0}^{\infty} P_{a}^{(k)} \cdot Q_{a}^{(k)} \frac{d a}{a}=\mathrm{Id} \tag{8.18}
\end{equation*}
$$

Next, define the square functions $S_{k}$ and $S_{k}^{\#}$ by setting

$$
S_{k}(f)(\mathbf{x})=\left(\int_{0}^{\infty}\left|P_{a}^{(k)}(f)(\mathbf{x})\right|^{2} \frac{d a}{a}\right)^{1 / 2}, \quad S_{k}^{\#}(f)(\mathbf{x})=\left(\int_{0}^{\infty}\left|Q_{a}^{(k)}(f)(\mathbf{x})\right|^{2} \frac{d a}{a}\right)^{1 / 2}
$$

The usual theory of singular integrals in [11] and [3], together with (8.18), then gives the inequalities

$$
\begin{equation*}
\|f\|_{L^{p}} \approx\left\|S_{k}(f)\right\|_{L^{p}} \approx\left\|S_{k}^{\#}(f)\right\|_{L^{p}} \tag{8.19}
\end{equation*}
$$

for $1<p<\infty$ on $G_{k}$. The result is valid not only for scalar-valued $f$, but also for $f$ that take their values in a Hilbert space.

Having recalled the known results for $G_{k}$ we transfer them to the whole group $G$ by writing

$$
\begin{aligned}
\tilde{P}_{a}^{(k)}(f) & =f *\left(\delta_{\mathbf{x}_{1} \cdots \mathbf{x}_{k-1}} \otimes \varphi_{a}^{(k)}\right), & \tilde{Q}_{a}^{(k)}(f) & =f *\left(\delta_{\mathbf{x}_{1} \cdots \mathbf{x}_{k-1}} \otimes \psi_{a}^{(k)}\right), \\
\tilde{S}_{k}(f) & =\left(\int_{0}^{\infty}\left|\tilde{P}_{a}^{(k)}(f)\right|^{2} \frac{d a}{a}\right)^{1 / 2}, & \tilde{S}_{k}^{\#}(f) & =\left(\int_{0}^{\infty}\left|\tilde{Q}_{a}^{(k)}(f)\right|^{2} \frac{d a}{a}\right)^{1 / 2}
\end{aligned}
$$

We get as a consequence

$$
\int_{0}^{\infty} \tilde{P}_{a}^{(k)} \cdot \tilde{Q}_{a}^{(k)} \frac{d a}{a}=\mathrm{Id}
$$

on $G$, and

$$
\|f\|_{L^{p}(G)} \approx\left\|\tilde{S}_{k}(f)\right\|_{L^{p}(G)} \approx\left\|\tilde{S}^{\#}(f)\right\|_{L^{p}(G)}
$$

With the above one-parameter theory arising from each $G_{k}$ we come to the square functions on $G$ that are relevant for us. For each $\mathbf{t}=\left(t_{1}, \ldots t_{n}\right) \in\left(\mathbb{R}^{+}\right)^{n}$, we set $P_{\mathbf{t}}=\tilde{P}_{t_{n}}^{(n)} \cdot \tilde{P}_{t_{n-1}}^{(n-1)} \cdots \tilde{P}_{t_{1}}^{(1)}$. That is, $P_{\mathbf{t}}(f)=f * \Phi_{\mathbf{t}}$, where $\Phi_{\mathbf{t}}=\tilde{\varphi}_{t_{1}}^{(1)} * \tilde{\varphi}_{t_{2}}^{(2)} *$ $\cdots * \tilde{\varphi}_{t_{n}}^{(n)}$ and $\tilde{\varphi}_{t_{k}}^{(k)}=\delta_{\mathbf{x}_{1} \cdots \mathbf{x}_{k-1}} \otimes \varphi_{t_{k}}^{(k)}$. Note also that $\Phi_{\mathbf{t}}$ is a $V$-valued function, where $V=V_{1} \otimes V_{2} \otimes \cdots \otimes V_{n}$. Similarly, we define $P_{\mathbf{t}}^{*}=\tilde{P}_{t_{1}}^{(1)} \cdot \tilde{P}_{t_{2}}^{(2)} \cdots \tilde{P}_{t_{n}}^{(n)}, Q_{\mathbf{t}}=$ $\tilde{Q}_{t_{n}}^{(n)} \cdots \tilde{Q}_{t_{1}}^{(1)}$, and $Q_{\mathbf{t}}^{*}=\tilde{Q}_{t_{1}}^{(1)} \cdots \tilde{Q}_{t_{n}}^{(n)}$. Also $Q_{\mathbf{t}}(f)=f * \bar{\psi}_{\mathbf{t}}$, with $\bar{\psi}_{\mathbf{t}}=\tilde{\psi}_{t_{1}}^{(1)} * \cdots * \tilde{\psi}_{t_{n}}^{(n)}$ and $\bar{\psi}_{\mathrm{t}}$ is also $V$-valued. Finally, we set

$$
S(f)(\mathbf{x})=\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left|P_{\mathbf{t}}(f)\right|^{2} \frac{d \mathbf{t}}{[\mathbf{t}]}\right)^{1 / 2}, \quad \mathfrak{S}(f)(\mathbf{x})=\left(\int_{\left(\mathbb{R}^{+}\right)^{n}}\left|\mathcal{M} Q_{\mathbf{t}} f\right|^{2} \frac{d \mathbf{t}}{[\mathbf{t}]}\right)^{1 / 2}
$$

Here we use the abbreviation that $[\mathbf{t}]=t_{1} \cdot t_{2} \cdots \cdot t_{n}$.
Lemma 8.12. We have
(a) $\int_{\left(\mathbb{R}^{+}\right)^{n}} P_{\mathbf{t}}^{*} Q_{\mathbf{t}} \frac{d \mathbf{t}}{[\mathbf{t}]}=\mathrm{Id}$;
(b) $\|f\|_{L^{p}} \leq A_{p}\|S(f)\|_{L^{p}}, 1<p<\infty$;
(c) $\|\mathfrak{S}(f)\|_{L^{p}} \leq A_{p}\|f\|_{L^{p}}, 1<p<\infty$.

To prove (a), we take first the identity (8.18) when $k=1$, and $a=t_{1}$. Next we multiply on the left of both sides by $P_{t_{2}}^{(2)}$ and on the right of both sides by $\tilde{Q}_{t_{2}}^{(2)}$ and integrate in $t_{2}$, using (8.18') for $k=2$. Continuing this way yields (a). Inequality (b) follows from repeated comparisons of the corresponding inequalities (8.19') for $\tilde{S}_{k}$. Also (c) follows by applying (8.19') for $\tilde{S}_{k}^{\#}$ and a two-fold application of the vector-valued maximal function in Corollary 8.4 , for $F_{\mathbf{t}}(\mathbf{x})=Q_{\mathbf{t}}(f)(\mathbf{x}) \cdot[\mathbf{t}]^{-1 / 2}$.

The final lemma needed is as follows:
Lemma 8.13. Suppose $\mathcal{K}$ is a flag kernel and $T(f)=f * \mathcal{K}$. Then,

$$
\begin{equation*}
S(T(f))(\mathbf{x}) \leq c \mathfrak{S}(f)(\mathbf{x}) \tag{8.20}
\end{equation*}
$$

Proof. Now $P_{\mathbf{t}} T(f)(\mathbf{x})=\int_{\left(\mathbb{R}^{+}\right)^{n}} P_{\mathbf{t}} \cdot T P_{\mathbf{s}}^{*} Q_{\mathbf{s}}(f)(\mathbf{x}) \frac{d \mathbf{s}}{[\mathrm{~s}]}$ by part (a) of the previous lemma. Hence Theorem 8.10, part (b) shows that

$$
\left|P_{\mathbf{t}} T(f)(\mathbf{x})\right| \leq \int_{\left(\mathbb{R}^{+}\right)^{n}} \gamma(\mathbf{s}, \mathbf{t}) \mathcal{M}\left(Q_{\mathbf{s}}(f)\right)(\mathbf{x}) \frac{d \mathbf{s}}{[\mathbf{s}]}
$$

where $\gamma(\mathbf{s}, \mathbf{t})=c\left(\prod_{k=1}^{n} \min \left(\frac{s_{k}}{t_{k}}, \frac{t_{k}}{s_{k}}\right)\right)^{\delta}$. Thus,

$$
\left|P_{\mathbf{t}} T(f)(\mathbf{x})\right|^{2} \leq \int_{\left(\mathbb{R}^{+}\right)^{n}} \gamma(\mathbf{s}, \mathbf{t})\left(\mathcal{M} Q_{\mathbf{s}}(f)(\mathbf{x})\right)^{2} \frac{d \mathbf{s}}{[\mathbf{s}]} \cdot I(\mathbf{t})
$$

with $I(\mathbf{t})=\int_{\left(\mathbb{R}^{+}\right)^{n}} \gamma(\mathbf{s}, \mathbf{t}) \frac{d \mathbf{s}}{[\mathbf{s}]}$, by Schwarz's inequality. But $\sup _{\mathbf{t}} I(\mathbf{t})=A<\infty$, since

$$
\int_{0}^{\infty} \min \left(\frac{s_{k}}{t_{k}}, \frac{t_{k}}{s_{k}}\right)^{\delta} \frac{d s_{k}}{s_{k}}=t_{k}^{-\delta} \int_{0}^{t_{k}} s_{k}^{-1+\delta} d s_{k}+t_{k}^{\delta} \int_{t_{k}}^{\infty} s_{k}^{-1-\delta} d s_{k}=\frac{2}{\delta}
$$

A further integration in $\mathbf{t}$ (noting that also $\left.\int_{\left(\mathbb{R}^{+}\right)^{n}} \gamma(\mathbf{s}, \mathbf{t}) \frac{d \mathbf{t}}{[\mathbf{t}]} \leq A\right)$ then gives the desired result.

Theorem 8.14. With $T f=f * K$ as above, we have $\|T f\|_{L^{p}(G)} \leq A_{p}\|f\|_{L^{p}(G)}$, for $1<p<\infty$.

This now follows directly from (8.20), once we apply Lemma 8.12, part (b), for $T f$ in place of $f$, and then part (c) of that Lemma.

## 9. Appendix I: Lifting

Suppose that $T(f)=f * \mathcal{K}$ is a convolution operator on $G_{k}$ with $f \in \mathcal{S}\left(G_{k}\right)$ and $\mathcal{K} \in \mathcal{S}^{\prime}\left(G_{k}\right)$, a tempered distribution. Then $T f$ can be written $T(f)(\mathbf{x})=$ $\int_{G_{k}} \mathcal{K}(\mathbf{y}) f\left(\mathbf{x y}^{-1}\right) d \mathbf{y}=\left\langle\mathcal{K}, F_{\mathbf{x}}\right\rangle$, where $F_{\mathbf{x}}$ is the element of $\mathcal{S}\left(G_{k}\right)$ given by $F_{\mathbf{x}}(\mathbf{y})=f\left(\mathbf{x y}^{-1}\right)$ for $\mathbf{y} \in G_{k}$. We can lift $T$ to a convolution operator on $G$, denoted by $\tilde{T}$, given by $\tilde{T}(f)(\mathbf{x})=\int_{G_{k}} K(\mathbf{y}) f\left(\mathbf{x y}^{-1}\right) d \mathbf{y}=\left\langle\mathcal{K}, F_{\mathbf{x}}\right\rangle$, where $f \in \mathcal{S}(G)$, and $F_{\mathbf{x}}(\mathbf{y})=f\left(\mathbf{x y}^{-1}\right)$ for $\mathbf{y} \in G_{k}$.

We describe this lifting in terms of the coordinate system used in the proof of Theorem 8.9. We can write each $\mathbf{x} \in G$ as a product $\mathbf{x}=\mathrm{x}^{\prime} \cdot \overline{\mathbf{x}}$, with $\mathbf{x}^{\prime}=$ $\left(\mathbf{x}_{1}, \ldots, \mathbf{x}_{k-1}, 0, \ldots, 0\right)$ and $\overline{\mathbf{x}} \in G_{k}$, where $\overline{\mathbf{x}}=\left(0, \ldots, 0, \mathbf{x}_{k}, \ldots, \mathbf{x}_{n}\right)$. With this coordinate system, we define $\tilde{K} \in \mathcal{S}^{\prime}(G)$ as $\delta_{\mathbf{x}^{\prime}} \otimes K$, where $\mathbf{x}=\mathbf{x}^{\prime} \cdot \overline{\mathbf{x}}$, and we set $\tilde{T}(f)(\mathbf{x})=(f * \tilde{K})(\mathbf{x})$ for $f \in \mathcal{S}(G)$ and $\mathbf{x} \in G$. Then $\tilde{T}(f)(\mathbf{x})=\tilde{T}(f)\left(\mathbf{x}^{\prime} \cdot \overline{\mathbf{x}}\right)$. However observe that $\tilde{T}(f)\left(\mathbf{x}^{\prime} \cdot \overline{\mathbf{x}}\right)=T\left(f^{\mathbf{x}^{\prime}}\right)(\overline{\mathbf{x}})$, where $f^{\mathbf{x}^{\prime}}$ is the element of $\mathcal{S}\left(G_{k}\right)$ given by $f^{\mathbf{x}^{\prime}}(\mathbf{y})=f\left(\mathbf{x}^{\prime} \cdot \mathbf{y}\right), \mathbf{y} \in G_{k}$. Therefore

$$
\begin{equation*}
\tilde{T}(f)\left(\mathbf{x}^{\prime} \cdot \overline{\mathbf{x}}\right)=T\left(f^{\mathbf{x}^{\prime}}\right)(\overline{\mathbf{x}}) \tag{9.1}
\end{equation*}
$$

Next, suppose that $T$ satisfies the bound

$$
\begin{equation*}
\|T(f)\|_{L^{p}\left(G_{k}\right)} \leq A\|f\|_{L^{p}\left(G_{k}\right)} \tag{9.2}
\end{equation*}
$$

for each $f \in \mathcal{S}(G)$. Then, applying this to $f=f^{\mathrm{x}^{\prime}}$ via (9.1) (and assuming $p<\infty$ ), gives

$$
\int_{G_{k}}\left|\tilde{T}(f)\left(\mathbf{x}^{\prime} \overline{\mathbf{x}}\right)\right|^{p} d \overline{\mathbf{x}} \leq A^{p} \int_{G_{k}}\left|f^{\mathbf{x}^{\prime}}(\overline{\mathbf{x}})\right|^{p} d \overline{\mathbf{x}},
$$

for each $\mathbf{x}^{\prime}$, and an integration in $\mathbf{x}^{\prime}$ yields

$$
\begin{equation*}
\|T(f)\|_{L^{p}(G)} \leq A\|f\|_{L^{p}(G)} \tag{9.3}
\end{equation*}
$$

Suppose next that $K$ depends on a parameter $t, K=K_{t}$ and set $T_{t}(f)=f * K_{t}$. Then the same argument shows that

$$
\left\|\sup _{t}\left|\tilde{T}_{t}(f)\right|\right\|_{L^{p}(G)} \leq A\|f\|_{L^{p}(G)}, \quad \text { for all } f \in \mathcal{S}(G)
$$

whenever

$$
\left\|\sup _{t}\left|T_{t}(f)\right|\right\|_{L^{p}\left(G_{k}\right)} \leq A\|f\|_{L^{p}\left(G_{k}\right)}, \quad \text { for all } f \in \mathcal{S}\left(G_{k}\right)
$$

This proves that the lifted maximal inequality $\left\|\tilde{M}_{k}(f)\right\|_{L^{p}(G)} \leq A_{p}\|f\|_{L^{p}(G)}$ follows from the corresponding inequality on $G_{k}$, by considering first the case when $f$ is non-negative (and $K_{t}=\eta_{B_{t}}^{(k)}$ ), and then by replacing $f$ by $|f|$.

In the same way the vector-valued maximal inequality (8.4) on $G_{k}$ can be lifted to the corresponding inequality $\left(8.4^{\prime}\right)$ on $G$. In fact, it suffices to prove ( $8.4^{\prime}$ ) when there are only $m$ non-zero $f_{j}$ 's, $1 \leq j \leq m$, with bounds independent of $m$. With this understanding, set

$$
f=\left(f_{1}, \ldots, f_{m}\right), \quad t=\left(t_{1}, \ldots, t_{m}\right)
$$

and

$$
T_{t}(f)=\left(T_{t_{1}}^{1}\left(f_{1}\right), \ldots, T_{t_{m}}^{m}\left(f_{m}\right)\right), \quad T_{t_{j}}^{j}(f)=f * K_{t_{j}}^{j}
$$

with

$$
|f|=\left(\sum_{j=1}^{m}\left|f_{j}\right|^{2}\right)^{1 / 2}, \quad\left|T_{t}(f)\right|=\left(\sum_{j=1}^{m}\left|T_{t_{j}}^{j}\left(f_{j}\right)\right|^{2}\right)^{1 / 2}
$$

Note that

$$
\left(\sum_{j=1}^{m} \sup _{t_{j}}\left|T_{t_{j}}^{j}(f)\right|^{2}\right)^{1 / 2}=\sup _{t}\left|T_{t}\right|(f) \mid
$$

Then as before the inequality

$$
\left\|\sup _{t}\left|T_{t}(f)\right|\right\|_{L^{p}\left(G_{n}\right)} \leq A\||f|\|_{L^{p}\left(G_{k}\right)}, \quad f \in \mathcal{S}\left(G_{n}\right)
$$

implies the corresponding inequality for $T_{t}$ lifted to $G$, that is for $\tilde{T}_{t}$, and this then yields the desired result.

We should remark that the lifting procedure used here can be viewed in terms of the more abstract "transference" method presented in [1].

## 10. Appendix II: An estimate for a geometric sum

Recall that $\mathcal{E}_{n}=\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{Z}^{n} \mid i_{1} \leq i_{2} \leq \cdots \leq i_{n}\right\}$. More generally, if $0 \leq B_{1} \leq B_{2} \leq \cdots \leq B_{n}$, let

$$
\begin{equation*}
\Lambda(B)=\left\{I=\left(i_{1}, \ldots, i_{n}\right) \in \mathcal{E}_{n} \mid B_{j} \leq 2^{i_{j}} \quad \text { for } \quad 1 \leq j \leq n\right\} \tag{10.1}
\end{equation*}
$$

We establish the following estimate for geometric sums which we shall use several times.

Proposition 10.1. Let $\alpha_{j}>0$ for $1 \leq j \leq n$, and let $M>\sum_{k=1}^{n} \alpha_{k}$. There is a constant $C$ depending on $n$, on $M$, and on the numbers $\left\{\alpha_{j}\right\}$ so that for any $A_{1}, \ldots, A_{n} \in(0, \infty)$ and any $0 \leq B_{1} \leq B_{2} \leq \cdots \leq B_{n}$,

$$
\begin{align*}
& \sum_{I \in \mathcal{E}_{n}} \frac{\prod_{k=1}^{n}\left(2^{-i_{k}}\right)^{\alpha_{k}}}{\left(1+\sum_{k=1}^{n} 2^{-i_{k}} A_{k}\right)^{M}} \leq C \prod_{j=1}^{n}\left(A_{1}+A_{2}+\cdots+A_{j}\right)^{-\alpha_{j}}  \tag{10.2}\\
& \sum_{I \in \Lambda(B)} \frac{\prod_{k=1}^{n}\left(2^{-i_{k}}\right)^{\alpha_{k}}}{\left(1+\sum_{k=1}^{n} 2^{-i_{k}} A_{k}\right)^{M}} \leq C \prod_{j=1}^{n}\left(A_{1}+A_{2}+\cdots+A_{j}+B_{j}\right)^{-\alpha_{j}} \tag{10.3}
\end{align*}
$$

Proof. Note that if we take $B_{1}=\cdots=B_{n}=0$, then the inequality (10.3) gives the inequality (10.2). If for $x_{1}, \ldots, x_{n} \geq 0$ we put

$$
\varphi\left(x_{1}, \ldots, x_{n}\right)=\left(\prod_{k=1}^{n} x_{k}^{\alpha_{k}}\right)\left(1+\sum_{k=1}^{n} x_{k} A_{k}\right)^{-M}
$$

then, if $1 \leq s_{j} \leq 2$ for $1 \leq j \leq n$, we have

$$
\varphi\left(s_{1} x_{1}, \ldots, s_{n} x_{n}\right) \leq 2^{|\alpha|} \prod_{k=1}^{n} x_{k}^{\alpha_{k}}\left(1+\sum_{k=1}^{n} x_{k} A_{k}\right)^{-M} \leq 2^{|\alpha|} \varphi\left(x_{1}, \ldots, x_{n}\right)
$$

For each $I=\left(i_{1}, \ldots, i_{n}\right) \in \mathbb{Z}^{n}$, let $Q_{I}=\left\{\mathbf{x} \in \mathbb{R}^{n} \left\lvert\, \frac{1}{2} 2^{-i_{k}} \leq x_{k}<2^{-i_{k}}\right.\right\}$. It follows that there is a constant $C=C(n, \alpha)$ depending only on $n$ and $\alpha$ such that

$$
C^{-1} \int_{Q_{I}} \varphi(\mathbf{x}) \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}} \leq \frac{\prod_{k=1}^{n}\left(2^{-i_{k}}\right)^{\alpha_{k}}}{\left(1+\sum_{k=1}^{n} 2^{-i_{k}} A_{k}\right)^{M}} \leq C \int_{Q_{I}} \varphi(\mathrm{x}) \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}} .
$$

Thus

$$
\sum_{I \in \Lambda(B)} \frac{\prod_{k=1}^{n}\left(2^{-i_{k}}\right)^{\alpha_{k}}}{\left(1+\sum_{k=1}^{n} 2^{-i_{k}} A_{k}\right)^{M}} \leq C \int_{\bigcup_{I \in \Lambda(B)} Q_{I}} \varphi(\mathbf{x}) \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}}
$$

On the other hand, it is easy to check that if $I \in \Lambda(B)$ and $\mathbf{x} \in Q_{I}$, then $0<$ $x_{k+1} \leq 2 x_{k}$ for $1 \leq k \leq n-1$ and $x_{k} \leq B_{k}^{-1}$ for $1 \leq k \leq n$. Thus if we put

$$
\Omega(B)=\left\{\mathbf{x} \in \mathbb{R}_{+}^{n}:\left\{\begin{array}{l}
\frac{1}{2} x_{k+1} \leq x_{k} \leq B_{k}^{-1} \quad \text { for } 1 \leq k \leq n-1 \\
0 \leq x_{n} \leq B_{n}^{-1}
\end{array}\right\}\right.
$$

then $\bigcup_{I \in \Lambda(B)} Q_{I} \subseteq \Omega(B)$. Thus to prove the proposition, it suffices to show that

$$
\int_{\Omega(B)} \frac{\prod_{k=1}^{n} x_{k}^{\alpha_{k}}}{\left(1+\sum_{k=1}^{n} x_{k} A_{k}\right)^{M}} \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}} \leq C \prod_{j=1}^{n}\left(A_{1}+A_{2}+\cdots+A_{j}+B_{j}\right)^{-\alpha_{j}}
$$

However,

$$
\begin{aligned}
\int_{\Omega(B)} \prod_{k=1}^{n} x_{k}^{\alpha_{k}}(1+ & \left.\sum_{k=1}^{n} x_{k} A_{k}\right)^{-M} \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}} \\
& =\int_{0}^{\infty} t^{M} e^{-t}\left[\int_{\Omega(B)} \prod_{k=1}^{n} x_{k}^{\alpha_{k}} e^{-x_{k} A_{k} t} \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}}\right] \frac{d t}{t}
\end{aligned}
$$

We will show that we can estimate the inner integral on the right hand side by

$$
\begin{align*}
& \int_{\Omega(B)} \prod_{k=1}^{n} x_{k}^{\alpha_{k}} e^{-x_{k} A_{k} t} \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}} \\
& \quad \leq C(n, \alpha) \prod_{j=1}^{n}\left(1+t^{-\alpha_{j}}\right)\left(A_{1}+A_{2}+\cdots+A_{j}+B_{j}\right)^{-\alpha_{j}} \tag{10.4}
\end{align*}
$$

and since $M>\sum_{k=1}^{n} \alpha_{k}$, this will complete the proof.
To establish (10.4), we first establish an estimate for $\int_{\frac{x}{2}}^{B^{-1}} s^{\alpha} e^{-s A t} \frac{d s}{s}$. On the one hand, we have

$$
\int_{\frac{x}{2}}^{B^{-1}} s^{\alpha} e^{-s A t} \frac{d s}{s} \leq e^{-\frac{1}{2} x A t} \int_{0}^{B^{-1}} s^{\alpha-1} d s=\alpha^{-1} e^{-\frac{1}{2} x A t} B^{-\alpha}
$$

On the other hand we have

$$
\int_{\frac{x}{2}}^{B^{-1}} s^{\alpha} e^{-s A t} \frac{d s}{s} \leq(A t)^{-\alpha} \int_{\frac{1}{2} x A t}^{\infty} s^{\alpha-1} e^{-s} d s \leq C_{\alpha}(A t)^{-\alpha} e^{-\frac{1}{4} x A t}
$$

Putting the two together, we have the estimate

$$
\begin{equation*}
\int_{\frac{x}{2}}^{B^{-1}} s^{\alpha} e^{-s A t} \frac{d s}{s} \leq C_{\alpha} e^{-\frac{1}{4} x A t}(A t+B)^{-\alpha} \leq C_{\alpha} e^{-\frac{1}{4} x A t}(A+B)^{-\alpha}\left(1+t^{-\alpha}\right) \tag{10.5}
\end{equation*}
$$

We now establish (10.4) by induction on $n$. When $n=1$, we use (10.5) with $x=0$ to get

$$
\int_{0}^{B_{1}^{-1}} x_{1}^{\alpha_{1}} e^{-\alpha_{1} A_{1} t} \frac{d x_{1}}{x_{1}} \leq C_{\alpha}\left(A_{1}+B_{1}\right)^{-\alpha_{1}}\left(1+t^{-\alpha_{1}}\right)
$$

For the induction step, we have

$$
\begin{aligned}
& \int_{\Omega(B)} \prod_{k=1}^{n} x_{k}^{\alpha_{k}} e^{-x_{k} A_{k} t} \frac{d x_{1} \cdots d x_{n}}{x_{1} \cdots x_{n}} \\
& \quad=\int_{\Omega^{\prime}(B)} \prod_{k=2}^{n} x_{k}^{\alpha_{k}} e^{-x_{k} A_{k} t}\left[\int_{\frac{x_{2}}{2}}^{B_{1}^{-1}} x_{1}^{\alpha_{1}} e^{-\alpha_{1} A_{1} t} \frac{d x_{1}}{x_{1}}\right] \frac{d x_{2} \cdots d x_{n}}{x_{2} \cdots x_{n}} \\
& \quad \leq C_{\alpha}\left(A_{1}+B_{1}\right)^{-\alpha_{1}}\left(1+t^{-\alpha_{1}}\right) \int_{\Omega^{\prime}(B)} \prod_{k=2}^{n} x_{k}^{\alpha_{k}} e^{-x_{k} A_{k} t} e^{-\frac{1}{4} x_{2} A_{1} t} \frac{d x_{2} \cdots d x_{n}}{x_{2} \cdots x_{n}} .
\end{aligned}
$$

Here,

$$
\Omega^{\prime}(B)=\left\{\mathbf{x} \in \mathbb{R}_{+}^{n}:\left\{\begin{array}{l}
\frac{1}{2} x_{k+1} \leq x_{k} \leq B_{k}^{-1} \quad \text { for } 2 \leq k \leq n-1 \\
0 \leq x_{n} \leq B_{n}^{-1}
\end{array}\right\}\right.
$$

and we have used the estimate in (10.5). The last integral on the right-hand side is thus of the same form as the original integral, except that $n$ has been replaced by $n-1$, and $A_{2}$ has been replaced by $A_{2}+\frac{1}{4} A_{1}$. We can thus use our inductive hypothesis on this integral, and we obtain the desired estimate. This completes the proof.
